ELSA MARIE BUTLER, 1673 North Golden Gate Avenue, Los Angeles, California, telephone 667-3384, was interviewed by SA NORMAN R. JOHNSON and SA THEODORE E. CHILDRESS on 6/10/68. She is employed as a belly dancer at The Fez, 1508 North Vermont. She furnished information concerning the atmosphere at this restaurant which is primarily Arabic and indicated that many of the employees have been interviewed by the authorities.

She noted that the manager, MACHMOUD SIAM, aka Mike, was observed by her to be quite elated over the assassination of Senator KENNEDY. He expressed the opinion that it had been committed by Jews. The bartender, SAM YASIR (phonetic), expressed the opinion it had been committed by Catholics. This was before the identity of SIRHAN BISHARA SIRHAN had been established.

The brothers of SIRHAN SIRHAN, namely ADEL SIRHAN and SHARIF SIRHAN, are known at The Fez, ADEL having been a former employee. SHARIF is a regular customer.

Miss BUTLER furnished the name of MYLENE KAY (phonetic) as a former girl friend of ADEL and who probably is acquainted with the entire SIRHAN family. KAY is an Australian and is believed to be currently employed as a belly dancer at the Barefoot Bar, Vacation Village, San Diego.

Miss BUTLER stated that the owner of The Fez is LOUIS SHALEBY, aka Louis Shelby. He resides on North Berendo Street and has telephone number NO 3-2649. Miss BUTLER noted that SHALEBY does not appear to be sympathetic with the Arabic clientele and has been quite upset about the assassination. The Fez has been closed since the assassination inasmuch as SHALEBY feels it is unsafe to open.

She stated that she believes most of these individuals used motion picture cameras in making their films. She stated that aside from the local television channels there were also representatives from Canadian Broadcasting Company and Swiss Television. She stated that JOHN FRANKENHEIMER of MGM Studios also took photographs.

SALENGER advised that to her knowledge the only person that took any photographs for their own personal use was a volunteer worker by the name of ANNIE (LNU). SALENGER stated that she would attempt to further identify ANNIE and obtain her address and telephone number.

On 6/8/68 at 3:51AM one HECTOR SALAZAR, home address 4264 Alla Road, Culver City, California telephonically advised that his brother JESUS SALAZAR was at the AMBASSADOR HOTEL the morning ~~SENATOR KENNEDY~~ was shot. He added that JESUS told him that he observed a man and woman leaving the AMBASSADOR HOTEL immediately after the shooting, and one of the two made the statement that "WE SHOT THE SENATOR". He added that JESUS told him he had not called the police, because he was scared.

During this conversation with HECTOR SALAZAR, the writer heard an individual in the background, with a spanish accent, who seemed to be under the influence of alcohol. HECTOR SALAZAR advised the writer, that this individual was his brother JESUS, and that he was intoxicated, but reiterated that he felt positive his brother was being truthful, when he had told him what he had witnessed at the AMBASSADOR HOTEL, the morning SENATOR KENNEDY was shot.

HECTOR SALAZAR did not appear to be under the influence of alcohol during this conversation, and advised that he was calling long distance, and he was about to hang up, but added that he and his brother could be contacted at 4264 Alla Road, Culver City, California. He said that he and his brother would be at this residence on 6/8/68 and that they were both unemployed. He went on to say that this call was being made from a pay phone since there was no telephone at their residence.

On 6-10-68 ~~HANS PETER BIDSTRUP~~, Electrician, Maintenance Dept. Ambassador Hotel, Los Angeles advised that on the night of 6/4/68 and he was on duty in the sound booth at the Rafferty Party in the Venetian Room at the Ambassador.

At about 11:00 PM, 6-4-68 an individual wandered into the booth with a drink in his hand and made inquiries relative to Senator KENNEDY, ie whether KENNEDY was in the hotel; when he was coming to the hotel; what floor or room KENNEDY was staying in the hotel; also, the nature of the security for Senator KENNEDY; possibly whether or not the Senator had any "bodyguards".

During the conversation a Los Angeles Fire Dept. fireman in uniform came into the booth and was present for a portion of the above conversation. The fireman left and shortly thereafter returned, staying only a few minutes and left again.

BIDSTRUP stated that the individual to whom he talked in the booth looked very much like a photo of SIRHAN SIRHAN.

BIDSTRUP described the individual to whom he talked in the booth as follows:

Male; Caucasian, possibly Mexican; early twenties; 5'6" or 7"; black curly hair; slender build; wearing no hat; a dark blue faded sweatshirt, with long sleeves and a full length zipper down the front; with blue denim trousers.

BIDSTRUP described the fireman in question, as: male, white; 30 years; 6'; 180#; medium build; possibly blonde hair; fair complexion.

In the event any difficulty is experienced in conducting the interview with PEREZ or if he continues to refuse the interview, SA LA JEUNESSE, who has liaison with the District Attorney Office, should be advised.

A Spanish speaking agent should conduct this interview inasmuch as PEREZ' command of the English language is limited.

Of the names appearing on the above list, ROOSEVELT GRIER, RAFAEL JOHNSON, and C.D. DILL, a LAPD Homicide Detective, did not testify before the Grand Jury.

JOHN HOWARD, a member of the Los Angeles County District Attorney's Prosecutive Staff, who thus far has handled the Grand Jury and court appearance in behalf of the Los Angeles County District Attorney with regard to SIRHAN, advised on 6/8/68, that JESUS PEREZ, mentioned above, is an individual who appeared before the Grand Jury and was not, in his opinion, a particularly helpful witness. HOWARD requested that in the event PEREZ is reinterviewed by Agents of the FBI, the results of that interview be made available to his office so that a comparison and evaluation could be made with the previous interview conducted. It was further HOWARD's opinion that the caliber of witness which PEREZ proved to be was quite probably due to his limited intellectual capacity and a language problem in that he does not speak good English.

Mr. HOWARD also advised that Judge ARTHUR L. ALARCON has ordered five copies of the daily trial transcript to be prepared during subsequent proceedings in this matter. He stated that in the event the Federal Government would be in need of a copy of the daily transcript, arrangements should be made through his office for appropriate copies to be made and which would have to be paid for.

On 6/10/68, GEORGE MURPHY advised that a complete transcript of the proceedings in this matter before the Los Angeles County Grand Jury on 6/7/68, had not been completed. It is believed that the complete transcript will not be completely typed for a period of approximately ten days.

On 6/10/68, Mr. HAROLD SHARP, 1611 South 4th Avenue, Arcadia, California, advised that DOBASS was sponsored on his entry to the United States as a student from Jordan in 1956. He stated that he was sponsored by an unknown friend of his wife's aunt, whose name was Mrs. JOHN G. GILLETTE, now deceased. He said the sponsor, whose name is unknown, is also deceased, and in 1956 the unknown friend and Mrs. GILLETTE resided at 15 $\frac{1}{2}$ El Dorado in Arcadia.

Mr. SHARP said he has met DOBASS on several occasions in 1956 - 1958 and believes DOBASS returned to Jordan sometime in 1962. He does not know if he attempted to re-enter the United States. He did not know, nor did Mrs. SHARP know that DOBASS had attended any other school in the United States except PCC. SHARP and wife visited Jordan in 1963 and tried to find DOBASS, but could not locate him by telephone. Mrs. SHARP advised that they have not seen DOBASS in at least eight years although she was aware that he had subsequently, that is after he had finished at PCC, attended USC and UCLA. They had no further information.

On June 10, 1968, Mrs. ~~CORINE KOSTICKA~~ and her daughter, ~~CLAUDIA KOSTICKA, 3702 El Carmen Avenue, Orange, California,~~ personally appeared at the Santa Ana Resident Agency Office.

5B-1076 Mrs. KOSTICKA stated that soon after the assassination of Senator ROBERT F. KENNEDY, she called ~~LINDA JAMES BAHTISHI~~, also known as Mrs. ~~MUSTAFA BAHTISHI~~, a friend of CLAUDIA, and stated "Isn't it terrible about Senator KENNEDY?" LINDA replied, "He should have been killed he is so pro-Jewish." The KOSTICKAs stated that they felt this matter should be brought to the attention of the FBI since it is not known if the assassination was a conspiracy. They explained that they had known the BAHTISHIs in Bozeman, Montana, and that MUSTAFA BAHTISHI had been a student at Montana State University from about 1961 to 1963, when he married LINDA. She described MUSTAFA as follows:

Mrs. HALDOR LILLENAS (LOLA), age 74, 5232 Roe Avenue, Mission, Kansas, advised she and her late husband were sponsors for BISHARA SIRHAN and family. Two oldest children of SIRHAN family remained in Jordan because LILLENAS refused to sponsor them as they were of legal age.

LILLENAS stated she and her husband, who was an ordained minister of the Church of the Nazarene, went on a European vacation in 1955. While visiting in Jordan, BISHARA SIRHAN contacted LILLENAS and inquired as to the possibility of coming to the United States. LILLENAS decided to sponsor the SIRHAN family as their inquiries reflected the SIRHAN family to be a worthy christian family.

Mr. LILLENAS, working through Church World Service and the Friends Organization, became the sponsor of the SIRHAN family and in November, 1957, SIRHAN came to Pasadena, California, and lived in the LILLENAS home for about three months until suitable housing and employment could be obtained.

BISHARA SIRHAN left his family in 1958 and returned to Jordan because he felt living in the United States did not allow him to control his family as in the past. BISHARA SIRHAN wrote letters to his wife requesting her to return to Jordan and if she refused he would obtain a divorce. Mrs. SIRHAN refused to return to Jordan and told LILLENAS since she had been married in the Greek Orthodox Church, no divorce would be granted to her husband.

LILLENAS advised her husband had handled all the responsibilities pertaining to the SIRHAN family and after Mr. LILLENAS died in 1959, she has had only one contact with the SIRHAN family which was in about 1963 when AYDA SIRHAN, a daughter, died. At this time, LILLENAS saw only Mrs. SIRHAN and she visited for only fifteen minutes. LILLENAS moved from Pasadena, California, to Mission, Kansas, about three years ago and has had no contact with the SIRHAN family since moving to Mission, Kansas.

During the time LILLENAS knew SIRHAN, politics were never discussed and they always appeared to be a devout christian family. SIRHAN BISHARA SIRHAN was recalled as a well-behaved, industrious, and obedient child.

LILLENAS stated her contact with SIRHAN BISHARA SIRHAN was only at the time when they resided for the three month period in her home in Pasadena, California, at which time SIRHAN was a child approximately thirteen years of age.

In connection with the lead being coordinated by SA RICHARD BUCARO, relating to a student-oriented publication titled, "The Opinion," found by the police among the personal property of SIRHAN B. SIRHAN, the following information was furnished the writer by Captain DALE HILTON, USN (Retired), established source, who is the Director of Student Publications, Room 303, Student Union Building, University Avenue and Childs Way, University of Southern California (USC), on June 11, 1968:

Captain HILTON said that he personally was not previously acquainted with the publication "The Opinion," but he caused a team of library researchers at the USC Library to check on this matter, and he has been advised that "The Opinion" is an intercollegiate mimeographed periodical, put out in two column format, for circulation to student leaders on college and university campuses throughout the United States. It is published by one JOSEPH MORELLA, Box 82, Nutley, New Jersey.

Publication of "The Opinion" was started in 1962. Contributors to it have been from Harvard University, the University of Illinois, University of Pennsylvania, and the University of Wisconsin. Except for a limited "carry over" the periodical deals largely with colleges and universities east of the Mississippi River.

The above is the only student-oriented periodical bearing the title "The Opinion," which the USC library research team was able to come up with, according to Captain HILTON.

Re Complaint Form dated 6/7/68 regarding EDNA BONACICH.

IRENE LONG, 12208 Clover Avenue, Los Angeles, California, was contacted at her residence regarding her telephone call to the FBI stating that EDNA BONACICH might be identical with the girl in the polka dot dress being sought by the Los Angeles Police Department.

During the interview it appeared that Mrs. LONG had a personal dislike for EDNA BONACICH and had no basis for believing that she might be the girl in the polka dot dress. She had worked for BONACICH as a KENNEDY campaign worker and during this time had never seen BONACICH in a dress. She also had not been in contact with BONACICH since the assassination. She stated further she had no real reason for believing that BONACICH might be identical with the unknown girl.

On 6/11/68, LA 4863-S furnished to SA J. CHARLES MERRIMAN a written report dated 6/11/68 containing the following:

On 6/8/68, LA 4863-S was in attendance at a meeting of the Students Club, Western Section, Southern California District Communist Party (SCDCP), at the residence of JIM BERLAND, 1974 South Robertson Avenue, Los Angeles. [X]

BERLAND announced at this meeting that subsequent to the assassination of Senator ROBERT F. KENNEDY, FBI Agents had visited and interviewed WALTER CROWE at the latter's residence and employment. RON RIDENOUR criticized CROWE for talking to FBI Agents. RIDENOUR further commented that every person has the right not to talk to the FBI until a warrant is presented, after which a person then has the right to see his attorney first. BERLAND suggested to CROWE that he should get in touch with attorney BEN MARGOLIS before submitting to another interview with FBI Agents. [X]

CROWE stated at this meeting that he did not divulge any information to the interviewing FBI Agents regarding the CP or CP members. CROWE commented that he was nervous while being interviewed by the FBI Agents. [X]

She was very desirous of knowing when they were going to be returned as campaign headquarters had intended to acknowledge in writing the cooperation of each of these individuals and that this was the only record which they had of the volunteers. She was advised that the writer would determine when she might expect them back and she would be contacted either by the writer or another representative of the Bureau.

On 6-11-68 HANS KORTHOFF, Assistant Manager; Ambassador Hotel advised that on Monday evening, June 3, 1968 Mrs. MARGARET MARY VENABLES, 760 So. Maringo Avenue, Pasadena, California, one of the supervisors in the House-keeping Dept. of the hotel telephoned him from her station in the hotel to tell him that two individuals whom she described only as "young Mexicans" were prowling her department and had requested of her or one of the employees in her department, that they furnish these individuals mess jackets so they could pose as waiters to get into the "KENNEDY quarters".

KORTHOFF advised that Mrs. VENABLES is presently on extended leave as her husband is seriously ill and her return to work indefinite.
