He further stated that GALLIVAN aided in the subduing of SIRHAN BISHARA SIRHAN after the assassination of Senator KENNEDY. In addition, a man by the name of UNO, who ROSEN described as the manager of the Ambassador Hotel, was in the immediate area at the time KENNEDY was assassinated. Post Office Carrier ANTHONY DI NICOLA, Station A, Hartford Post Office advised in confidence on July 16, 1968, that BUTEAU is unemployed and apparently subsists on funds supplied by Connecticut State Welfare.

Mrs. JOSEPH LASATA of 47 Congress Street, Hartford, advised on July 16, 1968, that Mrs. BUTEAU has resided at 51 Congress Street for approximately two years and is the mother of four small children. She is apparently an alcoholic and has been observed in a highly intoxicated condition on many occasions. She appears to be separated from her husband, as no man acting in that capacity has been observed at her residence. At least one man, however, has been observed at the location for extended periods at various times. Mrs. LASATA stated that no one in the neighborhood, with the exception of a Mrs. SLATER, who resides in the same building with Mrs. BUTEAU, has anything to do with Mrs. BUTEAU and that therefore nothing further is known of her.

In view of the above facts, no further action is being taken in this matter, UACB.

~~JOHN A. SWEDE~~ has been interviewed at Los Angeles and states he and his wife were at the Ambassador Hotel in Baghdad during the evening of 5/17/68. While they were in the dining room, a waiter said ROBERT KENNEDY had been shot in the head. The waiter said he heard this information over the Arabic radio. The waiter commented that the trouble with the world is the "Jew" and the U. S. is dominated and motivated by Zionists.

Mr. SWEDE is unable to explain why the waiter made comment regarding the shooting of Senator KENNEDY about three weeks before he was actually shot. He felt the information was important enough that it be brought to the attention of someone, and he notified the American Embassy in Singapore, shortly after the actual shooting of KENNEDY.

At 12:20AM, 7/20/68, ~~PATRICK O'BRIEN~~, 1800 N. Western Ave., Los Angeles, California, telephone Hollywood 22541, telephonically contacted the writer and advised as follows:

At approximately 11:30PM, 7/19/68, while O'BRIEN was having a beer in the ~~Playwrite Bar~~, located at the corner of Hollywood & Western, Los Angeles, a man named John introduced himself to O'BRIEN and Eddie the bartender, and advised that he was a friend of SIRHAN B. SIRHAN's brother, and knew the SIRHAN family well. O'BRIEN continued that John stated that either he (John) or a member of the SIRHAN family worked at the PEZ Restaurant, located at the corner of Vermont & Sunset, Los Angeles.

O'BRIEN advised that all the man had to say was that all Jordanians shouldn't be blamed for the Kennedy assassination.

O'BRIEN advised that he did not recall having ever seen John before, and that he was furnishing the information in case it might be of value to the FBI. He described John as follows:

white male appearing to be of Jordanian descent, age 25, Ht 5'9", Wt 145, build, very slender, Hair dark, complexion, dark.

Inquiries concerning JOHN HENRY FAHEY, Social Security No. [REDACTED] born 10/29/27, WMA, indicated emotional instability on his part. When employed by Fields Jewelers, SF, he provoked and assaulted co-workers, as well as customers. FAHEY also fired from Gensler Lee Jewelers, SF, after tipping over display case of jewelry following a mental upset. He also didn't get along with employees at Shick Service Center, SF, and transferred to their LA office, 611 So. Hill Street, after four months' employment.

Records Bank of America show FAHEY employed for nine months as a loan collector. He submitted his resignation to be effective 1/15/66 but was let off 1/4/66, paid to 1/15/66, following arguments with superiors. Also noted was FAHEY unable to get along with co-workers. FAHEY in USAF 1948-52, AFSN 12 301 036, honorably discharged. Also, U.S. Navy 1946-48, NSN unknown.

No further inquiries being made SF concerning FAHEY.

The writer was instructed to interview three employees of the Ambassador Hotel.

On 6/19/68, attempts were made to contact ESTRADA DURAN and WALTER JOACHIM with negative results.

DEG MACKINGA, 22109 Albert Ave., Torrance, advised she was working at the hotel on the night in question, however, she devoted her entire time to working in the ballroom downstairs from the Embassy Room. She had no opportunity to see KENNEDY or to observe any of the activity that took place upstairs.

MACKINGA further advised she was informed by JANE (LNU), the cashier in the Venetian Room of the hotel, that she observed SIRHAN order a coke in the Venetian Room earlier on the afternoon in question.

On 6/28/68, upon making inquiry in the Chef Department of the hotel, it was ascertained that WALTER JOACHIM was a patient at Keiser Hospital, Los Angeles.

It was further ascertained from records of personnel at the hotel that ESTRADA ELIAS DURAN listed his residence address as 10746 Telfair Ave., Pacoima.

On 7/1/68, an attempt was made to locate DURAN at the Pacoima address with negative results. It was ascertained that JOE ENOHOS and family has been residing at that address for the past three years. No one at that address has ever heard of DURAN. A neighborhood inquiry was made re any knowledge of DURAN with negative results.

It is further suggested that WALTER JOACHIM be interviewed upon his immediate release from the hospital.

It is also suggested that JOHN DAUGHERTY, Search and Investigation of INS, be contacted and a search of forms I-213s' be made to ascertain if DURAN can be identified as having been picked up by INS and possibly deported.

Mrs. HELEN GARVIN, Assistant Librarian, Santa Catalina Branch, Pasadena Public Library, 900 East Washington Boulevard, Pasadena, California, advised from records that SIRHAN SIRHAN and his sister, AIDA SIRHAN, listed as a reference on their library cards FRANCISCO TAPIA, 691 East Howard, Pasadena, California.

She further pointed out that SIRHAN SIRHAN's brother, MUNIR SIRHAN, on his library card listed as a reference a FRANCIS LEE LAIR, 1645 North Lake Avenue, Pasadena, California.

On 6/24/68 and 7/8/68 inquiries at 1645 North Lake Avenue, Pasadena, California, concerning one FRANCIS LEE LAIR met with negative results.

On 7/8/68 Mr. and Mrs. ROCCO ROCCO, 1647 North Lake Avenue, Pasadena, California, advised that they have resided at this location for approximately the past six years and have owned and managed the property at 1645 North Lake Avenue. During this period of time they advised that they could not recall ever renting this property at 1645 North Lake Avenue to one FRANCIS LEE LAIR. They stated further that they kept no records concerning former tenants. They stated that they have had a frequent turnover of tenants at said location.

On 6/24/68 and 7/8/68 attempts to contact FRANCISCO TAPIA, 691 East Howard Street, Pasadena, California were negative inasmuch as it was ascertained no one was at home.
