On 7/22/68, HENRY CHARLES FREDERICKS, aka Hank, Draftsman, General Electric, Rome, Georgia, home address 1901 Dean Street, Rome, Georgia, Roy's Trailer Park, telephonically contacted SA WILLIAM K. PATTON advising he wished to inform the FBI that he had written a letter to SIRHAN B. SIRHAN, the assassin of Senator KENNEDY as he felt sorry for him as a human but did not condone what he did. He said he had put the letter in an unsealed envelope and enclosed it in a letter to the Chief of Police of the Los Angeles, California PD, asking the COP to furnish his letter to SIRHAN if they were allowed to do so. He claimed the contents were of a general conversational nature and mentioned nothing of what he had done.

FREDERICKS advised he was infoming the FBI of his writing this letter as he felt the FBI at Rome, Georgia, would receive an inquiry concerning him.

This is being submitted to Los Angeles in the event FREDERICKS' letter is received by the local authorities.

Mrs. PANTHEA CASHOW, manager, Bartmore Beauty College, 12926 Main St, contacted 6/21/68, advised that the only JOHNNY she has working for her is JOHNNY NAZARIAN, 10602 Tibbs Circle, Garden Grove, Calif., apt. # 5, telephone 636 0184. She stated however, he is a Jordan subject and is in Jordan, visiting his family. She advised she will immediately advise when he returns, which should be mid-July, 1968.

Mrs. CASHOW advised 7/22/68, that NAZARIAN has returned on the preceding day and could be contacted at home.

On 7/24/68, JOHNNY NAZARIAN, apartment # 4, 10602 Tibbs Circle, advised he is a citizen of Jordan and formerly resided at Aman, Jerusalem. He stated since he is from Jordan, he has been very interested in suspect SIRHAN, but at no time did he meet him and only knows about him since the murder of Senator ROBERT KENNEDY. He added that his home is about 100 miles from that of SIRHAN in Jordan.

He stated he has only newspaper knowledge of this person and can offer no information about him.

Following investigation conducted by SA J. ROBERT SULLIVAN:

Mrs. McKEE, Secretary, Chief of Police, South Pasadena, on 7/22/68 advised that the records of this department contain no record on WILLIAM CRAMER, that on 6/5/68 no males were arrested by the South Pasadena PD and that during the entire month of June, 1968 no person was arrested by this department for carrying concealed weapons.

MARGARET TRAINOR, clerk, Pasadena Police Department on 7/22/68 advised that the files of this department reflect that WILLIAM HAROLD CRAMMER also known as William Harold Cramer was arrested on 6/5/68 on charge of Inv. 211 PC Robb. He was released on <sup>bond</sup> 6/8/68. He is listed as a transient, residing at 275 N. Chester, Penna. born 6/22/42 at Braddock, Penna. FBI# 217 372 D. (( Det.R. HILL advises he has 2 cts violation 417 PC pending

Inquiry at 275 N Chester on 7/22/68 disclosed that CRAMMER or CRAMER had moved out about a month ago, believed to be living on East Villa in Pasadena.

ADM: MARY ANNE KING, Secretary, Postmaster, Pasadena on 7/22/68 advised that WILLIAM HAROLD CRAMER had moved to 159 East Villa.

Mrs. WILLIAM CRAMER, 159 East Villa, on 7/22/68 advised that her husband works in the Pasadena area and would be home late in the day.

Mr. ~~WILLIAM HAROLD CRAMER~~, born ~~WILLIAM HAROLD CRAMMER~~, was interviewed on 7/23/68 at which time he advised that he does not know where RAY's GRILL is located, that he has not lived in South Pasadena. He related that he and his wife came out from Cleveland, Ohio arriving here on April 25, 1968 and that although he previously lived in Pasadena several years had elapsed during his present and former residence here.

CRAMER states that SIRHAN is known only to him by what he has read in the papers, that specifically he never personally SIRHAN.

Enclosed herewith is one xeroxed copy of a letter dated 7/9/68, from the Chicago State Hospital, Chicago, Illinois, directed to ROBERT A. HOUGHTON, Deputy Chief of Police, Los Angeles, California, Police Department (LAPD).

This letter, which is self-explanatory, pertains to one NORMAN SYDNEY WEXLER, who has been assigned FBI Number 486 535 A. The letter is in response to a previous letter directed to the Chicago State Hospital by the LAPD requesting medical records regarding treatment received by WEXLER when a patient at that institution.

For information of Chicago, WEXLER is not being considered as a participant in captioned investigation. However, following the assassination of Senator KENNEDY, WEXLER paraded in front of Universal Studios in Hollywood carrying a sign commenting on the death of KENNEDY and setting forth that DARRYL ZANUCK "would be next", or words to that effect. LAPD desirous of establishing sufficient background on WEXLER to establish him as a "psycho". It is not anticipated that this information will be used for prosecutive purposes or made available to the public or news media.

LEON DOUGLAS RALPH, 14013 Radall Avenue, Los Angeles, California, Assemblyman, 55th District, 1922 E. 103rd Street, Los Angeles, California, advised the writer on 7/22/68 that he had no knowledge of the shooting of Senator KENNEDY as he was enroute to the Hotel when he heard of the shooting and the Senator had been taken to the hospital by the time he (RALPH) arrived at the Hotel.

However, RALPH advised that he had heard that a MARIAN DAVIS, 825 West Elm Street, Compton, California, had mentioned that she had seen SIRHAN SIRHAN in the kitchen of the AMBASSADOR Hotel on Sunday night, June 2, 1968.

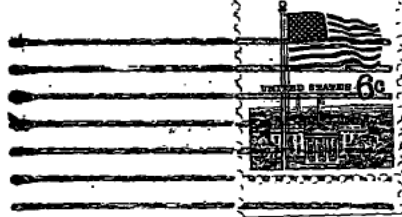

Gentlemen:

I want to report something confidential:

We own an Apt. Bldg., located at 7336 Fountain, West Hollywood. A young man by the name of Frank Abdala had rented a Single Apt. (# 10) in that bldg. from last May 27 to June 27. He said he came here many years ago from Egypt and that he was employed at the Ambassador Hotel (We didn't check.) As an <sup>e</sup>excuse for moving out so soon, he said that he was going to work out-of-town ("somewhere in the mountains"), although he gave "General Delivery, Hollywood" as his forwarding address. The rent check he gave us for one month in advance, was properly signed Frank Abdala and drawn on a North Hollyw'd Bank. He was tinkering with his car most of the time, behaving normally otherwise.

We have now received an electric bill for a Brashear, Lawrence, Apt. 10 - a name entirely unknown to us. The similarity of this name with the middle name of Sirhan B. Sirhan arises our suspicion. (It may also be a false alarm).

## RE JOSE A. PEREZ CUESTA

On 7/23/68, Investigator JAMES BUSSELLE, Immigration and Naturalization Service (INS), advised SA R.J. LA JEUNESSE, JR. that he had conducted a search of their central indices in Washington, D.C. concerning JOSE A. PEREZ CUESTA. No one by that name was mentioned in their Central Office indices, however, there was a JOSE ANTONIO PEREZ of the Dominican Republic, who was issued a Dominican Republic passport No. 183382 in February 1967. That individual subsequently was granted a B-2 (non-immigrant visitor's visa) No. 016120 by the American Embassy in the Dominican Republic, which permitted him to enter the United States. He subsequently entered the United States at San Juan, Puerto Rico, on 2/25/67, and thereafter took up residence in New York City where he remained until he left the United States on 10/14/67, as a "volunteer departee" at the request of the United States Government. During his residence in the United States, he lived at 971 Kelly Street, Bronx, New York, Apartment 1E. He was employed by the Empire State Display Company, 718 Broadway, New York City, from June 1967 until his departure from the United States.

INS files reflected his residence in the Dominican Republic was Calle Emilio Prudonme #24, San Pedro De Macoris. His father was indicated to be AUGUSTINE PEREZ (deceased) and his mother, ELSA PEREZ, of the Dominican Republic.

Enclosed herewith are five copies and one original of a letterhead memorandum regarding one, JOSE A. PEREZ QUESTA.

The information contained in the letterhead memorandum was furnished to SA R. J. LA JEUNESSE, JR., on 7/19/68 by Chief GEORGE STONER, of the Los Angeles County District Attorney's Office, Bureau of Investigation, 524 North Spring Street, Los Angeles, California.

Mr. STONER explained that the Honorable EVELLE J. YOUNGER, District Attorney for Los Angeles County, received a letter from Mr. THOMAS C. LYNCH, Attorney General for the State of California, dated 7/15/68. In his letter to Mr. YOUNGER, Mr. LYNCH included a letter bearing a date of 6/16/68 from one, JOSE A. PEREZ QUESTA of Calle Maria B. Sanchez, Number 46, Enriquillo, Dominican Republic. In the letter, PEREZ sets forth a personal desire in his part to personally confront SIRHAN BISHARA SIRHAN in personal combat for the purpose of killing him.

Mr. STONER advised that the letter was referred to the Office of the Los Angeles County District Attorney because SIRHAN will be prosecuted within the jurisdiction of that agency. In view of the Dominican Republic residence of PEREZ, this office does not anticipate conducting any investigation with respect to this letter. He advised, however, that it was desirable that the Bureau be advised and that perhaps appropriate authority to the Dominican Republic could be alerted, in the event PEREZ attempted to obtain permission to enter the United States.

Chief George Stoner of the Los Angeles County District Attorney's Office, Bureau of Investigation, 524 North Spring Street, Los Angeles, California on July 19, 1968 advised his office had received a letter from the Honorable Thomas C. Lynch, Attorney General for the State of California dated July 15, 1968.

Mr. Lynch forwarded to the Office of the Los Angeles County District Attorney, a letter handwritten in Spanish, dated June 15, 1968 from Enriquillo, Dominican Republic. The letter states that the writer, Jose A. Perez Questa extends his greetings to the Attorney General of California and requests his assistance in "something very important which must be said". The writer of the letter states, "I want to kill Sirhan Bishara Sirhan, I want to fight hand to hand with this Jordanian devil". The writer of the letter goes on to state that he desires an opportunity to "give what he deserves to this cowardly assassin". The letter continues stating that the writer would like to "confront him on the battle field, fist to fist with this dirty assassin in order to hit him strongly with my fist and after killing him to take him apart piece by piece with my teeth and if it is possible to eat him also because this dirty Jordanian does not deserve a different death since Sirhan Bishara Sirhan took the life of an idealistic man and humanitarian as Robert F. Kennedy".

The writer of the letter again repeats his desire as set forth above and requests the assistance of Mr. Lynch in helping him to ask the authorities of the Government of the United States, "to see if they can authorize such a thing". The writer of the letter closes by saying,

"Dear Sir, I hope you will extend me the favor of fighting in this way. Do everything you can. I will await your prompt reply without more". It is signed Jose A. Perez Questa, of Calle Maria B. Sanchez, Number 46, Enriquillo, Dominican Republic. He describes himself as being 21 years of age, 5' 6" tall, and 122 pounds.

In addition to the letter received by Mr. Lynch's Office, there is a photograph accompanying the letter which depicts a male individual, apparently Sirhan, upon which there is written, in part, "may the wrath of the devil come upon you, Jordanian devil, the dog without conscience; the devil controls your soul".

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

On 7/17/68, "RICHARD DAVID GILES contacted the Pomona Resident Agency telephonically. When questioned about the notations on a piece of paper regarding SIRHAN SIRHAN found in his possession at the time of his arrest on a drunk charge, GILES advised that he had been reading about SIRHAN in the newspapers and that this writing had been made by him in the form of doddling and had no significance whatsoever. He stated that he knew nothing of SIRHAN SIRHAN except what he had read in the papers and heard on news media of him.

TERRY was observed driving a 1968 Chev. Station Wagon, License #WSR-878 which is registered to ALLEN AUTO LEASING, 6020 Washington Blvd., Culver City. This is one of three vehicles being leased by the Black Congress. (1.89 has been made on these vehicles.)

The four other male Negroes who were not ID'D were also very vocal during the discussion on the corner. They left the scene in the above vehicle and no police incident occurred.
