These Officers were detailed to contact Lt. R.E. Smith, Shift Commander, at the Emergency room at St. Luke Hospital. Upon arrival at the location Lt. Smith advised the undersigned and partner Off. Nicholas that the above suspect was arrested for the above listed charge and to transport him to the Pasadena City Jail for booking.

The suspect was transported to the City Jail and was asked by the undersigned if he wished to be examined by a doctor, as the suspect had complained of a sore throat. The suspect refused and stated he would have his private doctor examine him later in the morning. After completion of the booking process the suspect was taken to the Emergency Center to be examined by a doctor but refused all medical aid. He was then taken back to the Jail where he posted bail and was released. Once again the suspect was asked if he wished treatment by the Emergency Center and stated that he would submit to an examination. The suspect was examined by Dr. L. Jones who stated the suspect had a possible bruised throat and a small contusion on the lower lip.

The suspect was transported to Wards Garage after the medical examination for release of his vehicle which was impounded. It should be noted that the suspect was extremely uncooperative during the booking process and when taken to the Emergency center.

On 8/7/69 MORT SALTZMAN, Associated Press Office, telephone 746-1200, appeared at the Los Angeles Office. He advised as follows:

He received information that one MAX BERMAN, who resides 4629 Fulton Avenue, Sherman Oaks, California, was in Israel 5/18/68. While in Israel on 5/18/68 ~~he~~ heard a news report that Senator ROBERT KENNEDY had been shot. Subsequently he returned to this country and was in this country in June, 1968, when the assassination transpired.

BERMAN told SALTZMAN he furnished this information to the FBI and investigation had been conducted. SALTZMAN desired to know the following:

1. Did BERMAN furnish such information to us?
2. Was it investigated?
3. Was investigation conducted in Israel?
4. The outcome of the investigation.

At this point Assistant Special Agent in Charge PHILIP R. SHERIDAN joined the ~~investigation~~. Mr. SHERIDAN advised SALTZMAN that all of our investigation had been turned over to the District Attorney's Office; the District Attorney had held a press conference after the SIRHAN trial; SIRHAN's conviction has been appealed. He suggested to SALTZMAN that in view of the above that perhaps he desired to contact the District Attorney's Office. SALTZMAN stated he understood.

SUBJECT: KENSALT

On 8/20/69, JOHN CHRISTIAN (telephone number 659-3726), telephonically contacted the writer to advise that he has been continuing his investigation into the assassination of the late Senator ROBERT F. KENNEDY. His inquiries have been restricted, however, to what he believes to have been a conspiratorial aspect of the activities of SIRHAN B. SIRHAN and the Reverend JERRY OWENS. CHRISTIAN went on to explain that he has been continually rebuffed between Los Angeles County District Attorney's Office and the Los Angeles Police Department when he has attempted to furnish information supporting his contention of the existence of a conspiracy between the two men. In accordance therewith, he has contacted JESSE UNRUH of the California State Legislature concerning his beliefs. According to CHRISTIAN, UNRUH has strongly urged him to furnish the information in his possession to Assistant California Attorney General CHARLES O'BRIEN. CHRISTIAN explained he intended to do so and to urge O'BRIEN to use the powers of his office to institute an appropriate investigation into the conspiracy aspect of the investigation.

Prior to doing so, however, CHRISTIAN desired to confer with the writer for the purpose of furnishing information which he feels definitely establishes active conspiracy between SIRHAN and OWENS.

In accordance with the foregoing, tentative arrangements were made with CHRISTIAN for the writer to speak with him regarding his beliefs sometime during the week of 8/24/69.

Any information obtained from CHRISTIAN at that time will be appropriately handled and disseminated.



Re Bureau letter to Los Angeles dated 6/27/69.

A review has been made of the final report by the Los Angeles Police Department captioned, "An Investigation Summary of the Senator Robert F. Kennedy Assassination". This final report by the Police Department was dated February 1969, and consisted of nine volumes.

This report was written in a narrative style and subdivides the investigation into various component aspects.

The review made by this office reveals there is no information contained therein which differs in substance from the information developed in the course of the Bureau investigation in this matter.

It is noted that in Volume 1 of the police report in describing the events just prior to the assassination it is indicated that WILLIAM BARRY, a bodyguard of Senator KENNEDY, had decided on a last minute change in the route that Senator KENNEDY would take off the stage in the Embassy Room of the Ambassador Hotel.

When BARRY testified at the SIRHAN trial in Los Angeles he indicated that he did not expect the Senator to leave the stage in the direction that he did and therefore, he, BARRY, was caught out of position and was considerably behind Senator KENNEDY at the time that he was shot.

Further, a review of the Los Angeles Police Department report reflects that this office conducted interviews with all individuals who had any substantive knowledge or connection with this matter with the exception of actual police officials who were not interviewed and of which the Bureau is aware.

On 8/28/69, JOHN CHRISTIAN, 840 North Larrabee, Beverly Hills, California, telephone 659-3726, was contacted at his residence per his request.

When contacted CHRISTIAN explained he is still currently engaged in investigating and researching what he believes to have been a conspiracy between JERRY OWEN and SIRHAN BISHARA SIRHAN in the assassination of the late Senator ROBERT F. KENNEDY.

CHRISTIAN explained that one PETER HITCHCOCK of San Francisco, California, whom he described as a "financier", had contacted OTIS CHANDLER in his behalf. OTIS CHANDLER is the publisher of the Los Angeles Times newspaper and when contacted by CHRISTIAN, designated JERRY COHEN and DAVE SMITH of the Los Angeles Times staff to meet with CHRISTIAN. CHRISTIAN plans to name the book he is writing "Plot to Murder Robert F. Kennedy", which is being co-authored by WILLIAM TURNER, a former Special Agent of the FBI. According to CHRISTIAN, he has already completed a 300 page outline of his manuscript.

On 8/27/69, COHEN and SMITH met with CHRISTIAN at his residence and spent the better part of one day with him, going over the material which CHRISTIAN has in his possession, concerning what he believes to be a conspiracy.

In the conversation with CHANDLER, he stated he learned from ROBERT B. KAISER, that SIRHAN went to Corona or near the Corona area sometime between 4:00 and 5:00 p.m. on 6/3/68. CHRISTIAN explained he cited the foregoing because of the "gratuitous" statement made by MARY SIRHAN, his mother, to the effect that SIRHAN was at the family residence at 4:30 p.m. on 6/3/68, watching television.

KAISER, ~~it~~ will be recalled, was formerly a member of the defense team representing SIRHAN and had access to results of investigation conducted by defense as well as numerous interviews with SIRHAN and other members of his family.

KAISER further advised that SIRHAN told him that on 6/3/68, he, SIRHAN, put 350 miles on his car. CHRISTIAN speculated that the above distance would represent approximately a round trip from Pasadena to San Diego and return. Of further significance, according to CHRISTIAN, was the fact that KENNEDY was making an appearance in San Diego on 6/3/68. Continuing further CHRISTIAN stated that KAISER told him that SIRHAN had confided in KAISER that he, SIRHAN, had been to Orange County on several occasions, probably in Anaheim.

Again with respect to SIRHAN's alleged trip on 6/3/68, CHRISTIAN quoted an investigation conducted by police authorities and reflected SIRHAN had purchased gas at a service station where he was formerly employed in the Pasadena area at 11:00 a.m. on that date. CHRISTIAN stated that an examination of a possible route from that area to San Diego and return would reflect a distance of approximately 350 miles. CHRISTIAN contacted representatives of the AAA who furnished him information indicating that between the hours of 11:00 a.m. and midnight, along the route from Pasadena to San Diego, a motorist could travel approximately 45 to 50 miles per hour. CHRISTIAN assuming one to travel a speed of 50 mph would require seven hours to go from the "outer perimeter" of Corona and return. CHRISTIAN specifically dwelled on 6/3/68, since it was on that date that JERRY OWEN claimed to have had SIRHAN in his truck with him.

OWEN further claimed, according to CHRISTIAN, that he departed from Los Angeles on 6/4/68, traveling ostensibly to Oxnard, California, where he claimed to have a scheduled appointment at the Calvary Baptist Church in that city. OWEN claimed to have remained there until 2:00 p.m. when he returned to Los Angeles on 6/5/68. CHRISTIAN claimed that the information furnished by OWEN was patently false since the Calvary Baptist Church was closed from 6/4/67. Further, the church belongs to EDGAR EUGENE BRADLEY, an individual associated in religious activities with CARL MACINTIRE. CHRISTIAN maintained that OWEN never actually

appeared at the Calvary Baptist Church and deliberately steered the police in his interviews with them, to the "right wing element" at the church.

CHRISTIAN subsequently interviewed a Reverend JONATHAN PERKINS, age 80, who is also acquainted with OWEN. PERKINS is alleged to have told CHRISTIAN that the first contact he had with OWEN was during the morning of 6/5/68, when OWEN reportedly told PERKINS the same story he furnished to the police. OWEN's version differed in one respect, in that in repeating his alleged activities with SIRHAN, he attributed them in his conversation to PERKINS to have occurred on 6/4/68, as opposed to 6/3/68, in his recitation to the police. PERKINS was described by CHRISTIAN as a "prodigy of GERALD L. K. SMITH". CHRISTIAN further advised that when he contacted PERKINS, PERKINS told him that the Los Angeles Police Department had attempted to get him to "change his story."

7 | CHRISTIAN claimed with respect to the so called "polka dot dress girl", KAISER, in his upcoming book will be able to produce her and place her with SIRHAN at the "armory" during May 1968.

CHRISTIAN mentioned an individual by the name of BILL POWERS, who was acquainted with the A Bar T Stable in Santa Ana, California, who apparently came into the investigation of the assassination in December 1968. CHRISTIAN alleged that the Sheriff's Office personnel at the Lakewood Station "picked up a kid" in December 1968. That individual is alleged to have told him that he had been contacted by BILL POWERS who told him that a "preacher", later identified as OWEN, and SIRHAN had come to POWERS' residence. POWERS allegedly resides in Anaheim and the A Bar T Stable is reportedly approximately one mile from OWEN's then residence. The trip to the POWERS residence by OWEN and SIRHAN was probably for the purpose of borrowing a 1967 one ton truck, blue in color, reportedly to be used to transport horses. That visit was reportedly made on 6/4/68. The person arrested by the Lakewood Sheriff's Office was reportedly a cowpuncher at the A Bar T Stable.

CHRISTIAN claimed to have become privy to the foregoing when KAISER mentioned it to him. KAISER explained he stumbled on the foregoing in the form of a one page report while examining police records. POWERS is alleged to have told police that he sold

the 1967 truck to OWEN, but did not get all of his money for the sale. CHRISTIAN points out the variance in the 1967 truck versus the 1948 truck OWEN claimed to be driving on 6/3/68, when he reportedly picked up SIRHAN.

CHRISTIAN further conducted additional investigation at the Coliseum Restaurant where OWEN allegedly went to on 6/5/68, and where he told his story which he later repeated to the Los Angeles Police Department. One of the trainers mentioned was a person named LEWIS who stated that he had met OWEN that week prior to 6/5/68. LEWIS allegedly told CHRISTIAN that he was working with a fighter named RIP KELLY, aka Rip O'Reilly. CHRISTIAN said LEWIS told him that KELLY traveled as a seaman aboard freighters to Australia and that LEWIS did not see O'REILLY or KELLY after 6/5/68. LEWIS further allegedly told CHRISTIAN that he met with RIP KELLY at the Coliseum Hotel for one week prior to the assassination of ROBERT F. KENNEDY.

Continuing further in his inquiry CHRISTIAN stated he traced the name of one EDWARD E. GLENN of 4149 East Easter Avenue, Littleton, Colorado, whom he claims at one time was associated with a Midland Oil Company. GLENN was, according to CHRISTIAN, also a manager for fighter RIP O'REILLY, at one time in the past and furnished the address of 2139 3rd Street, Santa Monica, California. GLENN was further described by CHRISTIAN as being President of the Midland Oil Company of Wyoming. CHRISTIAN further stated that the State of Wyoming's Attorney General has GLENN under investigation and that GLENN reportedly came to the Los Angeles area in 1968 when he supposedly sold stock and property to one RICHARD OWEN whom CHRISTIAN described as a brother of JERRY OWEN.

With respect to PETER HITCHCOCK, mentioned earlier in this memo, CHRISTIAN stated he is currently married to a "former mistress" of the late JOHN F. KENNEDY. The HITCHCOCKS are raising a daughter, whom CHRISTIAN stated receives monthly checks from a Chicago Bank which is associated with the Chicago Trade Mart owned by the KENNEDY family. He stated further that the daughter of Mrs. HITCHCOCK bears a striking resemblance to the late President JOHN F. KENNEDY.

CHRISTIAN explained he intends to pursue his belief that a conspiracy did exist between SIRHAN and JERRY OWEN, and possibly other individuals. He stated further he feels that his continuing inquiries will positively establish such a conspiracy. In furtherance, he claims to have discussed his theory with JESSE UNRUH, the leader of the Democratic Minority in the

California State Legislature. UNRUH is reported to have urged CHRISTIAN to discuss his theories and investigation with the USA, W. MATTHEW BYRNE, JR. of Los Angeles. As of 8/28/69, CHRISTIAN has not done so, preferring to wait until such time as he has substantiated his theories more solidly.

CHRISTIAN subsequently telephonically contacted SA LA JEUNESSE to advise that the arrest involving the cowpuncher from the A Bar T Stable in December 1968, did not occur at the Los Angeles Sheriff's Office, Lakewood Substation but rather by the Orange County Sheriff's Office.

On 9/15/69, CHRISTIAN again telephonically contacted the writer and advised that he had developed further information concerning his theory and specifically with respect to the Midland Oil Company which he desired to furnish to the writer. In addition, he discussed the name of WALTER THOMAS RATHKE of Pleasanton, California, as a person to be considered and described him as a "pen pal" of SIRHAN. CHRISTIAN claimed that RATHKE was interviewed by agents of the FBI following the assassination of ROBERT F. KENNEDY. *Correct*

On 6/11/68, Inspector JOHN POWERS, Detective Bureau, Los Angeles Police Department (LAPD), advised that as a result of a meeting held that morning with Deputy Chief ROBERT HOUGHTON, a complete reevaluation of the LAPD's investigation concerning this matter was discussed.

It has now been determined that the supervision of all investigation will be changed from the Rampart Division to Room 803 on the eighth floor of the Police Administration Building, 150 North Los Angeles Street. This facility was selected because of its excellent security and because it is out of the way of the general passageway of traffic in the building. It is anticipated that six outside and six inside telephone lines will be installed in the near future. In addition, sufficient furniture, supplies, and automobile equipment will be made available.

This detail will be under the direct command of Captain HUGH BROWN, commander of the Central Homicide Bureau, who has been detached from Homicide to supervise this investigation. He will be assisted by Lieutenants CHARLES HIGBY, ROY KEENE, and MANUEL PENA. They will have under their commanding investigation, a staff of seven teams of detective sergeants. One will include a polygraph examiner. In addition, there will be an administrative assistant, a civilian not yet determined, whose function will be to supervise and arrange an appropriate indexing, filing, reporting, and follow-up system. In addition, there will be female employees to man the telephones, both day and night. There will also be made available stenographic employees.

Inspector POWERS advised that the personnel assigned to the detail comprise a total of 323 years of police experience. The average experience of this group is 15 years 4 months investigative work.

This arrangement will operate on a day watch (approximately 8:00 a.m. to 4:00 p.m. daily) and a night watch (3:00 p.m. to 11:00 p.m. daily) with the exception of weekends, when a reduced force will probably be on duty. Inspector POWERS pointed out, however, that all of the details regarding the foregoing have not yet been worked out to completion and this operation may not go into effect until possibly 6/12 or 13/68 or later.

This entire operation will be under the direct administrative supervision of Deputy Chief ROBERT HOUGHTON and Inspector POWERS will have some administrative function, not yet fully determined.



On 10/10/69, Mr. ~~JOHN CHRISTIAN~~, 840 North Larabee, Apartment 2-318 (telephone 659-3969) Los Angeles, California, was telephonically contacted. Reason for the contact with CHRISTIAN was because he has persistently contacted the writer and has been personally interviewed in the past regarding his allegation and belief that a conspiracy existed between JERRY OWEN and SIRHAN BISHARA SIRHAN in the assassination of the late ROBERT F. KENNEDY. During the telephone conversation with CHRISTIAN, he stated that a Los Angeles Attorney, FRANK BURNS, had previously suggested that he, CHRISTIAN, furnish any information he has concerning his belief to the United States Attorney, W. MATTHEW BYRNE, JR. CHRISTIAN stated that he intended to do so hoping that United States Attorney BYRNE could cause an official investigation to be conducted into the conspiratorial aspects of this case.

It is noted that previous contacts with CHRISTIAN have been made the subject of separate memoranda dealing primarily with his contention of the existence of a conspiracy in the assassination. During those previous contacts, CHRISTIAN has maintain that the Office of the District Attorney, Los Angeles County and the Los Angeles Police Department have failed to be sympathetic to his overtures having taken the position that no conspiracy exists. CHRISTIAN has recently talked with one ~~BILL POWERS~~ who resides at 3633 West Ball Road in Anaheim, California, (telephone 527-9719). POWERS is reportedly affiliated with the A Bar T Stables, 3016 West 5th Street, in Santa Ana, California. POWERS, upon contact by CHRISTIAN, admitted knowing JERRY OWEN and furnished a rather long account of his association with OWEN. Also included in the conversation that CHRISTIAN had with POWERS is the statement on POWER's part that he had been interviewed on four or five occasions by Special Agents of the FBI during the investigation of the assassination of ROBERT F. KENNEDY.

On 5/6/69, PETE NOYES, Managing Editor, KNXT-TV, 6121 Sunset Blvd., Los Angeles, California, advised that with respect to the EUGENE HALE BRADING, about whom he spoke of on 5/5/69, that individual has FBI # 799431 and Texas Identification [REDACTED]

In addition, to the foregoing, NOYES was advised that his continuing investigation into the activities of BRADING, who is now better known as Jim Braden, has developed that Empire Oil Company owns 50 percent of another firm known as Bonanza International. The said company is Empire Crude Oil Company and it is with this organization that BRADEN is currently affiliated.

He stated that the Empire Company apparently has an office at 3925 Oneida St. in Denver, Colorado. NOYES explained his investigation is continuing since he is still of the opinion that BRADEN is the individual whom District Attorney JIM GARRISON of New Orleans, Louisiana, was referring to in his recent prosecution of CLAY SHAW rather than EUGENE BRADLY of North Hollywood whom GARRISON had insisted was the person he was looking for. NOYES again reiterated his contention that JIM BRADEN was in some way involved in the assassination of the late President JOHN F. KENNEDY in Dallas, Texas, in 1963.

On 5/12/69, NOYES again telephonically advised, on an extremely confidential basis, that he has spoken with ROBERT KAISER, an investigator for the defense team who represented SIRHAN BISHARA SIRHAN. KAISER is also writing a book concerning the assassination and has advised NOYES that he has seven reasons which he considers valid to suspect that a conspiracy actually did exist. NOYES proposed to KAISER that KAISER contact SIRHAN and specifically ask him whether he, SIRHAN, had actually attended a meeting of the Black Panthers in Los Angeles prior to the assassination of the late ROBERT F. KENNEDY on 6/5/68.

KAISER subsequently contacted NOYES and advised that he had interviewed SIRHAN which interview was recorded on tape. When KAISER asked SIRHAN whether he had ever attended a Black Panther meeting, SIRHAN became considerably upset; denied he had ever attended such a meeting, but told KAISER that he had, in fact, visited the Black Muslim Temple in Los Angeles.

It will be recalled that on 5/5/69, KAISER furnished information which he alleged came from a source whom he described as a former officer in the Black Panther organization in Los Angeles. That information was to the effect that SIRHAN had been observed by the aforementioned former member of the Black Panther at a meeting of that organization approximately one month prior to 6/5/68. NOYES advised on 5/12/69, again on an extremely confidential basis, his former Black Panther source is SHERMONT BANKS. He stated that BANKS is no longer affiliated with the Black Panther Party because he refused to use a gun on one previous occasion. NOYES alleges that BANKS is currently "hiding out" in the CBS facility, in fear of his life. NOYES explained he could make BANKS available for interview by FBI Agents.

NOYES again chose to discuss the Dallas, Texas, assassination of the late President KENNEDY and stated with respect to JIM BRADEN that he, NOYES, had learned that BRADEN had an appointment with LAMAR HUNT in Dallas on 11/20/63, and was scheduled to leave Dallas on 11/21/63.

NOYES also stated he learned from his New York CBS affiliate that there is a midwest publishing house which prints the literature paid for and put out by H. L. HUNT of Hunt Foods.

NOYES explained that in December 1968, former FBI Agent WILLIAM TURNER approached him in Los Angeles and attempted to sell to CBS the "zabruda film" (phonetic). NOYES at that time was skeptical and checked with the legal staff at CBS, KNXT-TV, 6121 Sunset Blvd., Los Angeles, California. One of the attorney's for CBS is also a lawyer for Life magazine and advised NOYES that the "zabruda film" (phonetic) is a copyright document owned by Life magazine publication and that TURNER very possibly did not have legal possession which would permit CBS, KNXT-TV, 6121 Sunset Blvd., Los Angeles, to exhibit it. NOYES learned later that KTLA-TV ran the "zabruda film" (phonetic), but not adaptable for TV.

At about that time, TURNER advised NOYES that he had sent one JIM ROSE (a TURNER associate) to 280 Beverly Drive, Beverly Hills, California, in an attempt to locate BRADEN. While there, ROSE was allegedly told that BRADEN was not in town and was not expected back for a month. ROSE obtained the names of the occupants of the building from the building directory which includes J. M. ARNOFF, GERALD CHASE and WALLACE HOYT, three of the individuals previously mentioned by NOYES on 5/5/69.

NOYES explained that TURNERs price for the sale of the "zabruda film" (phonetic) to him was to be installed as an investigator for CBS. NOYES explained that CBS had eliminated their investigative staff approximately two years ago and no longer has such an organization. NOYES did not negotiate with TURNER for the film based upon legal advice from the studio's attorney.

He stated that TURNER also advised that BRADEN had been in Dallas, Texas, and had moved to Los Angeles from that city shortly after the assassination of the late President JOHN F. KENNEDY.

NOYES claims to have been in contact with ROBERT FINCH, current Secretary of Health and Welfare, concerning his beliefs re BRADEN. He explained that FINCH is extremely concerned with the various militant groups functioning throughout the United States since HEW is responsible for funding money for the programs under the auspices of the Federal Government.

Arrangements were made to meet personally with NOYES on 5/14/69, or 5/15/69, for the specific purpose of interviewing SHERMONT BANKS with the intention of possibly producing him as an informant.

The "zabruda film" referred to herein is the movie film taken of the presidential motorcade in Dallas in December 1963, by ABRAHAM ZAPRUTER which was reportedly sold to Life magazine.

On 10/29/69, Doctor SEYMOUR POLLACK, a well-known Los Angeles psychiatrist, contacted SA R. J. LA JEUNESSE, JR., for the purpose of discussing the following:

Doctor POLLACK advised that he is currently considering what he characterizes as a new concept in the field of law enforcement and criminal law prosecution. He explained his concept is the possible establishment of what he referred to as a "medical-legal center", which would encompass the law enforcement community, the legal profession, and the medical profession with emphasis in the fields of specialization pertaining to psychiatry, psychology, and sociology.

Doctor POLLACK was appointed by the Los Angeles County District Attorney's Office to examine SIRHAN BISHARA SIRHAN as one of several prosecution psychiatrists. In connection therewith, considerable contacts have been maintained with Doctor POLLACK during the trial of SIRHAN.

Doctor POLLACK is a member of the medical staff at the University of Southern California in Los Angeles; is a professor in the graduate school of public administration, where he teaches courses in both law and psychiatric medicine; is a member of California Governor RONALD REAGAN's task force, representing California under the provisions of the Omnibus Crime Bill of 1968; is a member of the Los Angeles County General Hospital staff, and is frequently consulted by Los Angeles Superior Courts and United States District Court in connection with psychiatry examination ordered by those jurisdictions.

On 11/3/69, Mr. ROBERT KAISER, a former member of the SIRHAN defense team, telephonically contacted the writer and advised as follows:

The book he has written with respect to the assassination of the late Senator ROBERT F. KENNEDY, has not yet been published. The manuscript is being examined by attorneys for the publisher and being edited to some extent, all of which has caused delay in its publication.

KAISER explained that during his many interviews and contacts with SIRHAN, he has come to the conclusion that there very probably exists a conspiracy of sorts with respect to SIRHAN's involvement. For example on 12/31/68, KAISER, in a personal interview with SIRHAN, questioned SIRHAN regarding the possibility that someone may have had control or influence over SIRHAN's mind. On that occasion SIRHAN reacted visibly and was obviously offended because of KAISER's suggestion that someone could control his thinking process. Upon further discussion of that aspect, KAISER questioned SIRHAN as to who might possibly be in a position to furnish information regarding such a control factor. KAISER specifically questioned SIRHAN as to the reported incident (by OWEN) of an alleged relationship between SIRHAN and JERRY OWEN. SIRHAN commented to KAISER that there was nothing to such an allegation. SIRHAN did suggest to KAISER; however that perhaps OWEN could furnish information regarding the possible identification of the individual (s) who may have had such an influence over him.

KAISER also suggested the possibility that WILLIAM "BILL" POWERS, the Orange County stable owner, may possibly be in possession of additional information indicating a possible conspiracy in this assassination. POWERS is the individual who was previously interviewed by representatives of the Los Angeles Police Department when it came to that agency's attention that POWERS reportedly had been contacted

by a man named WEATHERLY. POWERS was interviewed by the police and subsequent contact by one JOHN CHRISTIAN, about whom information has been previously reported. POWERS in his conversation with CHRISTIAN furnished considerably more information than he furnished to police officers in January 1969. In his conversation with CHRISTIAN, POWERS referred to JERRY OWEN having been present at POWERS' stable, accompanied by a large, well-dressed Negro male, in a late model automobile. Present on that occasion, according to POWERS in his conversation with CHRISTIAN, was an individual, who was probably SIRHAN.

KAISER expressed the opinion he would not be in any violation of any court order or defense effort of SIRHAN to speak to the writer regarding some of the conversations he had with SIRHAN, which have not been made available heretofore, to law enforcement officials. Tentative arrangements were made with KAISER to meet with him on 11/7/69, for the purpose of affording him an opportunity to furnish to the writer results of some of the conversations he allegedly has with SIRHAN before, during and after his trial.

On 11/24/69, Mrs. FLORENCE G. FEVERGEON, operator of Professional Training School of Practical Nursing, 15 North Euclid, Suite 200, Pasadena, California, telephone 449-6223, furnished the following information:

A woman identifying herself as ROSE LYNN MC QUEARY, nee MASSEY, recently contacted Mrs. FEVERGEON about training as a practical nurse. Mrs. MC QUEARY furnished the following information about herself:

She called herself an Arab, an Arab Jew, a Jew; as ~~xxx~~ obtaining a divorce and as being married to a Scotsman and therefore "people don't know we're Jews".

She identified herself as the "unidentified woman" who escorted MARY BISHARA SIRHAN to the United Nations in her abortive effort to address the United Nations.

She is an adamant and very militant supporter of the Arab cause and very anti-Israel. She describes herself as having suffered miserably when the Jews took over parts of the Arab nations and forced the native residents to move to desolate desert areas.

She is very militant in her support of SIRHAN BISHARA SIRHAN, and is very vocal and open in her support of him. She actively solicits funds to further the defense of SIRHAN BISHARA SIRHAN.

The patient reported to Mrs. FEVERGEON that MC QUEARY immediately attempted to persuade him to sign various petitions in support of SIRHAN BISHARA SIRHAN and opposing the U.S. aid to Israel. She also solicited funds from the patient for SIRHAN's defense. The patient rejected these overtures and dismissed MC QUEARY.

MC QUEARY is supposed to take the practical nursing course from Mrs. FEVERGEON, but Mrs. FEVERGEON hopes to be able to deny her admittance.

On 1/12/70, an individual who introduced himself as ROBERT WILDE telephonically contacted the writer and advised as follow:

A letter was delivered to him personally on 1/12/70, by an individual he identified as RICHARD LUBIC. He stated that in delivering the letter to him and upon while reading the letter, he noted that a copy of the letter was directed to Agent "LONGINESS", of the FBI, Los Angeles.

Mr. WILDE subsequently ^{appeared} explained in person at the Los Angeles Office on 1/13/70, at which time he exhibited a letter dated 1/12/70, which he claims was delivered to him by RICHARD LUBIC. According to WILDE, LUBIC resides at 4151 Vanalden, Tarzana, California, (telephone 881-3988), and has a answering service, telephone number of 278-4466. WILDE explained that he has previously had some business dealings with LUBIC and LUBIC has refused to pay WILDE money which WILDE claims is owing to him. WILDE was advised that any previous business dealings he is alleged to have had with WILDE are of no official interest to the Bureau and/or the writer, and none of those are any personal interest to SA R. J. LA JEUNESSE, JR.

WILDE explained he resides at 1850 Harvard Avenue, Apartment 22, Los Angeles, California, and can be reached through a neighbor, telephone 466-6879. He claims to be presently employed as a construction worker and is attending classes at Columbia College in Los Angeles.

On 1/13/70, Mr. LUBIC was telephonically contacted at his residence concerning the foregoing. He explained that WILDE is an "ex-convict", and that he has had previous business dealings with WILDE. He acknowledged that he owes money to WILDE which he claims he intends to pay on 1/14/70. LUBIC was questioned concerning the above described letter and stated that a copy of the letter had, in fact, been directed to the writer. He explained he had done so because he is a friend of JOHN CHRISTIAN with whom SA R. J. LA JEUNESSE, JR. has previously had contact. In addition, LUBIC advised since his dealings with WILDE, he has received numerous telephone threats at his residence. He explained that his additional purpose in directing a copy of the above described letter to SA R. J. LA JEUNESSE, JR., was to insure that someone responsible would be aware of these so called threats in the event something did happen to him.

It was suggested to LUBIC that he take up the matter of any alleged threats with his local police department, which he claimed to have already done. LUBIC was again advised that any business transaction between he and WILDE are of no official concern to the FBI.
