

1 time that you asked about a gun?

2 MUNIR SIRHAN: No, but I talked to you about that.

3 Q Yeah, you're talking about when the gun was  
4 actually sold?

5 MUNIR SIRHAN: Right.

6 Q Changed hands?

7 MUNIR SIRHAN: Yes, sir.

8 Q Now, you said that you did not discuss the sale  
9 of that gun with George. That's a lie, isn't it? I'm  
10 talking about money. George was asking for \$30; you were  
11 saying 25, 20?

12 MUNIR SIRHAN: No, sir, that was my brother that  
13 was discussing this.

14 Q Well, we want to get this thing straight now.

15 MUNIR SIRHAN: Yes, sir.

16 Q George, do you remember this man here discussing  
17 the price of that gun with you?

18 GEORGE ERHARD: I believe I recall both persons  
19 being, and discussing the price; and I believe Joe did the  
20 talking, but it could have been that his brother was doing  
21 the gesturing.

22 Q But most of the time according to William Price,  
23 Sirhan Sirhan was talking to Bill?

24 GEORGE ERHARD: Yes.

25 Q So who were you talking with during this time?

26 GEORGE ERHARD: Well, I was speaking to Joe, and

1 then as I recall his brother did come over because I remember  
2 seeing them together. Now, I can't say that it was Sirhan  
3 but another party was with Joe.

4 Q But most of the conversation was between you and  
5 who?

6 GEORGE ERHARD: Between me and Joe.

7 Q Okay now what was that conversation about?

8 GEORGE ERHARD: Well, we had discussed the price  
9 of the gun, and then the two of them had gone off a few feet  
10 away and discussed something in another language, and then  
11 they came back and one of them decided, well, \$25 was all  
12 right and somebody loaned somebody about \$6, and from there  
13 somebody gave me the money and I gave somebody the gun. And  
14 just exactly who that person was, I can't recall.

15 Q My question was, did you discuss money with Joe  
16 Sirhan?

17 GEORGE ERHARD: At that particular point I  
18 believe I did mention money with Joe.

19 Q Do you remember that now, Joe?

20 MUNIR SIRHAN: We were--as I said, we were four  
21 together when we first got--when all of us were there, all four  
22 of us worked together, and he was talking toward us. Yeah.

23 Q And were you talking toward him?

24 MUNIR SIRHAN: Right about that time Bill--he was  
25 sitting in the car and he came out and I shook hands with  
26 him, and I said, "What's happening?"

1 Q Now, you're running away again. You're running  
2 away, Joe. Did you talk to him?

3 MUNIR SIRHAN: Well, yeah, I said, "Hello, George,  
4 how's things," and this and that. And he said, "Well, I've  
5 got the gun." And I said--I pointed toward Sirhan and Sirhan  
6 and George started carrying on the conversation or  
7 something.

8 Q I'll ask you the question again. Did you talk  
9 to George about money, about that gun?

10 MUNIR SIRHAN: I'm just--just got through saying  
11 it, sir.

12 Q No, you're running away from me, but I won't let  
13 you run. Now, did you ever talk with him about money  
14 concerning that gun?

15 MUNIR SIRHAN: Did I ever talk? Well, when we  
16 were in the parking lot, he said--

17 Q No, no, no.

18 MUNIR SIRHAN: I said, "How much are you asking  
19 for it?" He said, "\$30."

20 Q Uh huh.

21 A And I said, "Well, come up to the house and I'll  
22 see what my brother says.

23 Q Okay, so then he came up to the house?

24 MUNIR SIRHAN: No.

25 Q Not to your house, to the corner?

26 MUNIR SIRHAN: To the corner.

1 Q And you were there?

2 MUNIR SIRHAN: We were at the front of the house,  
3 yeah.

4 Q And again I'll ask you, did you discuss with  
5 George about money and the sale of that gun?

6 MUNIR SIRHAN: At that time when we were on the  
7 corner?

8 Q Yes.

9 MUNIR SIRHAN: No, huh uh.

10 Q Well, then again we have another lie. What's  
11 wrong? You've already admitted one lie.

12 MUNIR SIRHAN: Yes, sir, that's right; but I  
13 didn't discuss any of the money when we were out--I discussed  
14 the money in the parking lot.

15 Q Uh huh.

16 MUNIR SIRHAN: Prior to the meeting with Sirhan,  
17 But at the corner I did not discuss--unless giving Sirhan the  
18 \$6 that he had asked for when George didn't go down on the  
19 price.

20 Q I know that George has said that you discussed  
21 money with him; that you were trying to jaw him down.

22 MUNIR SIRHAN: Other than the parking lot, no,  
23 huh uh.

24 Q It's a very unimportant fact except that you  
25 are lying about it.

26 MUNIR SIRHAN: I'm not lying about it.

1 Q Well, we'll find out.

2 MUNIR SIRHAN: Yes, sir.

3 Q What did you tell Sirhan when you arrived home  
4 that night and you knew that George was going to come up with  
5 the gun?

6 MUNIR SIRHAN: I said, "There's a fellow out  
7 there that has a gun, a fellow that I work with that I was  
8 telling you about that collects antique guns."

9 Q What did he say?

10 MUNIR SIRHAN: He said, "Where is he?" I said,  
11 "He's supposed to be on the corner." And we both walked to  
12 the corner and immediately we watched and George had come  
13 around.

14 Q Now yesterday you told me that you didn't want  
15 your brother to buy a gun.

16 MUNIR SIRHAN: Right.

17 Q Because you knew that he was an alien.

18 MUNIR SIRHAN: Yes, sir.

19 Q And you knew that if he was in possession of a  
20 gun, it would be a crime?

21 MUNIR SIRHAN: Yes, sir.

22 Q That's what you were telling me yesterday that  
23 you had told George that if your brother wanted to buy a gun,  
24 to tell him that he couldn't sell it to him because he was an  
25 alien.

26 MUNIR SIRHAN: Right, sir.

1 Q Is that a lie?

2 MUNIR SIRHAN: No, that's the truth.

3 Q You told this to George?

4 MUNIR SIRHAN: Yeah.

5 Q When?

6 MUNIR SIRHAN: I told--I said to George, I said,  
7 "If he wants to really buy it, try to get the price either  
8 too high or don't go down on the price. He shouldn't have  
9 the gun; he is an alien," and I did tell you he's an alien  
10 and I'm not an alien--I mean, I am an alien?

11 GEORGE ERHARD: I don't recall speaking anything  
12 about alienization.

13 MUNIR SIRHAN: I told you that I wasn't a  
14 citizen.

15 GEORGE ERHARD: I don't believe that. I don't  
16 recall it, no.

17 MUNIR SIRHAN: Well, I did tell him that, sir.

18 Q Well, it's a matter of not recalling or recalling.  
19 Did he ever tell you that not to sell his brother a gun  
20 because he was an alien?

21 GEORGE ERHARD: No, there was no mention of any  
22 brother.

23 Q Was there any mention about "don't sell him the  
24 gun?"

25 GEORGE ERHARD: No.

26 MUNIR SIRHAN: When we were in the parking lot

1 when I asked you to come up, I said, "My brother is going to  
2 be there and he's going to try to buy it and try to keep it  
3 away--"

4 GEORGE ERHARD: I don't recall that, no.

5 Q Munir, you can make it awful simple for you--

6 MUNIR SIRHAN: --yes, sir.

7 Q --for me, for everybody--

8 MUNIR SIRHAN: --yes, sir.

9 Q --else if you tell the truth. Now I think I can  
10 see what you're fearing here, but I can tell you, you  
11 shouldn't fear anything unless you're going to sit there and  
12 lie to me. Now, do you want to straighten this out between  
13 you and me by ourselves?

14 MUNIR SIRHAN: It's straight, sir.

15 Q It isn't straight. Do you want to straighten this  
16 out between you and me?

17 MUNIR SIRHAN: How's that?

18 Q Just you and me in this room with the lady?

19 MUNIR SIRHAN: No, it's the same with him here.

20 It's--

21 Q You mean you're going to keep on lying to me?

22 MUNIR SIRHAN: I'm not lying, sir.

23 Q Okay, now, he just told me--

24 MUNIR SIRHAN: That's why I try. I know, but he  
25 doesn't seem to recall a lot of stuff.

26 Q And you seem to--

1           MUNIR SIRHAN: George, remember--you know where  
2 the men's--the boys' stockroom you were in today, when we go  
3 back there with Jose, when he was there one time? I'm just  
4 trying to remember the place, the spot--

5           GEORGE ERHARD: I don't recall.

6           MUNIR SIRHAN: --and I told you I was not an  
7 alien--I mean that I was an alien?

8           GEORGE ERHARD: I don't recall you mentioning  
9 anything about alienization because if you were, I would not  
10 have sold you the gun.

11           MUNIR SIRHAN: But I told you that I was not a  
12 citizen.

13           GEORGE ERHARD: I don't recall that.

14           MUNIR SIRHAN: Okay that--that is a lie. I did  
15 tell him I was not a citizen and not to sell my brother the  
16 gun and try to get the price a little higher so that my  
17 brother would argue with him or something, and so it wouldn't  
18 go through.

19           Q       That is a lie?

20           MUNIR SIRHAN: Yes, sir.

21           Q       Who's telling the lie, you or him?

22           MUNIR SIRHAN: He is. Remember when I told you  
23 I was not a citizen?

24           GEORGE ERHARD: No, I don't. Because if you had  
25 told me that, I would have remembered and not sold you the  
26 gun.

MUNIR SIRHAN: (Unintelligible)

THE REPORTER: I didn't hear what you said, sir.

MUNIR SIRHAN: We'll see the outcome on the lie detector test.

Q Okay. Now, the last time at Rampart one of the investigators asked you, "Where did your brother keep the gun?" and you answered by saying, "It wasn't in the house."

MUNIR SIRHAN: He had it in the car the two times I had seen him it was in the car.

Q Why didn't you tell them that?

MUNIR SIRHAN: Sir?

Q Why didn't you tell them that?

MUNIR SIRHAN: Well, after George had left, Sirhan put it in the car.

Q Why didn't you tell the investigators this?

MUNIR SIRHAN: I did.

Q No, you didn't because I have the report right here in front--

MUNIR SIRHAN: Then I must have--you see, I told it to other ones then.

Q Okay, then, why was it when they asked you this question, they said--they asked you, "Where did your brother keep the gun?" And you said it wasn't in the house.

MUNIR SIRHAN: No, sir, I said that when we were walking, he put it in the car. He didn't take it inside the house. That's the way I meant it.

1 Q Okay, you meant to say t' it was in the car?

2 MUNIR SIRHAN: Yeah.

3 Q Okay, then they asked you, "When was the last time  
4 that you saw it?" And you answered, "The first time that I  
5 saw it was the last time that I saw it when he put it in the  
6 car--"

7 MUNIR SIRHAN: --right.

8 Q "--after that I didn't see it."

9 MUNIR SIRHAN: Right. Well, it was in the car  
10 again when I told you yesterday when I was walking home--  
11 came home that one night. In fact, I had forgotten all about  
12 that until I talked with you again.

13 Q Now, you're saying you only saw it twice now?

14 MUNIR SIRHAN: Yeah.

15 Q The first time you said only once but now it's  
16 twice?

17 MUNIR SIRHAN: Yes.

18 Q Okay. When was the last time that you saw  
19 Sirhan?

20 MUNIR SIRHAN: I was going to work. It was about  
21 8:30 in the morning, Monday--no, Tuesday, I'm sorry.

22 Q Uh huh.

23 MUNIR SIRHAN: I saw him buying a paper on the--  
24 behind the Market Basket on Lake and Washington.

25 Q Uh huh. That was Tuesday morning?

26 MUNIR SIRHAN: I was on the bus.

1 Q Okay, here's the question that the investigators  
2 asked you. "Last night--" and this was when they were talking  
3 to you--

4 MUNIR SIRHAN: No, I'm sorry, it was--let's see,  
5 the fifth was on a Wednesday?

6 Q Yes.

7 MUNIR SIRHAN: It was payday I saw him, yeah,  
8 Tuesday at 8:30. Yeah, between 8:30 and 9 o'clock because I  
9 take--

10 Q In the morning?

11 MUNIR SIRHAN: --catch the bus, yes, sir.

12 Q In the morning?

13 A MUNIR SIRHAN: Yeah.

14 Q Do you remember seeing a gardener sometime that  
15 day?

16 MUNIR SIRHAN: Yes, sir.

17 Q What time did you see the gardener?

18 MUNIR SIRHAN: When I came home.

19 Q When you came home from work?

20 MUNIR SIRHAN: Yes, sir. I got off the bus about  
21 6:30. I get to that area about 6:30.

22 Q Tuesday evening?

23 MUNIR SIRHAN: Yeah.

24 Q Tuesday evening?

25 MUNIR SIRHAN: Right.

26 Q Okay. And you told the investigators at that time

1 on the 5th of June that you and your mother were discussing  
2 the budget?

3 MUNIR SIRHAN: Right.

4 Q You remember that?

5 MUNIR SIRHAN: Right.

6 Q And that you had talked to this gardener about  
7 doing your lawn--

8 MUNIR SIRHAN: --right.

9 Q --And giving you a price?

10 MUNIR SIRHAN: He had come to the house and we  
11 were talking in front of the house for about an hour or so.

12 Q Do you remember watching a TV program?

13 MUNIR SIRHAN: No, there was a TV program--  
14 Jerry Lewis is on on Tuesday nights, but he wasn't on that  
15 night, so it was about that time that the gardener was around.

16 Q Okay, do you remember what TV program was on?

17 MUNIR SIRHAN: No, my mother and I were just  
18 talking to my brother, Adel. My brother had just come home.

19 Q Do you remember anything about--

20 MUNIR SIRHAN: --I don't recall. I believe it  
21 was--I believe it was Truth or Consequences.

22 Q Very good. See, you are remembering well now,  
23 and also you said this, that your brother came in after your  
24 mother and you were discussing the budget. The budget. Your  
25 brother came out and it was about 7:30 when Truth or Conse-  
26 quences was on.

1           MUNIR SIRHAN: My brother came--yeah, Adel came  
2 home, right.

3           Q       This is Adel you are referring to?

4           MUNIR SIRHAN: Yeah, right.

5           Q       Not Sirhan?

6           MUNIR SIRHAN: No.

7           Q       Why did you lie to me when you said that he had  
8 been to your house?

9           MUNIR SIRHAN: Sir, as I say, truthfully, I  
10 didn't know--Les and he, they look alike, sir, and we both--  
11 we discuss so many things together. We go out to lunch  
12 together, it just--it may have happened; that's all.

13          Q       It may have happened.

14          MUNIR SIRHAN: Well, they look alike. That's all  
15 there is to it, sir.

16          Q       Look, you are an intelligent person, but you have  
17 a tendency to fabricate things.

18          MUNIR SIRHAN: Yeah.

19          Q       So don't fabricate anything. I'll ask you again,  
20 did you lie to me?

21          MUNIR SIRHAN: I'm so mixed up, sir.

22          Q       That's why you're mixed up because you have a  
23 tendency to fabricate things now. Now, tell me, Munir, why  
24 did you lie to me before when you said this man had been to  
25 your house?

26          MUNIR SIRHAN: I guess I just made it up.

1 Q Why?

2 MUMIR SIRHAN: For no reason, sir.

3 Q Yes, you did have a reason. I want to find out  
4 the reason.

5 MUMIR SIRHAN: Sir, I have enough guilt as it is.  
6 It's--it's getting George and Sirhan together to buy the gun.  
7 I didn't--I just--I just feel guilty that I was in the middle  
8 of all this.

9 Q Were you going to feel less guilty by lying about  
10 it?

11 MUMIR SIRHAN: No, no. I don't know I was tense.  
12 I'm still tense. I'm just mixed--

13 Q Well, get unmixd and tell me the truth now all the  
14 way down in your own words while I'm sitting here and while  
15 George is in this room, but tell me the truth, Mimir; okay?  
16 And you go ahead and tell me how the discussion between you  
17 and Sirhan started and how George got involved in this.

18 MUMIR SIRHAN: It was first Sirhan was with the  
19 ROTC--well, first, it was George as I say at work, you know,  
20 that situation. I don't want to go through that.

21 Q About being the antique collector and so forth?

22 MUMIR SIRHAN: No, that and what's involved with  
23 my brothers.

24 Q Okay. Okay.

25 MUMIR SIRHAN: First I had approached him with  
26 that. I had that idea in mind was to find out if--so then

1 between that time and between when the actual sale was made,  
2 I had asked him for a gun for my brother. He was telling me  
3 when we ate lunch--we used to go out and eat lunch, and he  
4 said he collected guns. He collects this part and this part.  
5 He had just collected this part of a gun, and he had a model  
6 T, and he does this, you know, this type of thing.

7 Q This is very important before you continue. You  
8 have told George, and I'm going to see--I'm going to see if  
9 you're going to come up and come up and stand up as a standup  
10 guy here now. Before you said that you had told George not to  
11 sell your brother a gun because he was an alien?

12 MUNIR SIRHAN: Yes, sir. Yes, sir, I did tell  
13 him that. Yes, sir.

14 Q And yet you pursued him and asked him a number of  
15 times--

16 MUNIR SIRHAN: Yes.

17 Q --to sell a gun to your brother?

18 MUNIR SIRHAN: Right, sir, but I didn't--in fact,  
19 it was Sirhan--I knew Sirhan--in fact, I was positive that  
20 Sirhan wouldn't go through with the thing. To show you how  
21 Sirhan was so law-abiding, sir, the whole fight between he  
22 and I started because the car that he wanted to drive didn't  
23 have any insurance on it, and I just didn't think he would  
24 carry it through.

25 Q Well, it's not against the law to drive a car  
26 without any insurance.

1                   MUNIR SIRHAN: I know that but I was just trying  
2 to show you Sirhan was law-abiding and I just didn't think--  
3 I didn't think he would go through with it.

4           Q       Through with what?

5                   MUNIR SIRHAN: With buying the gun.

6           Q       Well, could you not, realizing that an alien can-  
7 not be in possession of a gun, could you not have told him  
8 that you had asked George but that he did not have a gun?

9                   MUNIR SIRHAN: But, I'm not--Sirhan would have  
10 found out this and found out that somehow or other. He came  
11 down to work--he comes down to work once in awhile.

12           Q       But he didn't know George.

13                   MUNIR SIRHAN: Well, he had known him through me  
14 discussing him with me and so on.

15           Q       You mean you had mentioned George to Sirhan?

16                   MUNIR SIRHAN: Yeah, right.

17           Q       But Sirhan didn't know George?

18                   MUNIR SIRHAN: No, huh uh.

19           Q       Okay, then why didn't you just go ahead--

20                   MUNIR SIRHAN: As I say, I'm so mixed up. I'm  
21 so--it's my brother that's up there.

22           Q       I know it is your brother. And I hope that it's  
23 only your brother.

24                   MUNIR SIRHAN: I see.

25           Q       And I want you to tell me the truth. We're  
26 trying to arrive at a conclusion that is a truthful conclusion

1 here.

2 MUMIR SIRHAN: Yeah.

3 Q If you didn't tell him--I know that you feel guilty  
4 but say I didn't tell him. Don't mix it up any more by saying  
5 things that didn't happen.

6 MUMIR SIRHAN: All right.

7 Q Did you ever mention to George that your brother  
8 was an alien so don't sell him a gun?

9 MUMIR SIRHAN: Yes, sir. It was--

10 Q Then why--

11 MUMIR SIRHAN: --in the parking lot.

12 Q Then why did you still pursue George to get a  
13 gun for him then?

14 MUMIR SIRHAN: Well, I had only asked him one time  
15 for me for that purpose and then another time for my purpose,  
16 and then the third time was when he had the gun. He had come  
17 up to me and said, "Hey, I've got a gun." After that he had  
18 told me he didn't have a gun; that he had just gotten a gun  
19 from a lady. I told him, "Well, good, bring it down Monday,"  
20 and he said, "Well, I have to pick up my check anyway."

21 Q Well, Munir, you say you're going to stand up,  
22 and then you run away like a rabbit again. That's what you  
23 are doing because you know that George has sat here and he  
24 hasn't lied. I know that you have lied at least two or three  
25 times; right?

26 MUMIR SIRHAN: I'm not--sir, it's--I'm just

1 mixed up.

2 Q You have been mixed up at least two or three times,  
3 right? And now are you mixed up about this thing about an  
4 alien? Telling him that he was an alien?

5 MUNIR SIRHAN: No, sir, I am not. I told him that  
6 I was an alien; my brother was an alien.

7 Q So don't sell him a gun?

8 MUNIR SIRHAN: Right.

9 Q You told him that?

10 MUNIR SIRHAN: Right.

11 Q Well, I think the thing to do then is to go up  
12 and have a polygraph test right now then.

13 MUNIR SIRHAN: Okay.

14 Q I'd hoped that we would have straightened this  
15 thing out here and--

16 MUNIR SIRHAN: Right, sir.

17 Q But we can't the way you're pursuing--

18 MUNIR SIRHAN: --Sir, I--I did tell him that, sir.

19 Q Where else are you mixed up?

20 MUNIR SIRHAN: Sir?

21 Q Where else are you mixed up?

22 MUNIR SIRHAN: Except for the fact I wasn't sure  
23 it was George or Les that came up to the house there and  
24 then.

25 Q Wait a minute. Let's pursue that a little bit.  
26 You know it wasn't George.

1                   MUNIR SIRHAN: Okay.

2                   Q       But before, yesterday, you were telling very  
3 definitely that George had been to your house, but you knew  
4 you were again mixed up and lying about that. Why?

5                   MUNIR SIRHAN: Well, I was just--well, I guess I  
6 said it, sir. As I say, I'm mixed up. I don't remember  
7 dates. I have a very poor memory, and yesterday things were--  
8 I was tensed and I'm still tense. Now I have been tensed  
9 since I got out of jail, sir; since the narcotics thing  
10 happened to me, life isn't the same, so--

11                  Q       Do you think it's going to get better if you lie?

12                  MUNIR SIRHAN: No, but it was--just came out, sir.

13                  Q       Why?

14                  MUNIR SIRHAN: I don't know, sir. If I know I'm  
15 going to get in trouble if George--I did not buy the gun,  
16 that's the main thing. I didn't buy it. I can get into a  
17 lot of trouble. That's why I said I would like a polygraph  
18 test. I did not buy that gun. You were telling me that  
19 George said I did buy it, and I was trying to put in a little  
20 more into it than there was to make George not say that, to  
21 tell the truth that Sirhan had bought it, but I had--I had  
22 talked to George earlier, and he had told me that he had talked  
23 to one of the officers and said that I wasn't--yeah, he wasn't  
24 supposed to come near me or something, and not to discuss the  
25 case.

26                  Q       Look, I'm going to ask you a question here; and

1 if we have to go to a polygraph, then you go ahead. You say  
2 you're in trouble. I don't know whether you are in trouble  
3 or not except that if you're going to sit here and lie to me  
4 when you know you're lying to me, then it's going to come  
5 out. If you bought the gun, stand up for it. We're not  
6 concerned--

7 MUNIR SIRHAN: Sir, I did not buy the--

8 Q Listen to me.

9 MUNIR SIRHAN: Okay.

10 Q We're not concerned regarding this thing about  
11 possession of a gun by an alien. We're not concerned with  
12 that. You understand that? But I cannot submit a final  
13 report having statements that he has made to me about that  
14 gun, and the statements that you are making to me now. Did  
15 you put up most of the money for that gun?

16 MUNIR SIRHAN: No, I put up \$6 or somewhere around  
17 \$5, sir.

18 Q Okay, then, the next thing we have to pursue here  
19 is go ahead and administer a lie detector test to you.

20 MUNIR SIRHAN: Yes, sir.

21 SGT. HERNANDEZ: We are going to conclude this  
22 interview here now. It's 4:15.

To 777 East Valley Blvd., in Alhambra, and interviewed Mr & Mrs. Albert L. HERTZ. Subjects stated the gun in question had been purchased in August 1965 by Mr. HERTZ and several months later, Mrs. HERTZ gave this gun to her daughter, Dana. This person found to be Dana Westlake who lives at 349 Redwood Drive, in Woodacre, Calif., Ph# (415) 454-3202, with her husband, Robert F. Westlake.

Phone Marin County Sheriff's Office and talk to Sgt. McKamoy, who stated he would go to this location and interview Mrs. Westlake and returned disposition. Information from Sgt. McKamoy was that Mrs. Westlake stated while she was still living in Pasadena prior to moving to Woodacre, either in the latter part of November or the first part of December, in 1967, she gave the gun in question to a neighbor boy. She stated this boy's name was ERHARD, George of 1978 Olive Way in Pasadena, Ph#798-3957.

To 1978 Olive Way and picked up George ERHARD. Subject stated Mrs. WESTLAKE gave him the gun around the first of the year, in 1968, and that he had had it only a very short time before he sold it to a person that works with him at the Nash Department Store, which is located in Pasadena of the northeast corner of Aroyo and Colorado St. This person was known only to him as Joe and described as a Male Latin appearance that he thought he sounded like an Arab. ERHARD was taken to PAB where his statements were recorded in the presence of Officer EVANS & HARRISON.

Subject ERHARD stated he could recognize and point out Joe, so he was taken to the Nash Department Store in Pasadena where Joe, who was later identified as <sup>Munir SIRHAN</sup> was taken into custody. At this time officers received information that Adel SIRHAN volunteered to let his home be examined. He accompanied Sgt. Brandt (Con't)
