SUBJECT: KENSALT

Assistant Attorney General Stephen J. Pollak, Civil Rights Division, called with reference to my call of yesterday concerning the desire to interview the subject in the above-entitled matter. It is recalled we explained to the Department a desire to interview the subject and the possible problems which might arise in the event he has not obtained an attorney; possibility of criticism that might arise in the event we did interview him under various conditions.

Pollak stated the matter was under consideration, that he had learned William Buckley, the Public Defender in Los Angeles, was representing the defendant. He said if this is true we would have to approach the attorney and obtain his permission to interview the subject. If the subject has refused to accept the lawyer then another problem is presented. In such an instance the Evidence Code of California indicates under Section 1204 that the subject may be interviewed without an attorney providing he consents to such an interview after arraignment.

It was pointed out to Pollak that we were interested in knowing whether or not we should interview the subject, assuming that we get the consent and also assuming that the attorney would insist on being present. We wanted to know the views of the Department.

Pollak indicated he would have to await an answer but he wanted to merely give us his personal view concerning this matter. He said the decision is pending with the Attorney General, that Griswold was in California and he was sure the Attorney General would confer with Griswold on the matter and would subsequently insure that information was directed to the Bureau concerning the question whether or not we should interview the subject.

Mr. Herb Edelhertz, Duty Officer in the office of the Attorney General (code 187, extension 2012 or 2013) telephonically advised at 3:00 p. m. today that information had been received from the Veterans Administration (VA) that the VA had a file on Sirhan Selim Sirhan. Mr. Edelhertz stated that he was calling the Bureau in view of radio releases to the effect that Sirhan Sirhan was the individual who had been charged with the attempted assassination of Senator Kennedy. He stated that the radio releases had a different middle name.

According to the VA file, ~~Sirhan Selim Sirhan~~ was born in Jerusalem on 7-15-34. He was in the United States Army from September, 1954, to July 26, 1957. He has Army Serial Number 16470219.

At the time this man applied for educational benefits on 12-26-57 he listed his address as 1211 Hubbard Street, Detroit, Michigan, and his VA claim number is C 20509287. His military records are allegedly in "dead storage" in St. Louis, Missouri. While in the Army, Sirhan Selim Sirhan served in Korea. He is described as 67 inches tall, 145 pounds, brown hair, brown eyes and was rated as normal on discharge from the military service. On 5-27-57 he was married in Jordan to Nelly Abou-Khoudor.

Mr. Edelhertz stated that Mr. Bill Driver, Commissioner of the VA (code 148, extension 3775), has possession of Sirhan Selim Sirhan's file. Mr. Edelhertz requested that he be telephonically advised of any information developed concerning the subject in this case.

Supervisor Elmer Todd, Washington Field Office, was instructed to have an Agent immediately contact Commissioner Driver and secure the complete information in the file of Sirhan Selim Sirhan.

L. B. Nichols called from New York at 4:45 p.m. He stated that a friend of his who desired that his identity remain secret, called and had indicated that approximately one and a half hours prior to the time that Senator Robert Kennedy was shot, he had had a serious altercation with one Chavez who heads up the agricultural workers union. Approximately fifteen minutes before Kennedy was shot, Chavez was seen talking with a person believed to be the subject, Sirhan B. Sirhan.

I asked Nichols if he could reveal the identity of his source. He stated he could not; however, that his source had learned this information third handed from the Los Angeles Police Department Intelligence Bureau.

WILLIAMS, WF of White Plains, Charles County, Maryland upon hearing early broadcast 6/5/68 of caption made report to sheriff's office, Charles County, Maryland of a remark made to her, and her 19 year old daughter 5/16/68 by one STUART JOHNSON, an attorney in Washington, D. C. that "If BOBBY KENNEDY wins the nomination he will be killed before November." *P. APPROX 1923*

Mrs. WILLIAMS and daughter, FRANCES D. WILLIAMS - 19, interviewed 6/5/68 by way of background related as follows:

Both Mrs. WILLIAMS and daughter have been extremely interested in current political campaign, both are strong supporters of Senator EUGENE MC CARTHY.

In May, 1968 Mrs. WILLIAMS went to Charleston, West Virginia to help campaign for MC CARTHY in the 5/14/68 Primary. About 2 A.M. of 5/10/68 she was at the MC CARTHY Campaign Headquarters and took a phone call from a STUART JOHNSON, whom she did not know. JOHNSON sounded as though he was intoxicated and commented that he had been fired by the National Headquarters for MC CARTHY in Washington, D.C. Mrs. WILLIAMS then ascertained from a worker at the MC CARTHY Campaign Headquarters that STUART JOHNSON had been sent out by the National

MC CARTHY Campaign Committee in Washington, D. C. to prepare ground work for the MC CARTHY Campaign in West Virginia.

Mrs. WILLIAMS returned to her home on or about May 16, 1968. She had a feeling there was some unexplained friction in the MC CARTHY Campaign, so she called Attorney JOHNSON for an appointment in order to discuss this matter. An appointment was made for 3:00 P.M. 5/16/68 in Attorney STUART JOHNSON's office, 910 17th Street N.W., Washington, D. C.

Mrs. WILLIAMS and daughter met with Attorney JOHNSON in his private office. They discussed for about one half hour the political campaign in general. JOHNSON acknowledged he had been discharged from the MC CARTHY National Campaign Committee in Washington due to a personality conflict, but that he was still for MC CARTHY, and was now working with another pro-MC CARTHY group (not further identified) in Washington, D.C., and that he was going to California 5/21/68 to campaign for MC CARTHY.

Mrs. WILLIAMS and daughter stated that during the meeting with Attorney JOHNSON, the latter did not discuss Senator ROBERT KENNEDY personally nor did he make any derogatory remarks about the Senator. However, Attorney JOHNSON did say there was a lot of hatred for KENNEDY throughout the nation, and stated "If BOBBY KENNEDY wins the nomination he will be killed before November."

Mrs. WILLIAMS and daughter stated that Attorney JOHNSON did not elaborate on the statement, but made it sound as though it was a matter of fact and a foregone conclusion that KENNEDY would be killed.

Mrs. WILLIAMS stated that following the conference in Attorney JOHNSON's office, the latter escorted Mrs. WILLIAMS and daughter to MC CARTHY Campaign Headquarters in Washington where he introduced them to a number of party workers.

Mrs. WILLIAMS stated that she can furnish no additional information and can not explain the specific significance behind JOHNSON's statement.

Mrs. WILLIAMS and daughter described STUART JOHNSON as a white male, age about 45, 5'11" - 6'0", slender build, graying hair, wore reading glasses.

As there does not appear to be any connection with captioned matter, this is submitted for information of Bureau, Los Angeles and WFO.

On June 5, 1968, Investigator Edwin Chauvin, Jr., Immigration and Naturalization Service (INS), New Orleans, Louisiana, furnished to the New Orleans Office of the Federal Bureau of Investigation (FBI) a communication entitled "Biblegram (telegram) to McArthy" which was received by the New Orleans INS Office on June 4, 1968. The communication bears the typewritten name "Merle M. Matteson." No envelope was used in mailing the communication. The communication was folded and the address of "Departement of Imigration, New Orleans, Louisiana" was written on the reverse side. The communication bears the postmark of Los Angeles, California, PM, May 31, 1968.

Investigator Chauvin advised that his office has no record of a Merle M. Matteson, and he said he does not know why the communication was sent to the New Orleans INS Office.

The above-mentioned communication is as follows:

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

He said he noticed one individual in the audience rise and smile and walk away after the announcement of the shooting. He said it was his impression the individual "knew something" about the shooting. He suggested the T. V. films be reviewed in connection with this matter. He terminated the call before identifying the T. V. station.

**ASSASSINATION OF

This is to advise that Sirhan Bishara Sirhan, a Jordanian national, has been identified as the individual who shot Senator Robert F. Kennedy at 12:15 a. m. , Pacific Daylight Time, June 5, 1968, in the ballroom of the Ambassador Hotel at Los Angeles, California. The Senator subsequently died at 1:44 a. m. , Pacific Daylight Time, June 6, 1968, at the Good Samaritan Hospital, Los Angeles.

After the assailant was taken into custody by authorities, he refused to identify himself or otherwise discuss this matter. He was shortly thereafter charged by the Los Angeles Police Department with intent to commit murder and held on \$250,000 bond.

His brother, Adel Sirhan, notified authorities as to Sirhan's true identity. The FBI subsequently identified Sirhan's fingerprints as being identical with those of an individual by the same name which were submitted by the California State Horse Racing Board during 1965.

According to the Los Angeles Police Department, the weapon used in the assassination was an eight-shot .22 caliber Iver Johnson pistol. All eight shots were expended. Records of the California Department of Justice show this pistol to have been sold on August 10, 1965, to one Albert Leslie Hertz of Alhambra, California. It was subsequently traced by police authorities through several parties to one of Sirhan's brothers, Munir Sirhan.

## ASSASSINATION OF SENATOR ROBERT F. KENNEDY

Sirhan Bishara Sirhan, according to records of the Immigration and Naturalization Service, Los Angeles, California, was born on March 19, 1944, in Jerusalem, Palestine. His current address was given as 696 East Howard Street, Pasadena, California. Immigration and Naturalization Service records show he entered this country on January 12, 1957, with his father, Bishara Salameh Ghattas Sirhan, his mother, Mary, four brothers and a sister who is now deceased. His brothers, Adel, Munir, and Saidallah, are currently shown as residing with their mother and Sirhan at 696 East Howard Street, Pasadena, California. The fourth brother, Sharif, is a resident of Highland Park, California. His father allegedly resides now in Jordan.

Our Los Angeles Office reports that Sirhan Bishara Sirhan graduated from high school in Pasadena, California. He thereafter attended Pasadena City College, a junior college, for approximately two years, but did not graduate. He formerly worked as a race horse exercise boy and during September, 1966, sustained a head injury after falling from a horse. Interviews with his family indicate his behavior has changed considerably since this injury. Records of the State of California reveal he was awarded a settlement on March 27, 1968, in the sum of \$2,000. His brother, Adel, advised the assailant has been unemployed for the past three months. When taken into custody he had \$409 in cash on his person.

During a search of his room in the Pasadena family home numerous items, including notations advocating the overthrow of the President of the United States and statements alluding to the necessity for assassinating Robert F. Kennedy, were found. According to United States Attorney William Matthew Byrne, Jr., Central District of California, who had been in contact with the office of the Los Angeles County District Attorney, this material should not be disclosed publicly prior to the trial nor should it be made available to unauthorized persons since it could have a serious adverse effect upon successful prosecution in either Federal or State court. One handwritten page bearing the date May 18, 1968, 9:45 a. m., contains numerous notations among which are "My determination to eliminate RFK is becoming more the more of an unshakeable obsession." "RFK must die - RFK must be killed. Robert F. Kennedy must be assassinated." Another page contains the handwritten statement that "The so-called President of the United States

of America will be advised of their punishments for their treasonable crimes against the state. More over we believe that the glorious United States of America will eventually be felled by a blow of an assassin's bullet. "

A third page contains the following statement. "Ambassador Goldberg must die die die." Repeated numerous times on this same page appears "Goldberg will be illiminated. "

Page four contains the statement "Kennedy must die - Kennedy must fall," which is repeated numerous times.

Page five contains the statement that "RFK must be disposed of like his brother was. "

The statement "I advocate the overthrow of the current President of the (obscene) United States of America. I have no absolute plans yet - but soon will compose some" appears on page six.

Page seven contains the statement "Well, my solution to this type of Govt. today is to do away with its leaders and declare anarchy, the best form of Govt. or no Govt. "

On page eight appears the statement "I believe that I can effect the death of Bert C. Altfillisch," who was the employer of Sirhan at the time he was thrown from a horse during September, 1966.

Also appearing was the notation "Robert F. Kennedy must be assassinated before 5 June 68. "

In addition, a source who has furnished reliable information in the past and who is an active member of the Communist Party in California advised that he received information from an associate of Sirhan's to the effect he was extremely anti-Semitic in his views, was in favor of the Vietcong and supported some Communist Party ideals. Sirhan, according to this source, had been thoroughly briefed on Communist Party activities at the University of California at Los Angeles within the last two weeks. Although it was reported to this source that an attempt had been made to recruit Sirhan into the Communist Party, Sirhan allegedly has not engaged in any Communist Party activities.
