FLOYD ARMSTEAD, Instructor, Mathematics Department, Olympic College, Bremerton, Washington, advised on June 6, 1968 that on the morning of June 6, 1968 while he and some Olympic College students were in a discussion with a student named SULAIMAN NOSAYAN, the latter made some statements concerning the assassination of New York Senator ROBERT F. KENNEDY in Los Angeles, California, June 5, 1968.

Mr. ARMSTEAD stated that SULAIMAN NOSAYAN said the assassin of KENNEDY was "justified in doing what he did". He said that SULAIMAN NOSAYAN further said he knew the assassin personally, having met him in San Francisco. However, he did not indicate the closeness of their relationship. Mr. ARMSTEAD said that SULAIMAN NOSAYAN also remarked "you must remember that this took place one year from June 5" (of last year). Mr. ARMSTEAD said further that SULAIMAN NOSAYAN was apparently well informed concerning the statements of Senator KENNEDY and pointed out that Senator KENNEDY had recently made statements supporting the shipment of arms to Israel. Mr. ARMSTEAD said that he, ARMSTEAD, told SULAIMAN NOSAYAN that "you (Arabs) will not get anywhere by blood shed" whereupon SULAIMAN NOSAYAN said "we'll be back again" (apparently referring to the Arab-Israeli dispute).

Mr. ARMSTEAD said that in some previous discussions with SULAIMAN NOSAYAN, whom he described as a soft-spoken individual who is "nice to talk to", SULAIMAN NOSAYAN had indicated that he does not hate the Jews as individuals but is against the aggression of Israel and that he holds it against the United States and Britain for helping Israel. Mr. ARMSTEAD said that SULAIMAN NOSAYAN has also said that NASSER is a great man and we (United States) does not understand him.

This is to advise of current developments with respect to our investigation into captioned matter.

### ADMISSIBILITY OF EVIDENCE

With respect to the material obtained from Sirhan's room in the family home at Pasadena, California, information has been received from Los Angeles that Lynn Compton, Chief Deputy District Attorney, Los Angeles County, has voluntarily opined that the search was completely illegal as no search warrant had been obtained, and, furthermore, the evidence had been tainted by Los Angeles Mayor Yorty's public comment concerning the contents of the material seized. We had contacted Compton in connection with our Laboratory and Identification Division examination of this material and he emphasized that he was furnishing this opinion in extreme confidence and only for the information of the FBI.

Los Angeles reports that when a Bureau Agent reached the scene of the search the press and television were already at the home at 696 East Howard Street, Pasadena, setting up television equipment with newsmen searching through the trash cans. Local law enforcement officers immediately entered the home and the Agent, with another officer, went to the rear of the residence in order to determine if anything had been taken by the newsmen. When the Agent finally entered the residence police officers were in the process of sorting through the notebooks and other material. Our Agent did not participate in the search but merely observed the proceedings.

of the family; other victims of the assault; current incarceration of Sirhan as well as other related matters. Christopher, Lynch and Byrne all went to the county jail, observed the cell area and discussed the situation with the Los Angeles County Sheriff. They also viewed the crime scene at the Ambassador Hotel. According to SAC, Los Angeles, all appeared highly pleased with the thoroughness and accuracy as well as the over-all handling of the FBI investigation. No mention was made as to whether the FBI should interview Sirhan at this time, it being noted we have on 6/6-7/68 discussed this aspect with the Civil Rights Division requesting their views as to what action should be taken along these lines.

THE GIRL IN THE POLKA DOT DRESS

One phase of this investigation which has been receiving considerable attention by the news media is the so-called girl in the polka dot dress who was reportedly seen running from the ball room immediately after the shooting screaming "we have shot him." A student, Sandra Serrano appeared on television shortly after the shooting describing the incident. Cathie Fulmer, a Los Angeles cocktail waitress, contacted the Los Angeles Sheriff's Office indicating she may have been the girl involved since she had a polka dot scarf over her dress and did run from the hotel screaming "They have shot him" immediately after the incident. Fulmer although not certain, believes she saw Sirhan several times prior to the shooting at the hotel.

When questioned thoroughly by Los Angeles Agents it was noted that the area of the ball room where Fulmer states she was located and the entrance and exit she used were not near the area the witness claims to have seen the girl in the polka dot dress. The witness after viewing Fulmer claimed she was not identical with the individual she saw. This phase of our inquiry is being pressed.

ATTEMPT TO SMUGGLE GUNS INTO JAIL

According to information received from the Los Angeles Sheriff's Office on 6/7/68, that department received information from a confidential source to the effect that a woman was going to smuggle three guns into the jail in order to effect the escape

of two convicted murderers awaiting execution. At 7 p.m., 6/7/68, a 55-year-old woman, Edyth Claybaugh Grant, subsequently entered the jail building and the deputy discovered the guns secreted in a typewriter which she intended to leave for one of the inmates. This has no direct connection with captioned matter; however, it has received considerable attention in the press.

PHOTOGRAPHS AT AMBASSADOR HOTEL SOLD TO LIFE MAGAZINE

Peter Berksen Spencer, a professional free lance photographer was present at the scene of the shooting and reported to our Los Angeles Office that immediately upon hearing the shots took approximately 20 to 30 photographs of the ensuing action. The negatives were purchased by Life magazine and forwarded to New York City. We are contacting Life in an attempt to obtain copies of pertinent photographs.

ACTION

An exhaustive investigation of this matter is continuing.

On 6/10/68, "The Las Vegas Sun" newspaper, a Las Vegas daily morning newspaper, carried a lead article headed "Pastor Notes Sirhan Vegas Visit". The byline on the article is RALPH DONALD, Sun Staff Writer. The article is as follows:

"A mumbling, apparently tranquilized Sirhan Bishara Sirhan disrupted a Las Vegas Methodist service three weeks ago, a church pastor said last night.

"The accused assassin of Sen. Robert F. Kennedy, now in custody in Los Angeles pending a trial for murder and assault with intent to kill, walked into the First Methodist Church of Las Vegas, 231 South Third St., and annoyed Sunday worshippers, according to Pastor Rev. Douglas A. Harrell. MS

"During the service proper he made loud, unintelligible sounds,' Rev. Harrell said, 'and complained to nearby congregation members about some moral issue while I was preaching my sermon.'

"Harrell said that most of Sirhan's words were mumblings of some sort.

"Many times, especially in Las Vegas, odd people happen into the church and try to disrupt things. If the ushers think they are dangerous, they eject them. Sirhan was very tranquil, as if he might have been under the influence of a depressant, so they decided to allow him to remain.'

C. C. - Bishop: "Harrell said Sirhan seemed harmless. 'He was subdued, it seemed, and didn't look like the type of person who was capable of harming anyone,' REO 88 Registrar said.

" 'At a coffee hour after the service, Sirhan came right up to me, his face right up to mind, and introduced himself. He mumbled and tried to say something, but I couldn't understand him. I asked him how he liked Las Vegas, trying to be pleasant. I assumed he was a newcomer. He again muttered something unintelligible.'

"In the crowds at the coffee hour, the minister lost track of the accused slayer. 'He must have decided to leave,' Harrell said. 'The next time I saw him was on television during the coverage of the Kennedy assassination.'

"He seemed so subdued and introverted the minister remarked, 'He just didn't seem like the type of person who could commit such a foul act.' "

A photograph of Rev. HARRELL accompanied the story in the newspaper.

On 6/10/68, Rev. HARRELL advised SA DONALD M. HOLLAND that the above article is completely erroneous and contains nothing but misquotes. Rev. HARRELL stated that RALPH DONALD was best man at a wedding he performed on 6/9/68, and that after the ceremony he and DONALD engaged in a conversation concerning the KENNEDY assassination. During the conversation the topic of odd people and "kooks" came up and DONALD remarked at the number of this type of people who visit the "Sun" newspaper office on a daily basis. Rev. HARRELL stated he told DONALD that a number of such type people visit his church from time to time and that an individual who resembled SIRHAN SIRHAN had attended service at his church. He said that he in no way identified this individual as SIRHAN SIRHAN but merely related the story to DONALD as an example of "kooks" visiting his church.

In view of the publicity given this matter, Rev. HARRELL found it necessary to issue a public retraction to be disseminated to all news media. He said that even though there may have been a resemblance between the young man and SIRHAN SIRHAN, he, Rev. HARRELL, in no way identified the visitor as SIRHAN SIRHAN. Rev. HARRELL's prepared retraction is as follows:

Statement of Local Minister

On Sunday, May 26, a young man dressed in a blue suit and wearing cloth shoes, seated near the rear of the Sanctuary proved to be a problem to those worshipping near him. He laughed and mumbled aloud during the entire 11 o'clock service. He was a most disturbing influence to those seated near him and to the Minister. Later, during coffee hour, he approached the Minister and attempted to engage in conversation. He was soft spoken and to Rev. Harrell unintelligible.

The young man seemed very emotionally disturbed. It is not unusual for troubled people to seek help at First Methodist Church, which, being located in the center of the city, proves easily accessible. On this particular day the Minister was unable to relate to this person because of illness. (He was admitted, himself, to Sunrise Hospital at 12:40 that day.)

In view of the tragedy which occurred last week and the description of the suspect, there seemed to be a definite resemblance. However, Rev. Harrell has made, nor makes, any positive assertion of an identification.

On 6/10/68, DESSIE KNIGHT, wife of the manager, Town Palm Hotel, 321 South Casino Center Boulevard, Las Vegas, Nevada, advised SA DONALD M. HOLLAND that ELLEN BLASOR, who resided in Room 218 of the Town Palm from July to December, 1967, did work two or three nights as a night clerk in that hotel.

KNIGHT said BLASOR was completely unreliable and had to be relieved from her duty as night clerk because of her inability to do the job. KNIGHT stated that BLASOR had a very vivid imagination and as an example, BLASOR told KNIGHT she was getting a divorce so that she would be free to marry HOWARD HUGHES, who, according to BLASOR, was very much in love with her.

KNIGHT said there is no "B side" to the Town Palm and that term has never been used in connection with the hotel. KNIGHT stated she recalls no one having lived at the hotel who even remotely resembled SIRHAN SIRHAN. No one using that or similar names has ever been registered into the hotel.

No further inquiry is being made into the matter reported by ELLEN BLASOR.

Joe Dolan, Administrative Assistant to the late Senator Robert F. Kennedy, called at 10:15 a. m., 6/10/68. He told me that he was now attempting to close up the late Senator Kennedy's office and he just needed a little advice and guidance as to what should be done regarding certain things. I told Dolan that I wanted him to know that, despite the differences between the FBI and Senator Kennedy, we nevertheless extended our sympathy and had been appalled at the way Kennedy had been gunned down. Dolan stated he appreciated this sentiment. *D.C.*

Dolan mentioned that in reviewing the files in Senator Kennedy's office, he is coming across a number of threats which have never been referred to the FBI. I told him if they were of a Federal nature he should consider sending them to us. He stated he doubted that they were Federal violations. He asked what he should do concerning information received regarding the assassination of Senator Kennedy. I told him he should send this information to us and that it would be handled promptly. He stated that threats are still being received regarding Senator Edward Kennedy. Some people are indicating "two down and one to go." I told him if these represented violations within FBI jurisdiction, he should send them to us. *Mo*

Dolan told me that the man named Didell who was arrested in front of St. Patrick's Cathedral at the time of the funeral of Senator Kennedy had actually been known to the Senator's office and had been invited to the funeral. Didell had once been in the running over the job of head of Kennedy's Buffalo office. He was however not given this job. Dolan stated that Kennedy people regarded Didell as a promoter.

I told Dolan that in connection with the above-mentioned matters, he should feel free at any time to get in touch with SA Dave Bowers. I stated we would be glad to be of any possible assistance. Dolan expressed his appreciation.

Mr. P.J. McNichol, Assistant Director for Security, United States Information Agency (USIA), advised Liaison 6/5/68 that one Zaki Anis, an employee of the Voice of America, USIA, has reported to that Agency that he, Anis, is acquainted with a chauffeur at the Saudi Arabian Embassy, Washington, D.C., one Bassim Akkad. This latter individual, according to Anis, is acquainted with another employee of the Saudi Arabian Embassy, unidentified, who knows Sirhan Sirhan, the individual involved in captioned matter. According to Anis, this embassy employee describes Sirhan as a Palestinian Christian coming from Silwan Village, a suburb of Jerusalem on the Jordanian side of the 1948 armistice line. He states that Sirhan comes from a well-to-do family and has been in the United States for 5 years as a student. *MS*

McNichol stated that should we desire to interview Anis for further details, arrangements can be made through the Chief of the Arabian Service, USIA, Pierce Bullen (Code 13, Extension 33076).

Sirhan or identical with Sirhan. Driggs indicated that many "card carrying communists" were at the party and much communist literature was observed in the home. He furnished a color slide of the individual known to him as Serharnd which is being forwarded to Los Angeles by Cincinnati.

McNichol, Assistant Director for Security, United States Information Agency (USIA), advised Liaison 6/5/68 that one Zaki Anis, an employee of the Voice of America, USIA, has reported to that Agency that he, Anis, is acquainted with a chauffeur at the Saudi Arabian Embassy, Washington, D. C., one Bassim Akkad. This latter individual, according to Anis, is acquainted with another employee of the Saudi Arabian Embassy, unidentified, who knows Sirhan Sirhan, the individual involved in captioned matter. According to Anis, this embassy employee describes Sirhan as a Palestinian Christian coming from Silvan Village, a suburb of Jerusalem on the Jordanian side of the 1948 armistice line. He states that Sirhan comes from a well-to-do family and has been in the United States for 5 years as a student.

McNichol stated that should the FBI desire to interview Anis for further details, arrangements can be made through the Chief of the Arabian Service, USIA, Pierce Bullen (Code 13, Extension 33076).

THE INDIVIDUAL ARRESTED BY THE LOS ANGELES POLICE DEPARTMENT FOR THREATENING THE LIVES OF THE KENNEDY FAMILY HAD A DRIVER'S LICENSE IN HIS POSSESSION WHICH INDICATED THAT HIS NAME WAS WILLIAM FREDERICK CROSSON. HE TOLD THE POLICE THAT HIS NAME WAS HARRY WILLIAMS. A HYPODERMIC NEEDLE WAS IN HIS POSSESSION AT THE TIME OF ARREST. HE IS PRESENTLY BEING HELD IN CUSTODY BY THE LAPD FOR THE FBI. HE HAS NOT BEEN BOOKED BY LAPD AS YET. CROSSON ALSO HAD AN EIGHT PAGE TELEGRAM IN HIS POSSESSION WHICH HAD BEEN SENT TO "MR. WASHINGTON," SENTINAL NEWS, 1112 EAST 43RD STREET, LOS ANGELES, CALIFORNIA. CROSSON IS IDENTIFIED AS A MALE CAUCASIAN, DOB: 9 MAY 1922, 5'8", 220 POUNDS. NO FURTHER INFORMATION IS AVAILABLE AT THIS TIME.
