Dear Sir,

I have a theory on Robert Kennedy's shooting that I would like you to know about. I grew up in Kansas City; I was only vaguely aware of Mafia activities until I roomed with an Italian girl from Kansas City while we were in college. She was at that time dating an Italian boy who was definitely a member of the Mafia. (To my knowledge, she no longer dates him; she was even somewhat afraid to tell him she no longer cared to see him.)

However, one night my roommate and I were intimately talking, and the subject of current events came up. As you know, murderers names are very well-known by all of the Mafia, but never spoken to anyone outside of the Mafia. She said this boy knew the name of Sam Palma's killer, as did many Mafia members. (He didn't tell her so she could truthfully say she didn't know. Also, she didn't want to know.) In addition, my roommate mentioned that it was Mafia knowledge that they had arranged John F. Kennedy's death through Lee Harvey Oswald.

According to my roommate, J.F.K. had made some rather large promises to labor, and had failed to keep them. Also, Robert Kennedy had been too powerful an adversary for organized crime to feel comfortable with. So, the Mafia decided to take action against Robert Kennedy by killing someone very close to him-----John F. Kennedy. This, they felt, would serve as a warning to Robert Kennedy not to meddle further with organized crime.

Upon hearing about Robert Kennedy's attempted assassination, it suddenly occurred to me that perhaps organized crime had begun to fear Kennedy's ascension to power. They waited until after the crucial California primary to see if Kennedy would be a formidable contender for the Presidency. Another idea that suddenly came to mind was the similar "dead end" backgrounds of Lee Harvey Oswald and the would-be assassin of Robert Kennedy. My roommate had said Oswald had been picked because his background misleadingly pointed to Communism. Surhan's, or whatever his actual name is, background could be misleadingly pointing to the Middle East. It would be convenient for the Mafia to choose a killer who had no criminal record, ~~and therefore no fingerprints on file with the F.B.I.~~

This theory could be perfectly worthless; on the other hand, if it has shed any light upon this string of senseless assassinations, I am glad to have helped my country in a small way in this time of turmoil.







On June 10, 1968, at 9:00 AM, the Central Intelligence Agency (CIA) reported that one Arlington Robert Scott, 2919 Bedford Avenue, Pittsburgh, Pa., telephonically contacted CIA Headquarters at 4:00 AM on June 8, 1968, and requested assistance and equipment from the CIA in that he needed help to go to California to see Senator Robert F. Kennedy's assailant was properly punished. Scott alleged he could not be certain that the assailant would not get off and since Senator Kennedy was the only friend of the Negro, he wanted to make sure Sirhan Sirhan would receive proper punishment. C., and spoke to a man whose name he cannot recall. Scott said he called because he was angry over the assassination of Senator Robert F. Kennedy and is concerned the assailant, Sirhan Sirhan, will not receive the punishment he deserves since he is not a citizen of the United States. He feels diplomatic pressure will be applied by Jordan which will result in Sirhan receiving a lighter sentence than he deserves. Scott said Sirhan killed Kennedy and, therefore, he should die also. He said Sirhan will be killed by a "suicide squad" prior to going to trial, but would not elaborate on who will make up the "squad."

Scott was evasive when questioned if he personally plans to attempt any action against Sirhan, but admitted requesting assistance and equipment from the CIA in order that he could travel to California. Scott stated he will not incriminate himself by saying he plans to take some type of action against Sirhan nor would he say he is not going to attempt such an action.

Scott said he is practicing with a high-powered rifle equipped with a telescopic sight, which belongs to his Chinese girl friend, whose name he refused to give. Scott also stated that the feeling he has about Sirhan also applies to James Earl Ray, the accused assassin of Martin Luther King, Jr. Scott expressed hostility toward George Wallace, former governor of Alabama, and Pittsburgh Mayor Joseph Barr, but would not specifically state what he feels should be done about these individuals. However, Scott implied that both Wallace and Barr should be handled in the same fashion as Sirhan and Ray. Scott described himself as a "fanatic" and said he was treated at the State Mental Hospital in Petersburg, Va., from December 2, 1952, through April 13, 1953, for mental instability. He also stated he was treated at the Veterans Administration Hospitals in Roanoke, Va., during the late 1940's and early 1950's and in Pittsburgh, Pa., in 1967 for mental instability, and at St. Francis Hospital, Pittsburgh, Pa., in 1967 for the same reason. Scott said he served in the United States Army in 1946 through 1947 under Army serial number 123070733 and was given a medical discharge for being mentally unstable. Scott further stated he has had several operations in the past including one for ulcers and said he currently has scars on his lungs, which will prevent any future operations. Scott said he has little to live for and would willingly give up his own life in order to help his race.

He displayed a letter dated May 18, 1968, written by PHILLIP M. WRONKA, the late Senator KENNEDY's staff assistant, which acknowledged PIRAINO's telephone call early in May, 1968. WRONKA's letter informed PIRAINO that he could not clearly understand him over the telephone and suggested PIRAINO write another letter to him directly rather than to Senator KENNEDY.

The Visa Section did not issue a visa to PIRAINO.

PIRAINO was interviewed at the American Embassy, Rome, Italy, on June 11, 1968, and furnished the following information:

In approximately July, 1965, PIRAINO traveled to Copenhagen, Denmark, for the purpose of finding employment. After about one week of searching, he found himself in the vicinity of the central railroad station in Copenhagen and there encountered a dark, swarthy man about 1.85 to 1.87 meters in height. This individual had black, curly hair, black eyes and a deep olive complexion. PIRAINO said he is convinced after seeing photographs

of SIRHAN BISHARA SIRHAN in the newspapers that SIRHAN and the man he met in Copenhagen are one and the same person. PIRAINO does not recall the man's name but was told by him that he came from Naples, Italy, and PIRAINO noted that he spoke with a Neapolitan accent. According to PIRAINO, he never heard the individual speak English nor did this person ever mention that he had been in the United States. PIRAINO noted that the man was traveling with an Italian passport but declared that false passports were very easily obtained.

PIRAINO said he became quite friendly with this individual who displayed to PIRAINO a cut he had received across the abdomen in a fight over a girl in Germany. PIRAINO said the cut, which was on the right side of this man's abdomen, was still giving him pain. Several days later, PIRAINO and the individual proceeded to Stockholm, Sweden, where they remained for about three days. The last time PIRAINO saw this individual was in Stockholm when he was visited by a young Italian male who was accompanied by a young girl with blond hair. The three left Stockholm in the latter part of July, 1963, and he has not seen or heard from them again.

PIRAINO believes the young blond girl is the same person whom newspapers have reported is wanted for questioning by the Los Angeles Police Department. He said he is unable to furnish any other identifying data concerning the dark, swarthy male he met in Copenhagen or the blond girl.

Throughout the interview with PIRAINO, he often expressed his admiration for the United States of America and how he longed to reside in the United States. He said that ever since President JOHN F. KENNEDY was assassinated in 1963, he has been obsessed with a feeling of impending tragedy for other members of the KENNEDY family. He said he has sent at least eight letters to Senator ROBERT F. KENNEDY prior to his assassination disclosing his desire to enter the United States. Although he could furnish no facts to substantiate his feeling, he said he felt certain something was going to happen to Senator ROBERT F. KENNEDY prior to his assassination on June 3, 1968.
