SUBJECT: KENSALT

At 9:30 p. m. , 6-13-68, an individual identifying himself as Basil McCormick, 236 Westwood Avenue, Toronto, Ontario, Canada, telephonically contacted Extra-Duty Supervisor H. E. Helgeson. He said he was calling in connection with the recent assassination of Senator Robert F. Kennedy and commented "I feel Senator Edward Kennedy is a doomed man. Some nut is going to make a name for himself and assassinate him." He said that this was his own opinion and he had no knowledge whatsoever of any plans by any person to do this. He said the reason for his call was that he had a feeling of concern for Senator Edward Kennedy.

It was noted that McCormick appeared to be thick-tongued, although he spoke as a well-educated man. He appeared to be intoxicated.

After voicing his concern for Senator Edward Kennedy's life, he mentioned the assassination of President John F. Kennedy and stated it was the FBI's fault President Kennedy was assassinated because the FBI had a long list of people who were capable of committing this act and did nothing about it. At this point he was told that it appeared he was not in possession of the correct facts in this matter, at which time he interrupted and became abusive in his language, again criticizing the Bureau for failing to prevent the assassination of President Kennedy. The conversation was terminated with him at this point.

Bureau files contain no information identifiable with McCormick.

The following information was telephonically furnished to Special Agent Mark Brown, United States Secret Service, by Special Agent Conrad W. Thompson, Jr., of this Bureau, at 6:30 p.m. on June 7, 1968.

An individual, who identified himself as Robert Lee Driggs, 27 Ewing Street, Chillicothe, Ohio, appeared in the Chillicothe Resident Agency of this Bureau on June 6, 1968. He stated that he attended a party on July 4, 1965, at Pasadena, California, at the home of an individual known to Driggs as Serharnd. He now believes that Serharnd is possibly related to or identical with Sirhan B. Sirhan, accused assassin of Senator Robert Kennedy.

Driggs indicated that he intended to depart Chillicothe, Ohio, on June 7, 1968, to attend Senator Kennedy's funeral in Washington, D. C., and thereafter join the Poor People's Campaign.

Chief of Police George W. Rice, Chillicothe, Ohio, Police Department, advised that Driggs is known to him. Chief Rice indicated that he considers Driggs to be mentally unstable and described him as "radical."

Driggs is described as a white male; born May, 1940, Ross County, Ohio. He is 5 feet 8 inches tall and weighs 140 pounds. He has brown hair which is cut extremely short and green eyes. Driggs has previously been arrested by the Chillicothe, Ohio, Police Department

Floyd M. Baring, a retired Secret Service Agent who has been employed by the Kennedy for President Committee, telephonically furnished Special Agent Bowers on 6-12-68 the following information.

Emma Christopher, who was a volunteer worker at the Kennedy Campaign Headquarters in Washington for a time, has reported that she knew one Suleman A. Khattab, an Arab, who worked as a volunteer for a few days at Kennedy Headquarters. She has indicated this individual "acted suspicious" during the time he was there. Baring said she had mentioned this to her present employer, Robert Wald, a Washington attorney, who in turn informed the Kennedy Headquarters officials.

Baring stated their records on Khattab indicate he was a language instructor at the Institute of Modern Language, 1616 Connecticut Avenue, Northwest, with an additional address of 2020 F Street, Northwest, telephone number 659-1646. Baring stated Miss Christopher can be reached at telephone number 363-3013. He did not have an address for her and stated he has no further information on this matter.

2. QTE. STARTLING NEW EVIDENCE ABOUT THE IDENTITY OF THE MAN

WIFE WAS BROUGHT TO HIM. THE RECORDS OF HIS JOURNEY ARE NOT VERY PRECISE AND PROBABLY NOT VERY IMPORTANT, AS BOTH HUSBAND AND WIFE WERE LITTLE MORE THAN CHILDREN. RATHER MORE INTEREST CENTRES ON THREE LATER JOURNEYS WHICH SIRHAN MADE, ESPECIALLY ON THE LST TWO WHICH, ACCORDING TO THIS INVESTIGATION, WERE MADE IN 1964 AND 1966. IN 1964 SIRHAN, ACCORDING TO THESE RECORDS, RETURNED TO THE MIDDLE EAST FOR SEVEN MONTHS, FOUR OF WHICH HE SPENT IN DAMASCUS. WHERE HE WAS FOR THE REST OF THE TIME IS NOT STATED. IN 1966 HE IS SAID TO HAVE SPENT AN EVEN LONGER PERIOD IN THE MIDDLE EAST, INCLUDING A STRETCH OF FIVE MONTHS IN CAIRO. HE RETURNED TO THE UNITED STATES, ACCORDING TO THIS REPORT, AT THE BEGINNING OF 1967. THE ARAB GOVERNMENT IS CONVINCED THAT ITS RECORDS ARE ACCURATE BUT THEY ARE BEING SENT TO THE UNITED STATES SO THAT THEY CAN BE CHECKED WITH THE INFORMATION ASSEMBLED BY THE FBI. THERE IS AN EVIDENT AND INCREASING DISINCLINATION, HOWEVER, FOR WITNESSES TO TALK AND EVEN THOSE WHO SPOKE AT FIRST-- SUCH AS SIRHAN'S FATHER -- HAVE NOW ADJUSTED THEIR RESPONSES. LAST WEEK SIRHAN'S FATHER CURSED HIS SON. YESTERDAY HE WAS DENOUNCING KENNEDY AND PREPARING TO GO TO LOS ANGELES TO STAND BY HIS SON.

Dear Sir:

I have been watching the television coverage of the shooting of Robert Kennedy, and am getting angry at being told by so many people who should know better, that because I was one of those opposed to Kennedy's becoming president, I am in some way responsible for his being shot.

The situation at this time is none of my doing. It was caused by the Supreme Court's decisions favoring criminals as a, instead of their victims; the decisions making it possible for the communists to work against our government without penalty; and the coddling of the rioters and looters and promising people pie in the sky without working for it. All this under seven years of Democratic administration.

The authorities deny that there is a possibility of a conspiracy. Inclosed is a column by Paul Scott which states Martin Luther King's assassin went to Mexico, as did John Kennedy's killer, just before the crime. I think the possibility of Sirhan Sirhan's being a Castro agent should be thoroughly looked into.

I believe it extremely possible that Castro might be trying to start a revolution in this country by assassinating the special friends of the so-called "poor people".

Senator McCarthy has come right out and demanded the firing of J. Edgar Hoover, and we know Senator Robert Kennedy felt the same. Mr. Hoover has devoted his life to the service of his country, and has tried in every way to awaken us to our danger, but he seems to be a prophet his country refuses to heed. What can be done to save a country that seems determined to destroy itself?

I am writing to you because you are in a position to bring out these problems in the coming months. We must have a change!
