GEORGE ROBERT LETSINGER

On June 11, 1968, Mr. JOSEPH FORROR, Assistant Postmaster, Main Post Office, San Diego, California, advised as follows:

Found on the incoming mail belt was a piece of paper not in an envelope written in green ink which was addressed to "Post Office Post Master". This note reads as follows:

"If the F.B.I. wants Ray,s buddy go to 124 Broadway Metropole Hotel Room 117. He may be under the name Geore Letsinger or George Anderson. He knows about Kennedy and also King,s death,s. He may have part in Kings death. I know he was in Tenn. before and after King was killed. I know Letsinger is wonted in Seattle. Also in Big Stone Gap, Virginia, by the F.B.I."

On June 12, 1968, information was received from the Seattle Division, Federal Bureau of Investigation, that one GEORGE ROBERT LETSINGER, FBI Number 584 742 F, born July 13, 1942, at Macomb, Missouri, was arrested at Jacksonville, Florida, on April 11, 1968, charged with grand larceny having stolen \$550 to \$600 from a restaurant in Seattle, Washington, for which he was employed.

LETSINGER was returned to Seattle, Washington, and on the basis of the charge against him, received a three-year deferred sentence, six months in the county jail and ordered to make restitution.

LETSINGER appealed this sentence and was placed on bond, however, departed the State of Washington and a bench warrant was subsequently issued by the Superior Court, Seattle, Washington.

Information was also furnished that authorities at Seattle, Washington, desired his apprehension and would extradite LETSINGER to Seattle, Washington. Based on this information, the San Diego Police Department arrested GEORGE ROBERT LETSINGER at Room 117, Metropole Hotel, 124 Broadway, San Diego, California, on June 12, 1968. At time of arrest, LETSINGER admitted his identity and the fact that he knew he was wanted by the State of Washington.

GEORGE ROBERT LETSINGER was interviewed by Agents of the Federal Bureau of Investigation at San Diego, California, on June 13, 1968, at which time he advised as follows:

LETSINGER advised that in 1963 he went to England and visited the Russian Embassy, Grovesner Square, London, England, for the purpose of renouncing his United States citizenship.

He was arrested while in England by New Scotland Yard, based upon a check which he had deposited in a bank prior to his departure to England and later determined it was a fraudulent check.

LETSINGER was asked why he desired to renounce his citizenship, to which he replied the country is no longer a country for the white people and is eventually being taken over by the "niggers."

LETSINGER exhibited a strong anti-Negro sentiment and stated that at one time he had been a member of a clan-type organization at Big Stone Gap, Virginia.

LETSINGER was questioned as to his association with JAMES EARL RAY and whether he had any knowledge concerning the assassinations of Dr. MARTIN LUTHER KING, Senator ROBERT F. KENNEDY and President JOHN F. KENNEDY. LETSINGER merely replied "I do not wish to talk about these subjects."

LETSINGER did say, however, that if Senator TED KENNEDY and Vice President HUBERT H. HUMPHREY continue to seek the Presidency of the United States, they will be assassinated. LETSINGER did not desire to elaborate regarding this information.

GEORGE ROBERT LETSINGER

LETSINGER admitted previous mental history, having been confined during 1961 for a short period of time at St. John's Hospital, Springfield, Missouri.

Handprinting was obtained from LETSINGER and was compared with the note received by the U. S. Post Office, San Diego, California, and because of a close resemblance of these, LETSINGER was asked if he, in fact, had written the note himself.

He categorically denied having written this note.

Result of examination:

Due to differences in time of writing and due to the limited amount of available writing of Sirhan Bishara Sirhan, a definite conclusion was not reached whether Sirhan Bishara Sirhan wrote any of the questioned writing on specimens submitted previously in this matter. Due to the limited amount of writing available for examination, a definite conclusion was not reached whether the writers of K4 through K7 wrote any of the questioned writing on the specimens submitted previously.

Specimens K2 through K8 are being returned to FBI, Los Angeles. Specimen K9 is being returned to FBI, San Francisco. These specimens have been photographed.

NOTE FOR LOS ANGELES:

This confirms Bureau teletypes dated 6-11-68, 6-12-68, and 6-13-68 addressed to Los Angeles in this matter. For your investigative guidance, similarities were noted in the writings of Sirhan Bishara Sirhan and certain questioned writings.

Los Angeles has been requested to obtain contemporary writings of Sirhan containing words and letters comparable with the questioned writing. Efforts to obtain known writings comparable with the questioned writing should be continued.

San Francisco requested the return of specimen K9 so that it could be returned to the Argonaut Insurance Company. Since K9 may become a piece of crucial evidence in this case, San Francisco should retain K9 until such time as this specimen may no longer be needed as evidence.

A United Press International release on June 13, 1968, indicated an unidentified Arab Government had passed "new and startling" information to American officials relative to Sirhan Bishara Sirhan. It is reported by correspondent John Kimche in the London Evening Standard that Sirhan had traveled in the Middle East in 1964 for seven months. He allegedly returned to the Middle East in 1966 spending five months in Cairo, Egypt, before returning to the United States in the beginning of 1967.

A Reuters dispatch on June 13, 1968, additionally reported that this individual's full name, according to Kimche, was Sirhan Bishara Sirhan Abu Khatar. This individual, according to the dispatch, was first brought to the United States in 1928 when he was four years old. He was allegedly married upon a return to the Middle East on June 27, 1957, to Leila Ussef Mikhael at Es Salt, Jordan.

Records of the Immigration and Naturalization Service show that Sirhan Bishara Sirhan entered the United States on January 12, 1957. His date of birth was given as March 19, 1944, Jerusalem, Jordan.

Investigation by our Los Angeles Office reveals he took up residence with his family in Pasadena, California, immediately upon his entry into the United States attending the Pasadena city schools until graduation from the John Muir High School in June, 1963. Thereafter he attended Pasadena City College until May of 1965.

Investigation reveals that during 1964 Sirhan Bishara Sirhan was attending school and employed at two Pasadena, California, service stations. Investigation further indicates that during 1966 he was continuously in the Pasadena, California, area.

In addition, each of Sirhan's four brothers was interviewed by Special Agents of the Los Angeles Office of the FBI on June 13, 1968, at which time they advised Sirhan has never left the United States since his arrival in 1957. They pointed out that the word Abu Khatar, meaning "is the father of Khatar," is a term not used by Christians and that the Sirhan family is Christian.

The Department of State has advised that it has received no communication from any country in the Middle East relative to the aforementioned matter. According to the Department of State, information was received from the American Embassy in Tel Aviv, Israel, to the effect that a United Press International correspondent had reportedly talked with Sirhan's father in Jordan who stated that to his knowledge Sirhan never married and the other details contained in the original story of June 13, 1968, are highly improbable.

According to the Department of State an attempt was made by that agency in London to contact Jon, also known as John, Kimche with whom this story originated. Kimche refused to identify his source but reiterated his source is usually reliable. According to the Department of State he seemed unimpressed by the possibility this might be a simple case of mistaken identity.

Kimche, according to the Central Intelligence Agency, is an able, unscrupulous free lance journalist in London who apparently supports official Israeli Zionist lines in his work. The Central Intelligence Agency reports that during early 1968 there were strong protests from American Government circles in London against his articles which appeared to be aimed at destroying relations between the United States and Arab countries.

Attached is a memorandum setting forth full details relative to the story that appeared in the London Evening Standard on June 13, 1968, to the effect that "new and startling" information had been reported to American officials by an unidentified Arab Government concerning Sirhan Bishara Sirhan. The White House had previously made inquiry on June 13 concerning this release and a preliminary report was furnished the White House that date showing that the allegation had no basis in fact. This story was authored by Jon, also known as John, Kimche who has since been described by CIA as an unscrupulous free lance journalist who apparently supports official Israeli Zionists lines in his work.

Kimche alleged that his source identified Sirhan as having traveled to the Middle East from the United States in 1964 and 1966, during the latter visit spending time in Cairo, Egypt. It was reported that he allegedly married one Leila Ussef Mikhael at Es Salt, Jordan, during another trip to the Middle East on June 27, 1957.

Our investigation shows this to be entirely without foundation since we can definitely show Sirhan to have been either gainfully employed or in school during the periods he is alleged to have been abroad. Furthermore, interview with each of his brothers indicate Sirhan has not left this country since his arrival on Jan 12, 1957.

The State Department, through its Embassy in London, contacted Kimche in an effort to pin him down relative to this story but he refused to identify his source and seemed unimpressed, according to the State Department, by the possibility this might be a simple case of mistaken identity. *62-587-494*

Attached hereto for approval is a letterhead memorandum for the White House with copies for the Vice President and the Department setting forth current developments in our continuing investigation of the assassination of Senator Robert F. Kennedy.

Information contained in the personal effects of Sirhan Bishara Sirhan indicated he was interested in the Rosicrucian Order (Ancient Mystical Order Rosae Crucis, also known as AMORC), San Jose, California. Inquiry with officials of this order reveals Sirhan filed an application in June, 1966, and his membership subsequently became inactive due to his failure to pay dues. His membership was reactivated upon payment of dues in February, 1968.

Bureau files reveal the Rosicrucian Order is philosophical in nature with religious implications and has never been investigated by us.

Officials of this order state it is a world-wide fraternal organization operated on a lodge system. They claim it is nonsectarian and is not a religious order although Christian principles are adhered to. They state that any law abiding citizen over 21 years of age, of good repute, and believing in a "Supreme Being" are eligible for membership. Members reportedly include a cross section of all classes of people and total world membership is claimed at approximately 90,000 people, of which 45,000 are in the United States. An official of this order states it traces its origin to the "mystery schools or secret schools" in Egypt approximately 1500 years B. C. The order requires that each member take an oath in support of his country and the country in which he lives. The order claims that any member charged with commission of a felony or found guilty of a serious breach of moral ethics is immediately cast out.

Although Sirhan is a corresponding member, we have learned he did attend a meeting of the Pasadena, California, chapter on the evening of 5-28-68. We are interviewing all persons who were in attendance at that particular meeting.

The attached letterhead memorandum sets forth detailed information concerning this order.

Local authorities obtained a search warrant and thereafter searched Sirhan's automobile on 6-5-68. Among other items this search revealed a sales receipt from the Lock, Stock and Barrel gun store, San Gabriel, California, reflecting the purchase of four boxes of .22 caliber ammunition on 6-1-68. Interviews with the gun store owner, his wife and the salesman who allegedly sold Sirhan the ammunition have resulted in several inconsistent statements. We are intensifying our investigation into this phase.

They advised it is nonsectarian and is not a religious order although the ethics of the order adhere to Christian principles. They further advised that the teachings of the organization do not interfere with religious freedom of members and only law-abiding citizens over 21 years of age, of good repute, and believing in a "Supreme Being" are eligible for membership. Members reportedly include a cross section of all classes of people and total world membership is claimed at approximately 90,000 people of which 45,000 are in the United States. This order reportedly traces its origin back to the "mystery schools or secret schools" in Egypt approximately 1500 years B. C., and is nonpolitical in nature.

On June 5, 1968, a search of Sirhan's automobile was conducted by the Los Angeles, California, Police Department. This search revealed a sales receipt from the Lock, Stock and Barrel gun store, San Gabriel, California, reflecting the purchase of four boxes of .22 caliber ammunition on June 1, 1968. Intensive inquiries are continuing into this as well as all other phases of this investigation.

Specimen Q21, as received in the Laboratory, consists of a metal container, a piece of insulated wire and numerous black particles. Specimen Q21 is contained in a plastic envelope and the wire is not attached to the metal container.

The blast drum-shaped metal container in specimen Q21 is approximately 13/16" in diameter and approximately 5/16" thick. A 1/4" diameter brass rod extends from one side of the container and a mica diaphragm and brass plate are mounted on the other side. Black granules or particles are present in the container. The container appears to have been damaged before receipt in the Laboratory.

The metal container appears to be a microphone button of the type used in telephones manufactured twenty to thirty years ago. Microphone buttons of this type were manufactured in great quantities. These microphone buttons contain carbon granules which form a variable resistance under the influence of voice vibrations. Without additional components and circuitry, Q21 could not transmit special speech signals or otherwise act as a monitoring "bug."

The black particles present in Q21 are essentially carbon.

There are impressions on the metal container which appear to have been made by a tool employing a gripping action such as a pair of pliers. There are also scratch type marks on the container which are not sufficiently characteristic to determine the type object causing these marks. The marks and impressions on the metal container are suitable for comparison purposes.




