BREHL covered the California and Oregon primaries for his newspaper. He spent his time covering both the KENNEDY and MC CARTHY campaigns. In Los Angeles he also covered both the KENNEDY and MC CARTHY campaigns.

During the time BREHL spent in Los Angeles and around the Ambassador Hotel he noticed no one who resembled the picture of SIRHAN SIRHAN. BREHL was not in a position to see the shooting of KENNEDY and did not see KENNEDY or SIRHAN after the shooting.

BREHL did not remember seeing a girl in a polka dotted dress around the Ambassador Hotel. He was unable to furnish any additional information regarding the assassination.

He was watching the KENNEDY victory celebration on television and when the Senator left the celebration he (BROWN) went in to take a shower. After he came out of the shower he heard sirens and looked at the television and it was then he heard that Senator KENNEDY had been shot.

He did not see SIRHAN SIRHAN either before the shooting or after the shooting and he does not have any knowledge of a conspiracy.

GEORGE GALE

GEORGE GALE, a reporter for the "London Daily Mirror", was reportedly present at the Ambassador Hotel, Los Angeles, California, on the evening of June 4, 1968.

Inquiry at the "London Daily Mirror" Office, 220 East 42nd Street, New York, New York, on November 18, 1968, revealed that GEORGE GALE had returned to London, England, and was not expected back in the United States in the near future.

It was further ascertained that GEORGE GALE, a reporter for the "London Daily Mirror", could be contacted through the "London Daily Mirror", Holborn Circus, London EC 1, England.

Mr. Haynes Johnson stated that he is a reporter for the Washington, D. C. Star and that while in New York, New York he is residing at the Plaza Hotel.

On the night of June 4 - 5, 1968 he was at the Ambassador Hotel, Los Angeles, California covering the Presidential campaign of Senator Robert Kennedy. Johnson had a bungalow in back of the hotel and was in the bungalow during Senator Kennedy's speech and observed the speech there on television. He wrote his story there and when he delivered it to the press room he learned of the shooting of Senator Kennedy. Senator Kennedy had been taken to a hospital and he did not see Senator Kennedy, the shooting, or Sirhan Sirhan.

JOSEPH KRAFT, 3021 N Street, N. W., furnished the following information:

KRAFT is a reporter for the Hall Syndicate with his base of operations in Washington, D. C. KRAFT covered the Oregon and California Primary elections. In Oregon he was with KENNEDY the entire time and in California he divided his time between KENNEDY and MC CARTHY.

On election day KRAFT also split his time between KENNEDY and MC CARTHY. Between 10:00 and 12:00 p.m. election night KRAFT was at the Ambassador Hotel with KENNEDY in his upstairs hotel suite. When KENNEDY came down to give his victory speech, KRAFT listened to the speech in the Embassy Room. When KENNEDY left the podium and went into the kitchen area, KRAFT headed for the regular exit of the room. Before he left the room he heard shouts but no shots. He was then told that KENNEDY had been shot. KRAFT did not see KENNEDY after KENNEDY left the podium.

KRAFT does not recollect ever having seen SIRHAN at any time during the Oregon or California primary or at the Ambassador Hotel election night. While in Los Angeles, KRAFT stayed at the Beverly Wilshire Hotel. Mrs. KRAFT, KRAFT's wife, was in California during the early part of the campaign but she left California before the election and was in Washington, D. C., at the time KENNEDY was shot.

During Senator Kennedy's speech, Newfield was upstairs in a room in the hotel. At the conclusion of Senator Kennedy's speech, Newfield got on an elevator to go downstairs to join Senator Kennedy's group. While he was on the elevator, Senator Kennedy was shot. Newfield did not see or hear the shooting. He did not see Sirhan Sirhan.

Wainwright did not see or hear the shooting and did not see Sirhan Sirhan. He knows nothing to the shooting.

At the moment of the shooting of Senator ROBERT KENNEDY in the Ambassador Hotel in Los Angeles, California he was behind the Podium. Upon hearing the shots he headed toward the sound of the shots. He did not observe the shooting. Upon reaching the area of the shooting he observed a number of people grappling with SIRHAN SIRHAN. He had never observed SIRHAN SIRHAN prior to this time. He observed SIRHAN SIRHAN being hustled out of the hotel by the police.

JAMES CHARLES BAILEY, 260 South 156th Street, Apartment 36, Seattle, Washington, was interviewed at his place of employment, Snelling and Snelling Employment Service, 144 S.W. 153rd Street, Seattle, regarding his possible knowledge of the conspiracy upon the life of the late Senator ROBERT F. KENNEDY. BAILEY advised as follows:

He was a volunteer campaign worker for Senator KENNEDY and worked in the Portland, Oregon, office starting about one month before the Oregon primary elections. He worked in a liaison capacity between the campaign headquarters and the different celebrities who would come to town to give campaign speeches. After the Oregon primaries, he went to Los Angeles, California, to help with the California primaries.

While in Los Angeles, he lived in a motel across the street from the Ford Motor Assembly Plant in East Los Angeles. About 25 campaign workers were staying in the motel.

On the evening of June 45, 1968, he went to the Ambassador Hotel for the victory celebration held in the Embassy Ballroom. He was standing near to and was talking with Mrs. SARGEANT SHRIVER and her body guards at the time it was announced that there had been an accident. He then learned that KENNEDY had been shot.

BAILEY affirms that he has never seen or known SIRHAN BISHARA SIRHAN.

During the day he was not allowed to work and, therefore, he stayed at the motel and went swimming and visited with other campaign workers. The night of the shooting, he stayed at the Ambassador Hotel in a room on the third floor which had been set aside by an unknown person for the campaign workers.

She was in the Embassy Ballroom of the Ambassador Hotel at the approximate time when the Senator was assassinated. She recalls hearing only some noise and a lot of confusion after the noise. She was later told that the noise she probably heard was the sound of shots but she could not identify them as such. In the confusion she did not see the individual involved nor any of the events as they took place.

She is presently employed as a secretary at Glore, Forgan and Staats, Stockbrokers, 221 Montgomery Street, San Francisco.

CECY DOUCET, Martha Washington Apartments, 1802 S.W. 10th Avenue, Portland, Oregon, stated that she is employed at the Standard Plaza Building, 1100 S.W. 6th Avenue, Portland, Oregon, in Room 902. She stated she was in the Embassy Room of the hotel at the time Senator KENNEDY was assaulted. She did not see the shooting as the shooting occurred in a corridor outside the Embassy Room. When she heard the shots, she thought that it was balloons popping and that the yelling and excitement in the corridor came as a result of the people viewing Senator KENNEDY as he was considered quite a celebrity at the hotel. She said that she did not see SIRHAN BISHARA SIRHAN at anytime, either prior to the assassination or after the Senator had been shot. She said she had no knowledge of a conspiracy upon the life of the Senator and that the only knowledge she currently has of the assault came from what she heard on the news media. She did not witness any unusual activity around the hotel during the day before the assault took place and she noted that she had not slept for five days prior to the assault due to the pace of the campaign.

She stated that the following individuals, to her knowledge, were also present at the time the assassination took place:

WILLIS FRANKLIN EDWARDS, ASN US 56729416, Company D, 8th Battalion, Third AIT Brigade, Fort Gordon, Georgia, was interviewed regarding the assassination of Senator ROBERT KENNEDY. He advised the following:

He received a letter from California State Senator JESSE UNRUH, thanking him for supporting KENNEDY in his campaign and suggested that EDWARDS contact the Los Angeles Police Department. EDWARDS advised that he then wrote the Los Angeles Police Department and informed them that he was present during the KENNEDY assassination.

EDWARDS advised that he worked actively in the KENNEDY campaign in California and was present with approximately 1,000 other people in the room of the Ambassador Hotel where Senator KENNEDY was killed. He advised that he was standing approximately seven to ten people away from the alleged assassin and he was in a direct line with the assassin and Senator KENNEDY looking directly at the back of KENNEDY's head when KENNEDY fell. He advised that he first became aware that something unusual was going on when he heard shots ring out and heard people screaming. He stated that he saw ROOSEVELT GRIER and RAFAEL JOHNSON grab a man and take the gun from the man's hand. He stated that this man was the same man whose photograph later appeared in newspapers. He advised that he had seen this alleged assassin two or three hours before the shooting in a corridor leading to the room where KENNEDY was assassinated. He advised at that time he had done a double take when he had seen the man. He does not know why he paid particular attention to this individual inasmuch as he was not dressed any different from the people in the hotel. He stated that something unusual about the man's appearance caused him to take a second look. He advised that as best he can remember the man was by himself at the time and that he does not recall ever seeing this individual before that night.

EDWARDS advised that the memory of the assassination has caused him nightmares and that he has considered consulting a psychiatrist regarding his condition. He was visibly affected during the interview and became emotional, rambling in his conversation, expounding on the causes of Senator KENNEDY and MARTIN LUTHER KING.

DOROTHY HARTIGAN, who resides at 190-05 Hillside Avenue, Hollis, Queens, New York, advised that she was associated with the New York advertising agency of Papert, Lois and Koenig, and was in the Embassy Ballroom of the Ambassador Hotel in Los Angeles, California, the night Senator ROBERT F. KENNEDY was murdered. Miss HARTIGAN advised that she was to the right of the podium at the time of the speech and after the departure of Senator KENNEDY she was moved further to the right of the podium by the crowd. She stated that on that night she observed SIRHAN B. SIRHAN while he was being taken away by the police and when she saw him she was sure that she had never seen him before and specifically not earlier in the evening at the Ambassador Hotel.

DAVID HODGES, 235 25th Street, Hermosa Beach, (telephone 372-2832), was interviewed at this location and furnished the following information:

He is presently unemployed, being confined in a wheel chair as a result of an injury to his back from a car accident approximately five months ago.

HODGES, his girl friend, JAIET LOWRIE, 704 Manhattan Avenue, Manhattan Beach, and DEKKER and SARON RAWLINGS, 424 35th Street, Manhattan Beach, arrived at the Embassy Room of the Ambassador Hotel, Los Angeles, at approximately 7:45 PM, June 4, 1968, after driving to that location in an automobile owned by HODGES. Shortly after arriving at the hotel, HODGES and the others met his two brothers, WILLIAM and ROBERT HODGES, and CAROL FENBURY, 2215 Strand, Manhattan Beach, a girl friend of WILLIAM HODGES. These latter individuals drove to the hotel in a vehicle owned by WILLIAM HODGES.

From approximately 7:45 until 11:45 PM HODGES and the others remained together in the Embassy Room a short distance from the entrance through which Senator ROBERT F. KENNEDY was expected to enter the Embassy Room. Leaving the hotel from 11:30 to 11:45 PM, HODGES and the others in his car heard about the shooting on the car radio as they were proceeding back to Manhattan Beach.

Photographs of SIRHAN BISHARA SIRHAN were exhibited to HODGES. HODGES, after viewing these photographs, advised that he did not observe anyone resembling this individual at the Ambassador Hotel on the evening of June 4, 1968.

HODGES recalled that several days after the shooting of Senator KENNEDY, his brother, WILLIAM HODGES, mentioned that he observed a shabbily dressed individual loitering in the Embassy Room on June 4, 1968. HODGES, however, does not recall observing anyone fitting the description of this individual observed by his brother.

ROBERT R. HODGES, 543 - 21st Street, Hermosa Beach, California (545-5206), was interviewed at the residence of his brothers, WILLIAM HODGES, 235 - 25th Street, Hermosa Beach, and furnished the following information:

On the evening of June 4, 1968, he accompanied his brother, WILLIAM HODGES, and CAROL FENBURY, 2215 Strand, Manhattan Beach, girl friend of WILLIAM HODGES, to the Embassy Room of the Ambassador Hotel, 3400 Wilshire Boulevard, Los Angeles, to attend a reception for Senator ROBERT F. KENNEDY. HODGES and the others arrived at the hotel between 7:30 and 7:45 P.M., and shortly thereafter met his brother DAVID HODGES, 235 - 25th Street, Hermosa Beach, JANET LOURIE, 704 Manhattan Avenue, Manhattan Beach, and DEKKER and SHARON RAFLINGS, 424 - 35th Street, Manhattan Beach.

From the time that they arrived at the hotel until approximately 11:45 P.M. when they left this location, HODGES and the others remained together in the Embassy Room at a point near the entrance from which Senator KENNEDY was expected to enter the room.

HODGES was shown photographs of SIRHAN BISHARA SIRHAN and, after viewing these photographs, he could not recall observing anyone at the Ambassador Hotel on June 4, 1968, or anywhere else prior to that date resembling this individual.

HODGES, his brother, WILLIAM HODGES, and CAROL FENBURY left the hotel at approximately 11:45 P.M. and later heard of the shooting of Senator KENNEDY on the car radio as they were proceeding back to Manhattan Beach.

Mr. GILMAN KRAFT in response to attempts to contact him personally, December 12, 1968, phoned on December 13, 1968, and advised the following:

Mr. KRAFT is associated with, "Performing Arts", a theatrical program publication, 1915 Beverly Boulevard, Los Angeles, telephone 336-3791. He resides at 401 St. Cloud Road, Bel Air, California, telephone 467-4755.

Mr. KRAFT said at the time of the assassination of Senator ROBERT F. KENNEDY, he was in the lobby outside the Embassy Room at the Ambassador Hotel in Los Angeles and had not observed the shooting of Senator KENNEDY or any of the immediate aftermath in the vicinity of the shooting. Mr. KRAFT first became aware that something unusual had occurred when he observed persons who appeared to be excited and distraught running into the lobby from the Embassy Room. His attention was particularly drawn to a young man who was running and who hurdled a couch. This person was a male caucasian in his early 20s, about 6'2" in height, long blond hair and fair complexion, dressed in a casual shirt and slacks. Mr. KRAFT said he had reported this observation to the Los Angeles Police Department at the time. After learning what had occurred with respect to the assassination of Senator KENNEDY, Mr. KRAFT said that he had no reason to believe that the young man who he had seen running in the lobby, described above, had anything to do with the assassination. The young man who appeared to be distraught and excited was not known to Mr. KRAFT and the latter said that he would be unable to identify this young man at this point.

Mr. KRAFT said he had no recollection of ever seeing SIRHAN SIRHAN and had never heard of him until he was charged with the shooting of Senator ROBERT F. KENNEDY.

Mrs. LEE advised that she was present at the Ambassador Hotel, 3400 West Wilshire Boulevard, Los Angeles, on the night of June 4, 1968. Mrs. LEE stated she spent some of the evening in or near the kitchen area of the hotel. She stated that she was in the Embassy Room of the hotel during Senator KENNEDY'S speech, but she left the room just prior to the end of the Senator's speech in order to get a drink of water.

Mrs. LEE advised that she was returning to the Embassy Room by way of the kitchen when she heard shots. She stated that she knew PAUL SCHRADER and she saw him fall as the shots rang out. Mrs. LEE advised that she saw a group of people taking a gun from the hand of a person later identified as SIRHAN B. SIRHAN. She stated that as SIRHAN was being escorted from the area she attempted to strike him with her purse.

Mrs. LEE advised she could positively identify SIRHAN B. SIRHAN as being the person from whom a gun was taken soon after the shots were fired.

Mrs. LEE stated she was close enough to the shooting to observe Senator KENNEDY on the floor, and she thought that the Senator was dead.

On November 27, 1968, KATHY TAYLOR, 26 S.E. 71st Street, Portland, Oregon, stated that she was with the Senator ROBERT F. KENNEDY Campaign as a "Kennedy Girl," and is now employed by Meier and Frank Company in Portland.

She said she joined the campaign in April of 1968, when the Senator came to Oregon with his campaign, and almost constant companion with her during the campaign was CECI DOUCET, Martha Washington Apartments, 1802 S.W. 10th, Portland, Oregon. She and CECI remained with the campaign until the day after Senator KENNEDY was assassinated, they then returned to Portland, Oregon.

She said she did not know SIRHAN BISHARA SIRHAN, and did not see him at the hotel on the night of June 4, 1968. She was not aware of a conspiracy upon the life of Senator ROBERT F. KENNEDY and has not heard of one since the assassination took place.

She said the afternoon before the assassination she was filling balloons with helium in the Embassy Room of the hotel, and placing them around the speaker's podium in preparation for the speech that night. It was during this time that she had occasion to notice any strange activity at all. She said a dark skinned man, not SIRHAN, who was about 5'7" tall, stocky build, dark brown hair, wearing a white hat similar to a chef's hat, and a white waiter's style coat, made several trips into the Embassy Room. She felt this man was employed by the hotel. This man did not say a word while in the room even though she spoke a greeting to him on at least two occasions. Since he did not return her greeting she assumed that he did not speak English. She saw this man only in the afternoon and could not furnish a better description. The man seemed very inquisitive during his trips into the room even though he did not speak.

She said she was in the Embassy Room when Senator ROBERT F. KENNEDY was shot in the corridor outside. When

It is noted that the Mr. AOYAMA interviewed subsequently has the first name of AKIRA, but since he is obviously the individual referred to above as M. AOYAMA, apparently there was a mistake made by the individual registering him at the hotel initially.

A United States intelligence agency which conducts investigations abroad advised that on October 10, 1968, AKIRA AOYAMA, Chief, Planning Division, Misshin Hodo KK, #3, 2-chome, Nihonbashi-Kaomi-cho, Chuo-ku, Tokyo, Japan, was interviewed and stated that he, along with MORINAGA and HIRANO, arrived at the Ambassador Hotel, Los Angeles, California, at approximately 2340 hours on June 4, 1968. They checked in at the front desk and went directly to their separate rooms. He AOYAMA stayed in his room for only a few minutes and went to HIRANO's room where the three (HIRANO, MORINAGA and AOYAMA)

met to discuss their plans for the following day. After that discussion, interviewee returned to his room where he stayed for a few minutes, then went downstairs to the lobby. There he found everything in a state of confusion. He did not understand what was taking place because he did not understand English. The next day Mr. MORINAGA, who understands English, told him what had happened, and said that he (MORINAGA) had watched television in his room after the aforementioned meeting had been completed and the others had departed.

AOYAMA was unable to provide any information regarding the assassination of Senator KENNEDY. AOYAMA denied that he had ever seen SIRHAN and said he knew nothing about him. AOYAMA advised that Mr. HIRANO recently had an eye operation and was recovering in the Hagiwara Hospital, Tokyo, Japan.

The source advised that on October 14, 1968, HIROSHI HIRANO, Vice President, Nisshin Hodo KK, was interviewed and related substantially the same information as that provided by AOYAMA. HIRANO said he did not know SIRHAN and denied that he had ever seen him. He was unable to provide any information pertinent to the assassination of Senator Robert F. Kennedy.

The source advised that on October 24, 1968, TAMETAKA MORINAGA, Chief, President's Office Staff, Nisshin-seito KK, was interviewed and related substantially the same information as that provided by AOYAMA and HIRANO. He said that he did not know SIRHAN and denied that he had ever seen him. MORINAGA was unable to provide any information pertinent to the assassination of Senator Kennedy.

STEWART BLOCK was interviewed at his office at United Methodist Church, 100 Maryland Avenue, N. E., Washington, D. C., concerning the assassination of Senator ROBERT F. KENNEDY, and stated the following information:

He was present in the Embassy Ballroom June 5, 1968, at the time of KENNEDY'S assassination, in connection with the United Methodist Church's Vietnam Education Project. Standing in the anteroom watching the television monitor, he heard three gun shots which sounded like breaking glass. Soon after hearing the shots he was approached by a heavy-set, middle-aged male who told him that KENNEDY had been shot. BLOCK thought this was peculiar since the man appeared to be calm and had a smile on his face, while others in the ballroom were confused or hysterical. The man quickly departed the ballroom through the back door which led into a lot containing television equipment. He described the heavy-set man as follows:

Age:	Early 30's
Height:	5 feet 9 inches to 5 feet 10 inches
Weight:	210 to 225
Build:	Stout-heavy
Hair:	Curly; sand brown
Dress:	Open collar brown plaid shirt not entirely stuffed into his trousers

It was opined that the above individual could have had time to personally witness the assassination before confronting BLOCK with the news.

Dr. PHILLIP D. BONNET, Professor in the School of Hygiene and Health, Johns Hopkins University (JHU), Baltimore, Maryland, advised that on June 4, 1968 at approximately 8:30 P.M., Los Angeles time, he registered at the Ambassador Hotel in Los Angeles. He stated that this reservation was made by the American College of Hospital Administration, San Francisco, California and that he had gone to Los Angeles to attend a seminar on a hospital administration which began on June 3, 1968 and continued through June 6, 1968. Upon arrival at the Ambassador Hotel, he discovered that in addition to the seminar on hospital administration there were several other conventions and political meetings being held.

After checking into the hotel, Dr. BONNET had his dinner in the hotel and went to his room where he retired at approximately 10:30 P.M. Around 12:30 or 1 A.M. on June 5, 1968 he was awakened by someone knocking at his door and upon checking, found out that it was someone who had the wrong room. He stated that he then went back to sleep and when he awakened the next morning, he heard over his television that Senator ROBERT KENNEDY had been assassinated in the hotel. He stated that he did not see Senator KENNEDY upon his arrival at the hotel and upon viewing the photograph of SIRHAN SIRHAN he stated that he did not see anyone who resembled this picture.

Dr. BONNET stated that he has no information regarding the shooting of Senator KENNEDY and that it was quite a shock to him when he heard of it on the morning of June 5, 1968. He further stated that he had no information concerning any possible conspiracy in the shooting of Senator KENNEDY.

ROBERT BRADFORD, 8047 South Constance, Chicago, Illinois, advised that he and his family were in the Ambassador Hotel, Los Angeles, California, on the night of June 4, 1968.

BRADFORD advised that he and his wife were in the Embassy Room when Senator KENNEDY held his victory rally. He advised that after Senator KENNEDY had made his comments, he left the room, at which time shortly thereafter, he heard a commotion in the direction that KENNEDY had left. Mr. BRADFORD advised he did not realize what had happened until people began coming back into the room from the kitchen area screaming that the Senator had been shot.

BRADFORD advised that he had not seen SIRHAN SIRHAN in the hotel at any time. He advised he had heard nothing regarding a conspiracy to kill the Senator while in the hotel. BRADFORD advised that he and his family had come to California on a vacation, and this was his first time in the State.
