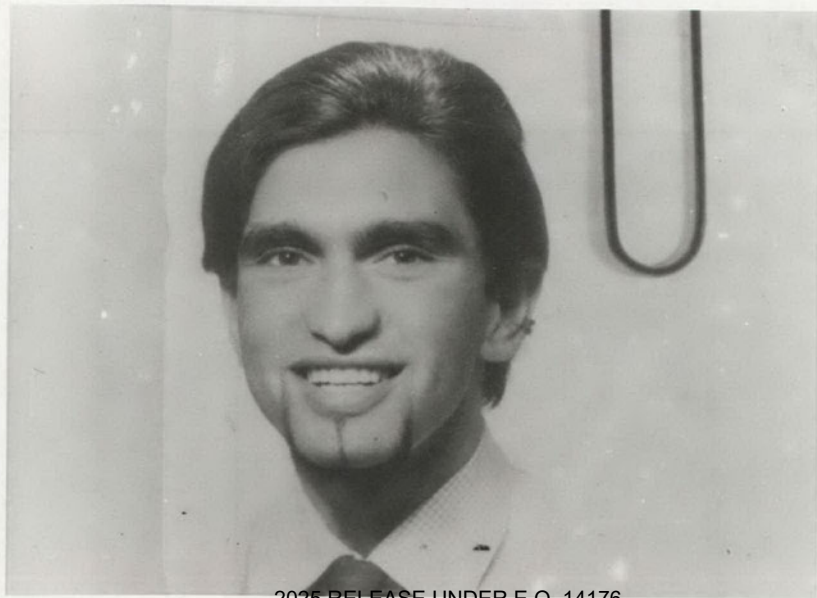

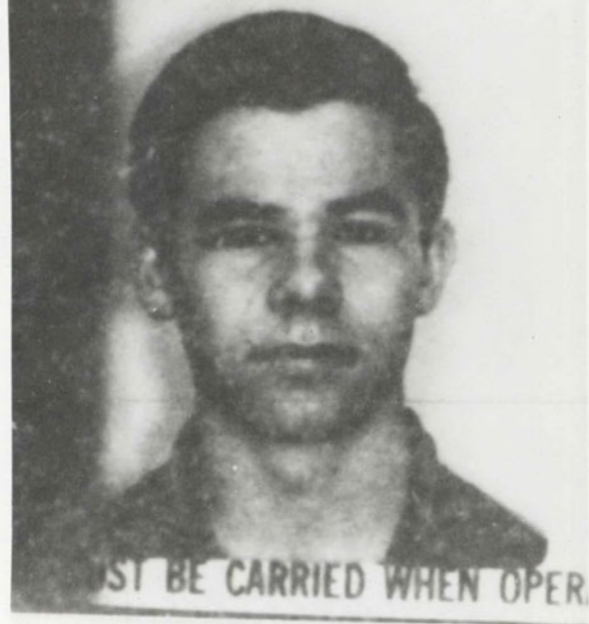

LEE PERRY, who is presently residing with his mother-in-law, Mrs. VENIE HENSLEY, 1826 Pullman Street, Richmond, Calif., telephone BE 4-2944, and who is presently employed as a driver by the Greyhound Bus Co., advised the writer the following information:

PERRY stated that he has observed the picture on television of the individual presently in custody in Los Angeles reportedly responsible for the attempted assassination of Senator KENNEDY and believes that this individual strongly resembles an individual who has been a passenger on his bus several times in the past as a passenger from San Francisco to Marin County. He said he has picked a man up at Van Ness and Lombard Streets in San Francisco on several occasions in the recent past and that this man rode the bus to Seminary Drive, located in Marin County and just across Highway 101 from Sabella's Restaurant. He said after the man left the bus, he has no information as to where this man went. Mr. PERRY said he does not know the man's name and has no information concerning his employment or address. He said however the individual, because of his manner of dress, gave him the impression that he possibly could have been employed in a kitchen, possibly at the Sabella's Restaurant.

Inspector GERALD SOUZA, Police Department, San Rafael, Calif., advised today that he received a telephone call from Mr. HERB SAXTON, a contactor in San Rafael, residing at 95 Lisbon Street, telephone 453-2292. He said Mr. SAXTON informed him he has observed the photo on television of the individual reportedly responsible for the attempted assassination of Senator ROBERT KENNEDY and said this individual strongly resembles one RONALD CRAIG HUNTER, who formerly worked for him. He said HUNTER also, at one time, worked for the Firestone Tire Co. in San Rafael. SOUZA said SAXTON told him that HUNTER has been arrested in Marin County.

SOUZA stated he has in his possession a photo of RONALD CRAIG HUNTER, FBI No. 125 023 F, CII No. 3004567. He said he has shown the photo of HUNTER to several individuals at the police department who have seen the photo of the individual in custody in LA believed to be responsible for the assassination attempt, and that all of them have stated HUNTER closely resembles the picture they have seen on television. SOUZA said HUNTER has Marin Co. SO No. 29856 and that he was able to obtain the following fingerprint classification of HUNTER:

The following information was obtained at the Marin County SO, San Rafael, Calif., on 6/5/68:

"At 4:25 a.m., 6/5/68, received a telephone call from Investigator EVANS, Los Angeles PD, requesting we contact Mrs. ROBERT F. DANA WESTLAKE, 349 Redwood Road, Woodacre, Calif., telephone 454-3202, in reference to a revolver used in the attempted assassination of Senator ROBERT F. KENNEDY.

"Investigator EVANS stated that the weapon had been purchased by a Mrs. WESTLAKE's father, ALBERT L. HURT, and that he had given the weapon to Mrs. WESTLAKE prior to their moving to this area.

"At 5:10 a.m., 6/5/68, Mrs. DANA T. WESTLAKE, DOB 9/5/32, was contacted at her home 349 Redwood Road, Woodacre, Calif. Mrs. WESTLAKE stated that her father had purchased a revolver on or about the time of the Watts Riot. Her mother had later given it to her. She described the weapon as being a .22 caliber, sub-nose revolver, black in color. No serial number available. Mrs. WESTLAKE related that in the latter part of November or the first part of December, 1967, she had given the weapon to GEORGE CHARLES "CHICK" ERHARD, III, 18 years old, 1978 Olive Way, Pasadena, Calif., 798-3957. She described "CHICK" as being a nice quiet young man from a good family. who have been long-time family friends.

"At 7:48 a.m., this information was relayed to Investigator EVANS via telephone."

Inspector KEN IRVING, Marin County SO, advised the writer on 6/5/68, that he had personally interviewed Mrs. WESTLAKE. Mrs. WESTLAKE advised him the picture being shown on TV of the individual reportedly responsible for the attempted assassination is not that of "CHICK" ERHARD. She further stated that the .22 caliber wapon involved was never brought to Marin County by her but was given by her personally to ERHARD prior to her moving from Pasadena, Calif. Woodacre, Calif.

Phone call received this date from WILLIAM R. PINE, 17340 Keaton Avenue, Fedder Springs, California, who is employed at the Doughnut Shop, 17790 Sonoma Highway in Boyes Springs.

PINE stated that the photo's he has seen on TV of KENNEDY's assassin closely resemble JIMMY "RED" O'CONNOR, whom he knew in Ukiah in 1955. JIMMY was an Argentinian whose mother married a lumberman named O'CONNOR. He described O'CONNOR as 27 or 28 years old, 5'8" or 5'9", 135 to 145 lbs.

At 8:15 A.M. this date, Mrs. DANIEL JOHNSON, 12100 Natoma Court, Saratoga, Calif., telephone 257-2114, called SA ERVIN THIBAUT, JR. at the San Jose RA. Mrs. JOHNSON advised that she and her two daughters, PATRICIA, age 16 and CHRISTINE, age 18, were looking at a TV account of the shooting of Senator ROBERT KENNEDY in Los Angeles, this date. They had an opportunity to view the suspect in this shooting and both PATRICIA and CHRISTINE stated that the young man allegedly responsible for the shooting bears a striking resemblance to one JOHN JOHNSON (no relation), a 20 year old Senior at Fremont Union High School, Highway 9, Sunnyvale, California.

PATRICIA and CHRISTINE also advised that JOHN JOHNSON and his family reportedly left the Saratoga-Sunnyvale area on Wednesday or Thursday, 5/28-29/68 for the Los Angeles area. They vaguely recall that the JOHNSON family may have been going to Malibu.

SA THIBAUT proceeded to the DANIEL JOHNSON residence and discussed this matter with PATRICIA and CHRISTINE JOHNSON. He also exhibited to them a photograph of the suspect in this matter as appears on page 2 of the "San Francisco Chronicle" this date. Both girls stated the photograph in the newspaper looks like JOHN JOHNSON. They produced a Fremont High School year book which includes a photograph of JOHN JOHNSON and SA THIBAUT states the photograph in the year book bears a striking resemblance to the suspect.

SA THIBAUT is contacting RALPH KLING, Principal, Fremont Union High School, an established source of the San Jose RA, for background information and additional photographs of JOHN JOHNSON.

It should be noted that Mrs. DANIEL JOHNSON is employed at 100 O'Connor Drive, San Jose, telephone 286-1505.

On 6/5/68, Mrs. NORMA McDERMOTT, 2921 Taravel, #3, SF, 731-8636 phoned to advise that when Senator KENNEDY was to visit the GETS Shopping Center on Sloat Blvd., SF, she went there. While there noted a young man wearing a sweater, with dark complexion and who acted very nervous. She stood about 2 feet from him and noted that he was carrying maps of Los Angeles. He was more or less looking the buildings and area over. He left the area prior to the time the Senator arrived by taking a Sloat Blvd. bus. She had not seen the photos in the newspapers but this person did meet the description given on the radio.

On 6/5/68 phone call received from a woman who refused to furnish her name. However, they go to Reno quite often and probably sometime in March while at the Palace Club, she overheard a conversation between a young man and his family who hated Negroes and who had attempted to purchase a gun at Harrold's Club. They had refused to sell him a gun because they were about to close and did not have time to complete the sale. This young man appeared to be Cuban or Mexican. There were 4 or 5 members in this particular family.

On 6/5/68, FRED CANNON, Calif. Blue Shield phoned. He is acquainted with former SAC WHELAN. Night before last he was at the Tudor Room, Sheraton-Wilshire Hotel, the Negro bartender said he had been asked to serve at the victory reception for Senator KENNEDY and added that he hoped that he didn't get shot at.

On 6/5/68 DAVID OVERHOLT STEVENS, Stanford University Senior History Student, Stern Hall, Stanford University, telephone number 327-6244; home address 1165 Banyon Street, Pasadena, California, appeared at the Palo Alto Resident Agency and furnished the following information concerning SIRHAN SIRHAN who is alleged to have attempted the assassination of Senator ROBERT F. KENNEDY.

STEVENS advised that he was casually acquainted with SIRHAN at John Muir High School, Pasadena, Calif., during the school year 1962-1963 when SIRHAN was a Junior and SIRHAN was a Senior. STEVENS described SIRHAN as a Palestinian Arab believed to have been born in Palestine or some other Arab country. STEVENS recalls that SIRHAN was at that time bitterly opposed to and hated Jews, particularly Zionists. STEVENS said SIRHAN listened to Radio Havana and he believed SIRHAN to be pro-Castro at that time. STEVENS said he is not aware of any organizational affiliations on the part of SIRHAN and has the impression that SIRHAN was not a Communist at that time. STEVENS said he has not seen SIRHAN since 1963 and added that he is not acquainted with any member of SIRHAN's family.

STEVENS advised that THOMAS D. GOOD, age about 23, was a close friend of SIRHAN in high school and may be able to add some light on SIRHAN's political views or a possible motive for the attempted assassination of KENNEDY. STEVENS said it is his recollection that GOOD resides on the 1300 block of Elizabeth Street, east of Lake Avenue and just off Hill Avenue, Pasadena, California. He recalled that GOOD had an unlisted telephone number in Pasadena. He also advised that GOOD reportedly graduated from San Jose State College, San Jose, California, in 1967.

SA TOM WESTON, San Jose RA, advised that the aforementioned THOMAS D. GOOD is probably identical with the subject of 100-56267.

On 6/5/68, the writer was in contact with Mrs. PAUL R. AMBROSE, 1617 Cavallo Road, Apartment C, Antioch, California, telephone 757-3522. Mrs. AMBROSE, who stated that she is the Vice-Chairman for the Kennedy For President Campaign in the Antioch area, advised that on 5/18/67, she and her husband had been seated at an unrecalled bar, Antioch, California, at which time an individual whom she believes possibly identical with the Subject responsible for shooting KENNEDY, entered the bar. This person was selling rugs, carpeting material, leather goods, and silk bedspreads. Much of the goods were reportedly from Arabia or Israel. She recalled purchasing a silk bedspread for \$6.00 and paying this individual by check drawn on the Security National Bank of Antioch, payable to cash.

She stated that the endorsement on the check was in Arabic and was illegible to her. She related that this individual was only described as of Arabic or similiar nationality, 23 to 26 years of age, 5' 9", olive complexion, black hair, with lower lip being larger than upper lip, and driving a white station wagon.

Mrs. AMBROSE stated that upon seeing the films of the apprehension of the Subject and the short observation of the Subject being arrested therein, she believed that she recalled this person as being identical or a look-a-like with the person described above whose identity is not known to her. She stated she was only reporting this to help in any way possible and had no additional information. She stated she would retain the check if it was required sometime in the future.

Mrs. AMBROSE was advised that this matter would be made a matter of record and given appropriate attention by this office.

At 2:25 P.M., 6/5/68, PATTY JOHNSON, 2351 Westwood Court, Apartment E-1, Arcata, California, employed Humboldt State College President's Office, Arcata, phone 822-0286, advised that from radio and television reports she recognized SIRHAN SIRHAN as a boy she attended school with at Pasadena from about 1963 to 1965, either at Pasadena City College or John Muir High School. She did not know anything personally about him except that it seemed to her that he kept to himself. She did not know what grades he received in classes, political feelings, or any other personal information. He said she only furnished this because she thought it might be helpful because she was shocked at the assassination attempt by someone who she has known slightly as a schoolmate in the past. She had no information on his background, family, residence, or other items of pertinence.

JOHN HERBERT REES, NATIONAL GOALS, INC., TEN HILL ST., NEWARK, NJ, WITH WHOM CONTACT HAS BEEN INSUFFICIENT TO DETERMINE RELIABILITY, ON JUNE FIVE INSTANT, TELEPHONICALLY ADVISED THAT THE SAN FRANCISCO EXPRESS TIMES, DESCRIBED BY REES AS AN UNDERGROUND NEWSPAPER, IN ITS MAY TWENTY THREE, NINETEEN SIXTY EIGHT ISSUE ON PAGE THREE, CARRIED AN ARTICLE WHICH IN THE OPINION OF REES PREDICTED THE EARLY ASSASSINATION OF SENATOR ROBERT F. KENNEDY. REES FURTHER ADVISED THAT THE ARTICLE INTIMATED THAT A MEXICAN-AMERICAN WOULD BE INVOLVED.
