Scope and Content

The materials in this series are a selective, not necessarily all-inclusive, body of documents responsive to the topic of FOIA request 2014-0030-F.

This series contains records related to the second meeting of the Gore-Chernomyrdin Commission (GCC) held in December 1993 in Moscow. The Gore-Chernomyrdin Commission formally known as the U.S. – Russian Joint Commission on Economic and Technological Cooperation was a collaborative effort established by President Bill Clinton and Russian President Boris Yelstin after their April 1993 summit meeting in Vancouver, Canada to increase cooperation in space, energy, business development, defense conversion, the environment, science and technology, health, and agriculture. Vice President Al Gore and Russian Prime Minister Victor Chernomyrdin were appointed and served as co-chairmen and the Commission derives its name from both individuals.

These materials consist of a trip book detailing Vice President Gore's travel to Frankfurt, Germany, Almaty, Kazakhstan, Bishkek, Kyrgyzstan, Moscow, Russia, and St. Petersburg, Russia from December 11-18, 1993. There are also remarks made by Vice President Gore during the signing ceremony along with a summary of results from the meeting, and copies of signed agreements and statements pertaining to five areas: space cooperation, trade and business development, defense conversion, science and technology, and energy, nuclear safety, and environment. Additional materials consist of White House press releases which describe the progress and efforts of the Gore-Chernomyrdin Commission as well as a transcript from a press conference held in Almaty, Kyrgyzstan, and data on activities in support of the Gore-Chernomyrdin process. The inclusive date range for this series of records is 1993 to 1994.

Due to national security restrictions, about half of this collection remains closed including memoranda of conversation, talking points, and committee reports and papers.

System of Arrangement

Records responsive to this FOIA request were found in the Gore Vice Presidential Records: White House Staff Member and Office Files.

Staff Member and Office Files are the textual records created and/or maintained by White House staff members within their individual offices. These files document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, and the documents within are maintained in their original order. Since the files are processed at the folder level, individual documents contained within these folders may not be wholly responsive to the subject area of this FOIA request.
