Scope and Content

The materials in this series are a selective, not necessarily all-inclusive, body of documents responsive to the topic of FOIA request 2014-0048-F.

This series contains records related to the fourth meeting of the Gore-Chernomyrdin Commission (GCC) held December 14-16, 1994 in Moscow, Russia. The Gore-Chernomyrdin Commission formally known as the U.S. – Russian Joint Commission on Economic and Technological Cooperation was a collaborative effort established by President Bill Clinton and Russian President Boris Yeltsin after their April 1993 summit meeting in Vancouver, Canada to increase cooperation in space, energy, business development, defense conversion, the environment, science and technology, health, and agriculture. Vice President Al Gore and Russian Prime Minister Victor Chernomyrdin were appointed and served as co-chairmen and the Commission derives its name from both individuals.

These materials consist of preparatory and advisory materials in the form of correspondence, lists, schedules, fact sheets, notes, reports, coversheets, unclassified cables and memoranda, GCC committee-generated scope and issue papers, photocopied news articles, Vice President Gore's opening remarks for the fourth commission meeting and remarks to the American Embassy staff, White House press releases which describe the progress and efforts of the Gore-Chernomyrdin Commission as well as copies of agreements and statements signed by Vice President Gore, Prime Minister Chernomyrdin, and Committee Chairs. There are also status reports for Defense Conversion Initiatives and Business Development programs along with talking points for and a memorandum of conversation from the preparatory meeting between Vice President Gore and the American Committee Chairs in advance of the commission meeting. Other materials included in this series document the administrative preparations for the arrival of Vice President Gore and the arrangements for a public, commission-related event. The inclusive date range of these records is 1994.

Due to national security restrictions, approximately half of this material remains closed, including memoranda, cables, talking points, and committee papers.

System of Arrangement

Records responsive to this FOIA request were found in Gore Vice Presidential Records: White House Staff Member and Office Files.

Staff Member and Office Files are the textual records created and/or maintained by White House staff members within their individual offices. These files document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, and the documents within are maintained in their original order. Since the files are processed at the folder level, individual documents contained within these folders may not be wholly responsive to the subject area of this FOIA request.
