#### Access

Collection is open to all researchers. ### **Provenance**

### **Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2016-0090-F.

This series consists of briefing materials and reports for Vice President Cheney and his staff related to a nuclear reactor in Syria. Nearly all of the records responsive to this FOIA case are currently closed to research due to national security restrictions. The records responsive to this request that contain no national security information and/or advisory information include tab dividers and cover sheets. There is one information memoranda addressed to President Bush from Special Assistant to the President Judith Ansley regarding a June 17, 2007 meeting.

### **System of Arrangement**

Records responsive to this FOIA request were found in Cheney Vice Presidential Records: White House Staff Member and Office Files. Responsive records were also found in the Cheney Vice Presidential Electronic Records collection.

Staff Member and Office Files are the textual records created and/or maintained by White House staff members within their individual offices. These files document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, and the documents within are maintained in their original order. Since the files are processed at the folder level, individual documents contained within these folders may not be wholly responsive to the subject area of this FOIA request.

Electronic records responsive to this request were maintained in a classified system during the George W. Bush Administration. The Classified Electronic Records collection includes email sent or received by the Office of the Vice President. Email messages are saved in indexes and search results are arranged chronologically by creation date. Access to these records is provided in paper.
