#### **Access**

**Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2017-0044-F.

This series consists of email messages with attachments which contain references to intelligence exchange agreements made with the governments of the United Kingdom, Canada, Australia, and/or New Zealand. Included in these records are administrative email messages from the National Security Affairs staff of Vice President Cheney, document distribution routing slips, and a United Kingdom government publication on preventing extremism. While the inclusive date range for this series of records is 1985 to 2008, the bulk of the materials are dated 2005 through 2008.

Most of the records responsive to this FOIA case are currently closed to research due to national security restrictions and restrictions regarding advisory materials.

**System of Arrangement**

Records responsive to this FOIA request were found in the Cheney Vice Presidential Electronic Records collection.

These electronic records were maintained in a classified system during the George W. Bush Administration. The Classified Electronic Records collection includes email sent or received by the Office of the Vice President. Email messages are saved in indexes and search results are arranged chronologically by creation date. Access to these records is provided in paper.
