#### **Extent**

4 folders, approximately 662 pages; 38 email messages and 18 electronic files

#### Access

Collection is open to all researchers. Access to Biden Vice Presidential records is governed by the Presidential Records Act, as amended (PRA) (44 USC 2201-2209) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore may be restricted in whole or in part in accordance with legal restrictions and exemptions.

#### **Provenance**

Official records of the Joseph Biden vice presidency are in the custody of the Archival Operations Division in Washington, DC and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act, as amended (PRA).

## **Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2022-0081-F.

This series consists of a cover sheet, daily schedules, email messages and electronic word processing files related to the events of October 20, 2012. The email messages pertain to posting and distributing the Weekend Guidance for the Vice President, official press releases from the Obama for America Press email account and emails with Vice President Biden's October 20, 2012 schedule attached. The electronic word processing file contains a copy of Vice President Biden's schedule for October 20, 2012.

The textual records processed for this FOIA request are from an Office of Scheduling and Operations binder containing final schedules for Vice President Biden within the timeframe of July 1, 2012 through October 31, 2012. This binder contains schedules for every date within this timeframe except Sunday October 14, 2012. The schedules document Vice President Biden's itinerary while in Washington D.C. and Wilmington, Delaware along with his travels to California, Colorado, Connecticut, Florida, Illinois, Iowa, Kentucky, Massachusetts, Michigan, Minnesota, Nevada, New Hampshire, New York, North Carolina, Ohio, Pennsylvania, South Carolina, South Dakota, Texas, Utah, Virginia, and Wisconsin.

#### **System of Arrangement**

Records responsive to this FOIA request were found in Biden Vice Presidential Electronic Records collection and in the Biden Vice Presidential Records White House Staff Member and Office Files.

The Biden Vice Presidential Electronic Records collection consists of email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The Staff Member and Office Files are the textual records created and/or maintained by White House staff members within their individual offices. These files document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, and the documents within are maintained in their original order. Since the files are processed at the folder level, individual documents contained within these folders may not be wholly responsive to the subject area of this FOIA request.
