**Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2022-0113-F.

This series consists of eight email messages sent to Vice President Biden's "robert.l.peters@pci.gov" email address from Marc Aidinoff, Sarah F. Berlenbach, Anne Marie (Person) Muldoon, and John S. Flynn which mention Antony (Tony) Blinken between January 24, 2015 and July 24, 2015. Materials include a list of voice messages left for Vice President Biden, draft statements, and advisory policy memos.

**System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2022-0113-F[18]:
