Scope and Content

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2022-0113-F.

This series consists of email messages from March 2011 through September 2011 that include communications to/from “robinware456@gmail.com” “JRBWare@gmail.com” and “Robert.L.Peters@pci.gov.” The emails include Vice President Biden’s daily schedules, call reminders, contact information for various associates, news articles, media appearances by Dr. Jill Biden, and speech drafts and transcripts for the Vice President’s remarks at various events.

System of Arrangement

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2022-0113-F [3]:
