Scope and Content

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2023-0042-F.

This series consist of email messages from January 2009 to December 2014. The records include email messages containing compilations of press coverage and photographs from Dr. Jill Biden's trip to Greece as head of the U.S. delegation to the 2011 Special Olympics Games, Vice President Biden's travel and work in May 2012, and Vice President Biden's trip to India and Singapore in July 2013. There are also emails related to Vice President Biden's trip to Tbilisi in July 2009 and travel day schedules from March and October 2010.

System of Arrangement

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2023-0042-F [1]:
