Scope and Content

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2023-0042-F.

The series consists of email messages from January 2009 to June 2016. The records include email messages from Vice President Joe Biden forwarding Washington Post and New York Times articles and a link to a White House blog post about April 2011 employment data. There is also an email containing an unsolicited invitation to an October 18, 2012 event honoring Sadguru Sant Pujya Kothari Swami and emails containing Vice President Biden's schedule cards for May and June 2016.

System of Arrangement

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2023-0042-F [2]:
