#### **Extent**

126 email messages

#### **Access**

## **Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2023-0042-F.

This series consists of email communications between or among Vice President Joe Biden and individuals associated with Rosemont Seneca in the second term of the Obama administration and the Lion Hall Group LLC for the entire administration. These records also include emails between Vice President Biden and Francis Person from June to December 2009. Many of the emails contain Vice President Biden's daily schedule, schedule cards, and updates on the timing of scheduled events as well as contact information for calls and events. Some of the emails forward links to articles from various news organizations including The Washington Post, the New York Times, and Forbes.

## **System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2023-0042-F [3]:

### **Biden Vice Presidential Records: Electronic Records**

#### **Exchange Email – Rosemont Seneca, 2013-01-01 to 2017-01-20**

This SRL contains 31 responsive email messages.
