Scope and Content

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2024-0017-F. This FOIA request consists of 10 email messages originally processed in response to the following FOIA case segments: 2022-0113-F-3, 2023-0042-F-5, and 2023-0042-F-6.

This series consists of email messages to or from Vice President Biden that mention the topics Extortion 17, Afghanistan, OBL, UBL, Osama bin Laden, Mahmoud Ahmadinejad, SEAL or ST6. The email messages dated May 8, 2011 through August 15, 2011, include transcripts of Vice President Biden's remarks and speeches that mention these topics, news articles from Fran Person to Vice President Biden regarding Afghanistan and Osama bin Laden, and a transcript of Antony Blinken's conference call with reporters discussing Vice President Biden's trip to Asia.

System of Arrangement

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2024-0017-F:
