**Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2024-0122-F.

This series consists of email messages sent from November 14, 2012 to January 11, 2017. Topics covered in this series of emails include daily news cards, transcripts of press briefings, press releases, statements, biographies of event attendees, administrative correspondence, and released remarks from the President at the presentation of the Medal of Honor.

**System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack H. Obama. These electronic records are born-digital files and are primarily .eml and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2024-0122-F:
