#### **Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2024-0130-F.

This series consists of email messages containing White House News Summaries from 77 specific dates between January 26, 2009 and January 3, 2017. The summary is included both in the body of each email and in the accompanying .doc electronic file. Included are email messages sent from Bulletin Intelligence or Bulletin News. This series does not include duplicate copies per specification of the original requester.

#### **System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily eml and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.
