Scope and Content

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2025-0002-F.

This series consists of email messages to or from Kendra Barkoff to select recipients, dated April 26, 2012 through August 30, 2015. The email messages include correspondence with colleagues in the Office of the Vice President regarding office activities and protocol, published news articles and press releases, draft social media posts, and a speaking invitation.

System of Arrangement

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml and .pdf files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.
