- 6. (Secret LLM) Talked with Mr. John Buckley, Administive Assistant to Congressman Fascell, so that the Congressman could be appropriately advised that we had completed our survey of the Richmond Naval Air Station; that we would be in touch shortly concerning the outcome and that our representative had not been able to meet with the University's vice president, who was away on leave. Mr. Buckley appreciated the call and asked if I would stop by to talk about another matter.
- 7. (Internal Use Only JSW) During the course of the day, I talked with William Darden, Russ Blandford (Phil Kelleher), Bill Woodruff, and Bob Michaels and discussed with each of them two topics. The first dealt with THE WASHINGTON POST item of this morning on page A7. They were informed that this was an Air Force matter and that if there were any questions they should be directed to the Air Force. The second matter concerned the Hans Tofte case. I briefed them in general on the story appearing in the Minneapolis press and the essence of the Agency press release. In addition to these topics, Mr. Woodruff and Mr. Darden had discussed possibility of budget briefings on Friday. They were both advised that this happened to be the one day that Mr. Helms was fully committed to long-standing obligations. They were appreciative and steered away from this day. There were three topics which Mr. Woodruff mentioned which would surely be brought up. (a) security review procedures for employees; (b) the overall intelligence budget; and (c) peripheral flights.
- 8. (Internal Use Only JSW) Talked to Miss Mary Ellen McFerren, in the office of Senator Jacob Javits, on the Colgan case and it was agreed that I would meet with her in a day or two to go over the case and the facts of the situation.
- 9. (Internal Use Only JSW) Herb Roback, Staff Administrator, Subcommitee on Military Operations of House Government Operations Committee, called stating he was writing a report on his trip to Vietnam and inquired whether he could use the names of Agency personnel he saw. I stated he should not use actual names but there was no objection to stating he met with CIA people.

(Internal Use Only JSW) James Gehrig, Staff Director, Senate Aeronautical and Space Sciences Committee, called stating he would like to be brought up to date on Soviet space matters and suggested he would be happy to come to the building. - Il. (Confidential JSW) Talked with John Jackson, in the office of Senator Leverett Saltonstall, He said the Senator was interested in whether we had any information on the Amelia Earhart case. He referred to recent news accounts and certain aspects of this. I said I would look into this and advise.
- 12. (Internal Use Only JSW) Arranged to have picked up from Austin Smith, CIA Appropriations Subcommittee staff, certain old transcripts and waste of hearings before that Subcommittee which are to be destroyed.
