Your June 23rd letter to President Reagan seeking information relating to the disappearance of Amelia Earhart has been forwarded to the FBI for response.

Because the FBI had no jurisdictional basis, we did not conduct an investigation into Ms. Earhart's disappearance. However, over the years, we have received inquiries concerning her and miscellaneous documents relating to her. If you are interested our Freedom of Information-Privacy Acts Section has 53 pages pertaining to this subject, which are available for duplication. The first 249 pages of documents are furnished to the requestor without cost.

Dear Mr. President:

First, Let me say that I am proud of our President and only wish that I could vote for you a third time.

I want to touch on a subject that has been on my mind a long time: "The Amelia Earhart Affair". July 2-1987 will mark 50 years, since the most remarkable Lady of all time, left us. I, for one, believe the time is right for someone to make an official statement and clear up this "Mystery" once and for all.

When Fred Goerner of KCBS was making his investigation, the Late and Great Adm. Chester Nimitz confirmed that the couple did go down in the Marshalls and were taken prisoner by the Japanese.

Also, Major's Joseph Gervais and Robert Dinger uncovered a lot of strange bits, during their investigation.

This cover-up makes Watergate look like a 6-year old's Birthday Party. Major Gervais now says that Ms. Earhart returned to the U.S. in 1945 to live until the Summer of 1983, as Mrs. Guy (Irene) Bolan, when she



Died, from Cancer. Her life seemed to start  
in 1945; and would never allow her fingerprints  
to be made.

There are many questions unanswered - Such as:  
Why was Ms. Earhart's husband, M. P. Putman  
granted a Direct Commission as Major in the USAF  
Intelligence, to spend much time in the Far East?  
Was her plane discovered & destroyed by the  
Marines at Aslito Field, Saipan?  
And, why did the same type of plane  
bearing the same Reg. No. NR-16020, crash  
into a Calif. Mtn., 24 years - 5 months  
after her disappearance, killing two U.S.  
pilots?

The list could go on for months, but  
have taken up too much of your time. I  
do hope to hear a statement on this before  
long. I do not think it would embarrass  
anyon, and the public deserves to know.

Also, Ms. Earhart and Fred Noonan deserve  
better than silence. Thank you for your time.  
Sorry this letter is so long.
