Dear Mr. Eggleston:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George H.W. Bush Presidential records in response to the Freedom of Information Act (FOIA) request listed in Attachment A.

This material, consisting of 2,600 pages, has been reviewed for all applicable FOIA exemptions, resulting in a total of 2,007 pages restricted. NARA is proposing to open the remaining 593 pages. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President Bush's representative, James W. Cicconi, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is March 31, 2015, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

These materials include correspondence consisting of internal staff memoranda that arranged administrative details, such as meetings and scheduling, and external correspondence with executive branch agencies addressing the delegation of responsibility under the Nunn-Lugar act. Other material includes clearance of proposed bills and statements, proposed notifications to Congress, and letters from private citizens and organizations discussing issues such as Russian disarmament and a study of leukemia in Belarus. Also included are cover sheets and correspondence that route other documents, press releases from the White House including statements from President Bush on nuclear conversion and the signing of the Freedom Support Act, fact sheets on agreements with Russia and the Former Soviet Republics, and press guidance on aid and Nunn-Lugar Certifications of Former Soviet Republics. In addition, there is printed material, such as a news conference and interview with Senators Nunn and Lugar, and newspaper clippings on the Nunn-Lugar Act, Soviet nuclear dumps, and an arms pact with Ukraine.
