	<p>The Census Bureau has a records storage facility in Building 72 at Jeffersonville, Indiana which has severe structural problems that necessitate removal of all records within.</p> <p>To facilitate the removal process, the Bureau is seeking authority to destroy all series of records on the attached list marked by the letter "D". This list also contains both the present records schedule provision governing the series and the eligible destruction date for the record as well as the volume, division of origin, and cubic footage. The other series of records on this list (Marked by the letters R, W, and H) will either be sent to the Federal Records Center, brought back to the divisions at Suitland, or held at other buildings on the Jeffersonville site.</p> <p>The vast bulk of records marked for destruction are completed sample survey questionnaires.
