Documents are used to follow trends in drug/alcohol abuse and to gauge the effectiveness of control activities. Documents must be available to support comparative evaluations required by DOD and Congressional Committees. Since both the Drug and Alcohol Abuse Control Programs are relatively new, they continue to be subject of high level interest. The proposed dispositions of destroying after five years at HQ USAF , after three years at major commands and after two years at below major commands are considered adequate for Air Force needs. <i>Rule 13 is proposed for permanent retention.
