When space defense log book is active, it is used continuously. Once closed out and stored, it is seldom, if ever, referred to. As such, 6 months retention is sufficient.</p> <p>2 Rule 15 documents are a daily compilation of reports and a record of missile warning performance. The missile warning logs include such information as operational capability changes, electronic counter measures (ECM) reports, event detections, communications outages, and significant equipment outages. Command and Control and higher organizations use the data for research, analysis and historical purposes.
