	<p style="text-align: center;"><b>Vehicle Registry Inquiry Network (VERINET) Files</b></p> <p><b>Background information:</b> The VERINET is an official U.S. Army Europe (USAREUR) automated information system that stores, processes, issues, and retrieves privately owned vehicle (POV) and privately owned firearm (POF) registrations, and POV driver certificates of license for U.S. Forces military and civilian personnel and family members located in Germany. The database resides on a central host at the Registry of Motor Vehicles and is updated daily as registration and license applications are received and processed at Local Field Registration and Driver Testing Stations and as personnel are separated or transferred from USAREUR duty stations. The system is also used by authorized law enforcement personnel, primarily military police and security forces in Germany, for verifying the status of POV operators stopped for traffic offenses or entering an U.S. Forces military installation.</p> <p><b>Source of data for the system:</b> Information used to populate the VERINET is gathered from other records systems and individuals such as: Applicants and registrants of licenses, vehicles, and firearms; Local Field Registration and Driver Testing Station personnel; PERSCOM Theater UIC-SSN file; AE Forms 190-1AA (Application for Motor Vehicle Registration and Allied Transactions), 190-1F (Private Operators License in Germany), 190-1K (Report of Administrative Action), 190-1T (Application for USAREUR POV Operators License and Allied Transactions), 190-6D (USAREUR Application for Registration of a Firearm), 4833 (Commander's Report of Disciplinary or Administrative Action), DA Form 3975 (Military Police Report), and DD Form 1408 (Armed Forces Traffic Ticket).
