Background Information **The National Database Services Tracking Analysis and Reporting System (NDB STARS) provides the claims, provider, and beneficiary information needed to detect fraud, waste, and abuse in the Medicare fee-for-service program. Data is extracted from various CMS systems (National Claims History, Medicare Enrollment Database, Provider Enrollment & Chain Ownership System), transformed and loaded monthly into the National Database Services Tracking Analysis and Reporting System (NDB STARS) and maintained in various tables in the Oracle database. Data includes but is not limited to Medicare claims (Inpatient/skilled nursing facility, outpatient home health, hospital carrier and durable medical equipment), Medicare Enrollment Database (monthly report of new Medicare enrollees), Certification and Survey Provider Reports (certification information for Part A institutions, clinical laboratory provider certifications), demographic and eligibility information for suppliers of durable medical equipment (DME), prosthetics, orthotics and supplies, Part B provider data, original and adjustment records for Pharmacy events, relationship information, taxonomy codes, Medicaid, payment center, parent organization and other provider information, Railroad Retirement Board and Drug Enforcement Agency provider data, provider trading partner information on DME supplies**
