

1.	<p><b><u>A ONE-TIME DISPOSAL OF MEDICARE A AND B CLAIMS AT THE ATLANTA FEDERAL RECORDS CENTER CONTAINED IN THE ACCESSIONS ON THE ATTACHED DISPOSAL LIST</u></b></p> <p>The relocation of the annex to the Atlanta Federal Records Center will start this January and, hopefully be completed by March 1989. Located in the annex are approximately 7,000 cubic feet of Medicare carrier A and B claim files for 1982. Normally these files will become eligible for destruction on April 1, 1989, under NC1-440-83-1, Item 2A2. The purpose of this one-time disposition request is to authorize the destruction of these records two months earlier than their normal disposal.
