The Joint Analysis Center Collaborative Information System (JACCIS) maintains situational awareness of the Global Nuclear Detection Architecture (GNDA), facilitates the adjudication of nuclear detection alarms, provides information and analysis and coordinates both technical support to federal, state and local authorities and government response to radiological alarms. These mission functions are accomplished in respect to border and domestic areas but in the future will also apply to international areas in order to prevent the import, possession, storage, transport, development or use of an unauthorized nuclear device, fissile material or radiological material in the U S

The primary purpose of the information collected and maintained within all of the DNDO JACCIS Portals, with the exception of the RFI Portal, is to assist with supporting a large community of interest in facilitating alarm adjudication, situational awareness, coordination of US Government response to nuclear incidents, and information and analysis capabilities through collection, consolidation, and redistribution of data

The creation of the JACCIS was authorized within Interagency Agreements between SPAWAR System Center Charleston and the Domestic Nuclear Detection Office

Data collection for the JACCIS is authorized by the following legal authorities and/or agreements

- National Security Presidential Directive NSPD-43,
- Homeland Security Presidential Directive HSPD-14 (Domestic Nuclear Detection, April 15, 2005),
- Homeland Security Act of 2002,
- E-Government Act of 2002,
- Memorandum of Understanding with each State
