


Financial Reporting Repository (FRR)

The Financial Reporting Repository (FRR) is a web based application used by the U.S. Immigration and Customs Enforcement (ICE), Office of Financial Management (OFM) as a financial data analysis and reporting tool. FRR was developed and implemented in order to streamline the various processes that OFM personnel use to fulfill the mission of the office to collect, merge, analyze, and report on financial data. FRR provides OFM with enhanced tools and technology that reduce their manual processing of financial data.

A. Master File Data:

(1.) Financial Data Repository

The data that makes up the repository is taken from various information technology system sources by either requesting the data, or receiving data batches. Data gathered from the various sources is financial in nature (payments, receivables, costs, etc) and is organized by financial subject areas such as General Ledger (GL), Payment Management, Receivables Management, Cost Management, and Asset Management. This repository consists of current and historical detailed, structured, transaction data

Disposition:

TEMPORARY. The Cutoff is the end of the Fiscal Year in which data is received by FRR. Destroy/delete seven (7) years after cutoff.

Disposition:

(1.) Standard (Canned) Reports

FRR is capable of producing several standard reports for users. While the type of information in these reports is pre-defined by parameters set by the system, users can modify the reports by adding items to be queried and filters, as well as adjusting the formatting

- **Cash Summary**

This report generally is for a particular set of FRR users and provides a listing of each subaccount and the ending balance as of the end of the current closing month.

- **Fund Balance with Treasury (FBWT) Reconciliation Report**

This report reflects the ending balance for the current closing month for specific Treasury Accounting Symbols as is being reported by the Federal Financial Management System (FFMS) and Government-Wide Accounting (GWA).

- **Payroll Reconciliation Report (ICE Only)**

This report shows the balances in the cash accounts for both FFMS and GWA which are used for payroll.

- **Trial Balance Report**

Enables a more detailed look at ending balances of each
