1.	<p>NEWSPAPER PRESERVATION ACT FILES</p> <p>The Newspaper Preservation Act (Public Law 91-353, 84 Stat. 466, 15 USC 1801 et seq.) allows newspapers, that are entering into a joint operation arrangement after July 24, 1970, to obtain the benefit of a limited exemption from the antitrust laws by filing an application to the Attorney General for approval. The provisions of 28 CFR 48.3 require the Assistant Attorney General for Administration to maintain a public file as well as a duplicate of this file "for the use of officials with decisional responsibility."</p> <p><u>Pre-Statute.</u></p> <p>a. <u>Officials' file</u> contains each renewal and/or amendment, including the amended portion of the original agreement, to the terms of a joint newspaper operating arrangement entered into before July 24, 1970.</p> <p><u>Disposition:</u> Permanent.
