	<b>FUGITIVE FELON PROGRAM "Operation Joint Venture"</b>  The Personal Responsibility and Work Opportunity Reconciliation Act of 1996 made persons ineligible to receive federally funded benefits during any month in which the recipient is in violation of their parole or probation agreement. Since 1999, the FBI has been working with the Social Security Administration's (SSA) Office of Inspector General on "Operation Joint Venture." This program identifies wanted fugitives receiving Supplemental Security Income (SSI) benefits in violation of Public Law 104-193 and wanted fugitives receiving Old Age Survivor Disability Income (OASDI) benefits in violation of Public Law 108-203.

	<p>The FBI matches information contained in the National Crime Information Center's (NCIC) Wanted File against recipient information stored in the SSA's SSI and OASDI files. Whenever data matches occur, the FBI prepares a letter to local law enforcement agencies or an electronic communication (EC) to FBI Task Force members or Special Agents with the location and biographical features of the fugitive. Electronic versions of these communications are uploaded into Classification 88 control files in the Automated Case Support (ACS) System. The FBI prepares approximately 1,000 communications per month.</p> <p>Prior to December 12, 2002, a paper version of each communication was printed out and filed in a hard copy control file. Due to the overwhelming volume and lack of reference activity, the FBI discontinued printing out paper versions. Currently, over 110 linear feet (51,000 serials) of paper documents are filed in control files 88A-HQ-C1298915-A (communications with external law enforcement entities) and 88A-HQ-C1298915-B (communications with internal Bureau components).
