	<p>The United States Marshals Service Witness Security Division oversees the Witness Protection Program which was established under the Organized Crime Control Act of 1970 and authorized the Attorney General of the United States to provide for the security of federal and state government witnesses and their dependents whose lives are jeopardized by virtue of their testimony against persons engaged in organized criminal activity. The records maintained by the Witness Security Division consist of various memoranda pertaining to the individual and their authorized family members.</p> <p>The inactive case files are being microfilmed in accordance with standards and guidelines set forth in FPMR 101-11.506. The film stock used conforms to Federal Standard No. 125D and is on safety-base permanent film as specified in ANSI PH 1.25-1976. Film will be able to meet the methylene blue test specified in ANSI PH 4.8-1971. The silver original microfilm will be stored in facilities meeting the standards set forth in FPMR 101-11.507-1. The silver original microfilm will be inspected every two years of their scheduled life in accordance with FPMR 101-11.507.2. The first inspection will be made in 1986. The master microform shall not be used for reference purposes in accordance with FPMR 101-11.508.</p>
