HEALTH SERVICES DIVISION (HSD)

The Health Services Division has three primary missions relating to its concerns and responsibilities in medical care, safety and environmental health, and food services:

- 1- To deliver medically necessary health care to inmates effectively in accordance with proven standards of care without compromising public safety concerns inherent to the BOP's overall mission.
- 2- To provide a safe and healthful environment in which staff and inmates can work and live.
- 3- To provide healthy, nutritionally-sound, and appetizing meals that meet the needs of the general population and those at nutritional risk.

Within these mission objectives, the Health Services Branch focuses on the first mission objective and is responsible for the Bureau's TeleRadiology system.

1. TELERADIOLOGY SYSTEM (TeleRad)

The TeleRad System is a web-based database application used to capture and store inmate X-rays and X-ray reports. BOP sites use TeleRad to take digital X-rays of inmate patients using digital equipment. The X-ray captured is submitted to a Central BOP server (MEDWEB) that forwards it to the University of Maryland to perform the reading and analysis of the X-ray. The University of Maryland creates an X-ray report and forwards it to the Central BOP server, where it is paired with the X-ray image it references. TeleRadiology uses two servers: one to store current data being processed and the second to store non-active archived data.

A. INPUT

- (1) ~~Electronic X-ray images containing the inmate's name, register number, type of examination, date, referring physician or facility, and analysis reports containing textual interpretations of the associated X-ray images. Both X-ray images and reports are in DICOMH07 format.~~

(2) X-ray film

Disposition. Temporary. Delete/Destroy after digital conversion verification.

(3) Paper reports and notes associated with X-ray.

Disposition. Temporary. Delete/Destroy after digital conversion verification.

B. ~~OUTPUT~~ Paper printouts or electronic media containing copies of images and/or medical reports and related information on X-ray images.

Disposition. Temporary. Destroy when no longer needed for reference purposes.

C. DATA

(1) X-ray digital images

Disposition. Temporary. Destroy 5 years after expiration of sentence.

(2) X-ray reports and X-ray metadata including but not limited to an inmate's name, register number, sentence information, examination, date, referring physician or facility, analysis reports, and system-generated fielded information.

Disposition. Temporary. Destroy 30 years after expiration of sentence.

(3) Un-scanned X-ray film

Disposition. Temporary. Destroy 5 years after creation.
