The International Claims Commission, a predecessor organization of the FCSC administered a claims program under an agreement between the Government of the United States and Yugoslavia, concluded on July 19, 1948, and Title I of the International Claims Settlement Act of 1949 covering claims for the nationalization of American owned property prior to the date of the agreement. The program was completed on December 31, 1954.

(2) A second claims agreement was reached between the two governments on November 5, 1964 covering claims by United States nationals against the Government of Yugoslavia which arose subsequent to the 1948 agreement. This program was completed on July 15, 1969.
