The Office's function was to advise the Secretary of Labor with regard to rules and regulations to assure non-discrimination in employment practices of certain contractors, and to maintain liaison with the Equal Employment Opportunity Commission, and the Department of Justice on matters relating to Title VII of the Civil Rights Act of 1964 and to manage agencies having civil rights and equal opportunity activities under Executive Order 11246, as amended. The Office of Eederal Contract Compliance Programs (OFCCP) was created to administer in addition the affirmative action and non-discrimination provisions of the Rehabilitation Act of 1973, as amended, and the Vietnam Veterans' Readjustment Assistance Act of 1974.
