The Welfare Branch was concerned with such issues as Indian education, income support, and health and sanitation. The documents in these boxes are of a reference nature and/or non-record copies of school support ledgers and direct assistance accounts. They cover the period 1933-49. Included is a reference file compiled to assist Indian veterans about to return from WW II. This file consists exclusively of printed copies of regulations and pamphlets from the Social Security Administration, the Selective Service, and other government agencies. There are also copies of printed Congressional hearings and reports on miscellaneous topics apparently maintained for staff use.

Also contained in the box are 10 stenographer notebooks containing handwritten narrative statements made to BIA employee Walter Goldschmidt by Alaska natives in the summer of 1946. These notes, which contain a great deal of information about the customs and standard of living of natives of Southeastern Alaska in the late 19th and early 20th centuries, were used to compile "Possessory Rights of the Natives of Southeastern Alaska. A detailed analysis of the early and present territory used and occupied by natives of southeastern Alaska...", a report submitted to the <del>These</del> Commissioner of Indian Affairs, in October 1946. [These stenographer notebooks are recommended for disposal because typed transcripts of each narrative statement, plus the original copy of "Possessory Rights," are available in another BIA accession that has been offered to NARS. The typed transcripts and the report itself will be recommended for permanent retention, and will be described in a later accession job.]</p> <p style="text-align: center;">Destroy immediately.</p>

They provide information concerning sources of income, education, <u>etc.</u>, and were apparently used as background and/or reference material.</p> <p style="text-align: center;">Destroy immediately.</p>		
7.	<p>Box 1774, Accession 75-53-U-367</p> <p>This box contains Service Record Cards (SF 7) for Intermittent Employees, Indian and non-Indian, all of whom were separated or transferred on or before December 31, 1947. Earliest personnel actions for most cards were post-1918, usually 1930's or 1940's. These records are made disposable under GRS 1, Item 2a, 60 years after earliest personnel action date.</p> <p style="text-align: center;">Transfer immediately to St. Louis, National Personnel Records Center, Destroy in 2006.</p>		
8.	<p>Boxes 1784-85, Accession 75-53-U-367</p> <p>These boxes contain a card file of names and addresses created by the National Indian Institute (NII). Included are names of persons in Latin America associated with the Inter-American Indian Institute. The cards were apparently maintained as a mailing list for NII bulletins and publications.</p> <p style="text-align: center;">Destroy immediately.</p>		
9.	<p>Boxes 1787 (except for the 3 census reports) and 1788, Accession 75-53-U-367</p> <p>These boxes contain monthly hospital and out-patient reports, 1944-6. These reports were probably used to prepare the statistical supplement to the Commissioner's annual report. Also included are photostatic copies of miscellaneous charts and tables related to Indian employees in the Indian Service, lands under BIA jurisdiction, <u>etc.</u> The 3 census reports will be accessioned into NARS under NC3-75-78-7.</p> <p style="text-align: center;">Destroy immediately.</p>

Box 452, Accession 75-53-G-367</p> <p>These are non-record copies of public works allotments and circulars regarding procedures and operations of the Civilian Conservation Corps. Box 474, Accession 75-53-H-367.</p> <p>These records consist of Crow Family Income Cards for 1940. The cards are mimeographed forms with handwritten notations in pencil detailing sources of income, age of family members, and other information, apparently used in preparing a staff report. Also included is a chart entitled "Distribution of Income of Crow Indians--by major sources for year ending 1940."
