**Records of the Alaska Task Force to Study
"National Interest Lands" in Alaska, 1972-77.

Under section 17(d-2) of the Alaska Native Claims Settlement Act of 1971, the Secretary of the Interior could receive certain "national interest" lands in Alaska for possible inclusion in the National Park System. An Alaska Task Force was created by the National Park Service and assigned to study the lands in question. The records included in this appraisal were generated by the Task Force in the course of their studies. We believe that the Park Service was correct in keeping these records together as a block rather than dispersing them into their filing system.

The files include a large proportion of mechanically-duplicated or photocopied records, and some files include non-record items--published journal articles or studies. Despite this, we believe this series merit permanent preservation because they constitute the most complete record available of the "d-2" land studies in Alaska, and represent a unique compilation of information that would probably be prohibitively expensive to reassemble should the series be destroyed.
