## 1. PROJECT FILE OF DC AND QL CHEMICAL FACILITY DESIGN/BUILD CONTRACT, U.S. ARMY PINE BLUFF ARSENAL, ARKANSAS

This series contains project files generated during the period a Memorandum of Agreement (MOA) was in effect between the U.S. Army Engineer District, Little Rock (CESWL) and TVA's Office of Agricultural and Chemical Development (OACD)/National Fertilizer and Environmental Research Center (NFERC). This project file contains copies of the official records produced by the loaned TVA employees under the MOA. The originals of these records were turned over to the Army. The MOA states that TVA would provide to CESWL expert technical, engineering, and construction management support during the design, construction and proveout phases of the systems contract for the acquisition of the Binary DC and QL Chemical Production Facility at the U.S. Army Pine Bluff Arsenal, Arkansas. TVA employees were loaned to CESWL beginning 11/12/87, and were under their control and supervision during this project. The MOA was terminated effective 12/4/91.

The records include TVA's copies of reports, correspondence, drawings, specifications, and manuals, and are organized numerically by vendor for the period June 1987 through December 1991. The volume is 80 cubic feet. The records have no further value to TVA.
