The Working Group was established to locate, identify, inventory, recommend for declassification, coordinate release to the public, and report to Congress all Nazi and Japanese Imperial Government war crimes records of the United State. The law required the President to establish a new and separate agency. President Clinton did so under the provisions of EO 13110.</p> <p>The Archivist of the United States served as chair. The National Archives and Records Administration hosted and provided the support staff for the the IWG. The IWG delivered its final report to Congress in April 2007.</p>
