DESCRIPTION: WASDE is a tool for the management of the U.S. Department of Agriculture world agriculture supply and demand estimates and records. WASDE utilizes the Foreign Agriculture Service (FAS) Production, Supply and Demand (PS&D) to forecast commodity supply and demand estimates for the U.S. and selected foreign

Input

Data entered into the system by agency user, paper and electronic inputs extracted from the FAS PS&D system

Item 1: Hardcopy.

Disposition TEMPORARY. Destroy after the information has been converted to an electronic medium and verified, when no longer needed for legal or audit purposes GRS 20, Electronic Records, item 2(a)(4).

Item 2: Electronic copy.

Disposition TEMPORARY. Delete when data have been entered into the master file or database and verified, or when no longer needed to support reconstruction of, or serve as backup to, the master file or database, whichever is later GRS 20, Electronic Records, item 2(c).

Item 3: Master File.

Data input includes agency user, and agricultural commodity supply, estimates and data span crop years 1960 to present

Disposition **TEMPORARY.** Delete/destroy 3 years when current data is migrated to a new system and verified or after termination of the system

Item 4: Output

This system provides USDA employees, contractors with information such as the commodity, country, date and crop estimate, reports both canned and ad hoc

Disposition TEMPORARY Delete when the agency determines that they are no longer needed for administrative, legal, audit, or other operational purposes GRS 20, Electronic Records, stem 6

Item 5: System Documentation

Data systems specifications, file specifications, codebooks, record layouts, user guides, output specifications, and final reports (regardless of medium) relating to a master file, database or other electronic records.

Disposition TEMPORARY. Destroy or delete upon authorized deletion of the related electronic records or upon the destruction of the output of the system if the output is needed to protect legal rights, whichever is later GRS 20, Electronic Records, item-11(a)(1)
