Justification: The files were created at a lower level organizational unit within the agency and were maintained as the Chief's personal reference subject files (publications on transportation/warehousing issues, outside speeches given, writing style manuals, etc.) rather than an official program/policy file. Records had been scheduled under NC1/145/79/1, item 14B1.

#### **Cotton Division:**

#### 8. COTTON ALLOTMENT RECORDS, 1938-43

Memorandums and yield adjustment tabulation data compiled and used in the determination of yearly State cotton allotments and acreage. Arranged roughly by year

Justification: Records contain only a limited amount of evidential value with regard to the overall cotton linters program functions and policies -they mainly document the administrative and reporting needs within the cotton linters program.

Justification: Printouts were generated and maintained solely for agency's administrative needs and reporting purposes

#### 1,12. GRAIN DIVISION LOAN RATE RECORDS, 1942-52

Handwritten tabulations on oversized ledger sheets and published maps regarding the weighted loan rates and price support and differential rates for barley, corn, flaxseed products, grain sorghums, oats, rye, soybean, and wheat for States as well as commodity terminals in Duluth, Omaha, Kansas City, Chicago, and St. Louis. Includes some negatives used in the printing of the maps. Arranged by State or commodity office.

AUTHORIZED DISPOSITION: Destroy on approval of this schedule.

Aec 62B1043, packages/bundles 1-6

Justification: Although loan rates/price support were major program function areas within the agency, the records do not reflect or document any policy actions or decisions with regard to

these areas. The records appear only to chart/track the rates for administrative purposes and possibly provided statistical information for later use in policy making decisions; however, the records do not indicate they were used in that manner.

#### 13. GRAIN DIVISION DISTRIBUTION FORMS, 1957

CSS Form 527 (Frequency Distribution of Farms by Size and Acreage); forms contain handwritten statistical information regarding acres planted with wheat versus acres allotted. Arranged alphabetically by State.

Justification. The records were solely maintained for agency's administrative and reporting needs and neither-reflect or document any evidential value with regard to agency policies or program functions.

Feed grain, corn, and rice approved subsidy bids. Series consists of cover memorandums of approved company bids with attached price data used in determining the approval or rejection of bids. The Grain Division forwarded the bids to the General Sales Manager. Arranged chronologically by year.

Justification. Bids were solely maintained for administrative needs.

I believe that information regarding the unit could be readily located within the agency's central files - which are permanent. The files had been scheduled under NC1/145/79/1, item 14B1.

#### 19. ADMINISTRATIVE/PROCEDURAL MANUALS AND ISSUANCES, 1943-51

"Green Copies" of outgoing letters to State committee chairmen - files only pertain to South

Carolina to Wyoming. Arranged alphabetically by State.

AUTHORIZED DISPOSITION: Destroy on approval of this schedule.

Acc. 62C1260, box 59

Justification: The letters comprise the end of what was a larger series which was destroyed (Boxes 56-58) on 10/21/64 as annotated on SF 135 (no authority cited).. Boxes 56-58 contained letters for Alabama - Rhode Island. The letters have little or no evidential value and most likely the information can be located within the agency's central files which are permanent. These records had been scheduled under NC1/145/79/1, item 14B1.

#### **Unknown Organization Subunit**

#### 21. MISCELLANEOUS FILES, 1954-55

Copies of GAO audit reports pertaining to commodity offices; congratulatory letters and letters of acceptance for speaking engagements maintained by Clay H. Stackhouse, Assistant Deputy for Product Adjustment; and memorandums pertaining to wheat load outs by Mills.

Justification: The Commodity Credit Corporation had filed a multimillion dollar claim against Burrus Mills for the spoilage of stored grain. As result of this claim, the CCC altered its grain storage policies and procedures. The letters, which are in support of Burrus Mills, provide evidential value regarding CCC grain storage and subsequent policy changes The records had been scheduled under NC1/145/79/1, item 14B1.

#### 23. STATE WORKLOAD TABULATION SHEETS, 1960-62

State and county operation workload tabulation sheets used in the determination of budgetary and program needs. Information submitted by State committees/administrators via printed worksheets pertaining to expenditures for price support, production adjustment, loan service charges, and loan purchase agreements. Arranged chronologically by year.

AUTHORIZED DISPOSITION. Destroy on approval of this schedule.

Acc. 64G1210, boxes 57-62

Justification: Purely maintained for administrative needs and have no long term financial or statistical value to warrant their permanent retention.

## Policy Program & Appraisal Division (Formerly Program Analysis Branch, Sugar Division):

#### 24. SUGAR COST STUDY SUMMARIES, 1942-60

Statistical summaries of sugar studies on the costs, returns, profits for all types of sugar products as means to develop cost, price, and profit differentials for refining and packaging sugar products. Includes publications relating to cost and returns of operating raw sugar mills in Louisiana and workpapers on the returns, costs, profits, net worths, and wages gathered via surveys performed in Florida, Louisiana, Puerto Rico, Hawaii, and the Virgin Islands. Arranged by type of record.

AUTHORIZED DISPOSITION: Destroy on approval of this schedule.

Acc. 63A1340, boxes 1-7

Justification: The records were created and maintained in conjunction with the statistical analysis of costs/profits within the sugar industry. Much of the information is "raw data" to be used in projecting industry trends and in support of proposed differentials; however, the records do not include any differential reports/recommendations from which this data was used in formulating agency program or policy decisions. Results of sugar surveys are printed in the GPO publication "Sugar Reports" which is available at Federal depository libraries as well as in Record Group 287, Publications of the U.S. Government.

#### Policy Program Appraisal Division, Statistical Service Branch

#### 25. GRAIN COMMODITIES RECORDS, 1942-61

Records pertain to price and loan support rates of grain commodities and include CCC Form 388 (Cumulative Report of Commodity Loan Activity), CCC Form 416 (Cumulative Report of Variety or Class), and CCC Form 604 (Cumulative Report of Price Support Activity), as well as statistical summary printouts generated by Kansas City data processing center and differential worksheets.

AUTHORIZED DISPOSITION: Destroy on approval of this schedule.

Acc. 66A2146, boxes 11-19

Justification: Records were maintained solely for the analytical and reporting purposes of the agency and do not indicate what, if any, rate actions the agency took as a result of the information extracted from these records. In turn, their lack of evidential value does not warrant permanent retention.

Records pertain to price and loan support rates for peanuts and consist of summary worksheets, peanut loan reports, grading data, and distribution charts.

Reports pertain to the number of county and State Conservation Reserve Program contracts received by News Orleans data processing center and the number of contracts suspended by data processing center for corrections via CSS Form 204-3. Includes Form 204-3 as well as cover memorandums on the transmittal of contract forms. Arranged chronologically by year.

AUTHORIZED DISPOSITION: Destroy on approval of this schedule

Acc. 66A2146, box 22

Justification: Reports were created and maintained for agency's administrative and reporting needs only.

#### Sugar Wage & Price Group

#### 28. SUGAR WORKSHEETS, 1957-59

Via worksheets, statistical data was gathered on sugar mill production capacity, sugar cane and sugar beet stocks, raw and refined sugar stocks, sugar beet processing, industry molasses distribution, and refinery capacities.

AUTHORIZED DISPOSITION. Destroy on approval of this schedule

Justification: Purely statistical information gathered in the research/analysis process on the sugar industry - no final report or recommendations were found among records nor any indication on how information was used in subsequent program/policy planning or actions.

Justification: Information gathered on forms was used in the research of cost/price analysis within the sugar industry; however, only statistical information with no accompanying reports/recommendations with regard to program changes or agency policies.

Bulletins, journals, and newsletters published by sugar companies or associations regarding wages and labor within the sugar industry.

AUTHORIZED DISPOSITION: Destroy on approval of this schedule.

Justification: Publications were maintained as means of keeping abreast on sugar industry activities - no evidential value of agency policy actions - solely used for reference purposes

#### 31. SUGAR REPORT WORKSHEETS AND RELATED WORK RECORDS, 1963

Records appear to have been collected and used in the writing and compiling of overall reports and includes tables/charts; press releases; reports regarding the cost of living and retail prices in Hawaii; sugar act payments and applications in Florida, Louisiana, and Hawaii, trash/waste reports for Louisiana; statistical year books for Puerto Rico, annual report for Caribbean area; applicable sugar prices, and statistical data on foreign labor.

AUTHORIZED DISPOSITION: Destroy on approval of this schedule.

Acc. 66A2146, boxes 40-43

Justification: Background data gathered during sugar surveys. Results of surveys were published in the GPO publication "Sugar Reports" available at Federal depository libraries as well as in RG 287, Publications of the U.S. Government.

#### 32. SUGAR WORKPAPERS, 1949-62

Working/background materials compiled as a result of sugar cost surveys performed in Puerto Rico, Florida, Louisiana, and Hawaii. Includes financial statements for Puerto Rican land authority farms (written in Spanish); survey questionnaires; producers and processors reports for sugar beets and sugar cane; survey instructions, itineraries, and forms; refinery cost summaries; sampling data, and negatives used in the printing of the final reports.

AUTHORIZED DISPOSITION: Destroy on approval of this schedule.
