The headquarters office is in Washington, DC. Both the Actuarial Division which devises actuarial/underwriting policies of the Corporation and the National Service Office which conducts the accounting function for the Corporation are in Kansas City, MO. FCIC also has offices for individual states or groups of states and offices for individual counties or groups of counties which sell the insurance policies, collect the premiums, and service the contracts.</p> <p>The purpose of the crop insurance is to reduce the risk of crop failure caused by natural hazards.
